**CHAPTER 1**

**H.P. 371 - L.D. 482**

**Resolve, To Name the Washington  
County Portion of US Rt. 9 the Tony  
Tamaro Memorial Highway**

**Sec. 1. Designate Route 9 in Washington County Tony Tamaro Memorial Highway.**  
**Resolved:** That the Department of Transportation shall designate the part of United States Route 9 that is within Washington County as the Tony Tamaro Memorial Highway.

**CHAPTER 2**

**H.P. 21 - L.D. 14**

**Resolve, to Designate Interstate 95  
from Augusta to Houlton as the  
Purple Heart Trail**

**Sec. 1. Designate Interstate 95 from Augusta to Houlton as Purple Heart Trail.**  
**Resolved:** That, notwithstanding Resolve 1965, chapter 31, the Department of Transportation shall designate that part of Interstate 95 that starts in Augusta and continues through to Houlton as the Purple Heart Trail and shall erect appropriate signs along the highway to proclaim this designation. The Department of Transportation shall continue to maintain signs erected at rest areas on that part of Interstate 95 that starts in Augusta and continues through to Houlton memorializing Brian M. Jewett.

**CHAPTER 3**

**H.P. 277 - L.D. 357**

**Resolve, Regarding State Designation  
of Memorials Honoring Maine's  
Vietnam War Veterans**

**Sec. 1. Recognizing State Vietnam Veterans' Memorial in Capitol Park as official state**

**memorial in honor of Vietnam War veterans.**

**Resolved:** That the memorial known as the State Vietnam Veterans' Memorial located in Capitol Park in Augusta, which was funded in part by funds appropriated in Private and Special Law 1985, chapter 59, is designated the official state memorial to honor the veterans of Maine who gave their lives in defense of freedom during the Vietnam War. Notwithstanding that designation, the Legislature may from time to time designate other monuments, structures or property in other locations throughout the State as state memorials in honor of those veterans; and be it further

**Sec. 2. Monument designated as state memorial to Vietnam veterans.**  
**Resolved:** That the monument to be erected in Bangor on the grounds of the Cole Land Transportation Museum is designated as a state memorial to honor the veterans of Maine who gave their lives during the Vietnam War and those veterans of the Vietnam War who are still missing in action.

**CHAPTER 4**

**H.P. 58 - L.D. 50**

**Resolve, Requiring the Department  
of Transportation To Consider  
Replacement of the Waldo-Hancock  
Bridge**

**Emergency preamble.** Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** the condition of the Waldo-Hancock Bridge is posing a danger to users; and

**Whereas,** it is the only means of crossing the Penobscot River south of Bangor; and

**Whereas,** the bridge is part of a major tourist route in the State; and

**Whereas,** in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following
