Halifax in Winslow with the intent of eventually extending the waterway upriver to the headwaters of the Kennebec River. No later than January 31, 2004, the department shall report to the Joint Standing Committee on Agriculture, Conservation and Forestry on progress made to:

1. Coordinate the management and promotion of state recreational, scenic and historic lands and easements with municipal and private recreational, scenic and historic lands along the Kennebec River;
2. Integrate launching and landing sites, existing trails, historic and educational sites, scenic viewing opportunities and other sites of interest in a unified approach to protect, interpret, promote and develop the river's outstanding natural, educational, scientific and historic resource values; and
3. Offer primitive camping at intervals along the waterway to encourage canoeing, kayaking and other forms of recreation; and be it further

Sec. 2. Funding; assistance. Resolved: That the Department of Conservation shall seek to identify funding sources and technical assistance that could help implement joint projects and strategies in connection with creating the waterway; and be it further

Sec. 3. Local involvement. Resolved: That the Department of Conservation, in coordination with the Executive Department, State Planning Office; the Department of Inland Fisheries and Wildlife; the Department of Transportation; the Department of Marine Resources; the Department of Economic and Community Development, Office of Tourism; the Maine Historic Preservation Commission; and the Kennebec-Chaudiere Heritage Corridor Corporation, shall seek the input and cooperation of representatives of municipalities, land trusts, community groups, conservation organizations and businesses that benefit from a clean and healthy Kennebec River.

CHAPTER 14

H.P. 197 - L.D. 242

Resolve, Relating to the Consideration of the Cumulative Effect on Protected Natural Resources

Sec. 1. Department to convene working group of interested parties. Resolved: That, within existing resources, the Department of Environmental Protection shall convene a working group of interested parties to design a method for considering

the cumulative effects of activities on protected natural resources when the activities are permitted; and be it further

Sec. 2. Proposal. Resolved: That the Department of Environmental Protection shall submit a proposal for considering the cumulative effects of activities on protected natural resources, including any draft legislation necessary to implement the proposal, to the Joint Standing Committee on Natural Resources by January 5, 2004; and be it further

Sec. 3. Authority to report out legislation. Resolved: That the Joint Standing Committee on Natural Resources may report out legislation during the Second Regular Session of the 121st Legislature relating to the Department of Environmental Protection's proposal for the consideration of cumulative effects on protected natural resources.

Sec. 1. Sale of land. Resolved: That the State, by and through the Commissioner of Administrative and Financial Services, is authorized to convey by sale the interest of the State in real estate as indicated in section 3 of this resolve to Baron C. Wormser and Janet G. Wormser; and be it further

Sec. 2. Property to be sold as is. Resolved: That the Commissioner of Administrative and Financial Services may negotiate and execute the
