### CHAPTER 6 S.P. 161 - L.D. 474

Resolve, To Direct the Department of Transportation To Rename State Bridge Number 5278 the Ryan Quirion Guthrie Bridge

Sec. 1. State bridge number 5278 renamed. Resolved: That the Department of Transportation shall designate with appropriate signs and notices state bridge number 5278 on Interstate 295, commonly known as the Staples Point Bridge, as it crosses the Presumpscot River as the Ryan Quirion Guthrie Bridge to honor the memory of Ryan Guthrie, who died in an accident at that site.

### CHAPTER 7 H.P. 35 - L.D. 34

Resolve, Regarding Legislative Review of Portions of Chapter 28: Closing a School in the Unorganized Territory, a Major Substantive Rule of the Department of Education

**Emergency preamble. Whereas,** acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A requires legislative authorization before major substantive agency rules may be finally adopted by the agency; and

Whereas, the above-named major substantive rule has been submitted to the Legislature for review; and

Whereas, immediate enactment of this resolve is necessary to record the Legislature's position on final adoption of the rule; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

**Sec. 1. Adoption. Resolved:** That final adoption of portions of Chapter 28: Closing a School in the Unorganized Territory, a provisionally adopted major substantive rule of the Department of Education that has been submitted to the Legislature for review

pursuant to the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A, is authorized.
