LEGISLATIVE COUNCIL
February 12, 1982

CALL TO ORDER

A meeting of the Legislative Council was held in the Legislative Council Chambers, Room 327 and called to order by Chairman Elizabeth Mitchell at 9:50 a.m.

Sen. Collins moved that the amended salary scale for Staff Assistants submitted on this date be approved, retroactive to January 4, 1982 and the previous scale adopted by the Council on January 21, 1982 be rescinded.
