

SECRETARY'S REPORT

The Summary of the March 16, 1993, Council meeting was approved and placed on file. (Motion by Sen. Dutremble; second by Sen. Cahill; unanimous).

EXECUTIVE DIRECTOR'S REPORT

Sally Tubbesing noted that David Kennedy and Martha Freeman were prepared to give Council members a general status report on both bill drafting and committee work at the appropriate time. The Chair asked the two Office Directors to proceed.

Mr. Kennedy reported that of the 2,250 legislative instruments filed to date, only 150 remain to be drafted, of which 103 are pre-cloture bills. Ms. Freeman noted that the work load had now shifted to the committees. She reported that while committees were, at this point, keeping pace with the session 2 years ago, they still have about 80% of the total bills referred before them. She suggested that the Council consider establishing staggered deadlines for completion of committee work as previous Councils had, noting that this has been a useful way to encourage the small workload committees to complete their work so their staff can be reassigned to the larger committees. Sen. Dutremble observed that the Committee workload had been increased this year by the new rules related to consideration of the budget. Ms. Freeman concurred, noting that most committees had already reached the level of activity that usually comes only in the closing weeks of the session.

The Chair, Rep. Gwadosky, thanked Ms. Freeman and Mr. Kennedy for their reports and asked that they keep Council members posted.

No formal Council action was required on this item.

The Chair, Sen. Dutremble, reported that the Committee would be meeting.

Personnel Committee

Rep. Gwadosky, Committee Chair, reported that he would be scheduling a meeting within the next week to review the draft regarding the development of a Sick Leave Bank.
