

The Summary of the April 6 Council meeting was approved and placed on file. (Motion by Sen. Dutremble; second by Sen. Cahill; unanimous).

## **EXECUTIVE DIRECTOR'S REPORT**

Sally Tubbesing deferred to Martha Freeman and David Kennedy to present a status report on bill drafting and committee work. Mr. Kennedy reported that there were currently 209 bills left to be printed, of which 155 were out for sponsor review and signature or, for Governor's bills, final review by the Governor's Office. Ms. Freeman then reported that of the total number of bills referred, approximately 50% -- or 700 -- have yet to be voted on by committees. She noted that committees are working hard to meet their deadlines and suggested that the Council and the presiding officers needed to adopt clear policies regarding how the 209 bills that are still to be printed should be handled in terms of hearings, etc.

Council members then engaged in a general discussion of how to help committees balance the need to complete their work by the established deadlines (May 1 for small & moderate workload committees; May 13 for large workload committees) with their responsibility to give each bill individual consideration. Sen. Dutremble stated that at this point in the session committees must decide whether to "kill or carry" - that is, whether to kill a bill, or request that it be carried over to the Second Regular Session. He reported that he had instructed Senate Chairs to group bills as much as possible for purposes of public hearings and work sessions and then observed that this Legislature is a part-time legislature and must cut down on the amount of work it can reasonably do. Sen. Cahill expressed concern that some of the bills just being printed are bills filed before cloture and that the sponsors of those bills were not to blame. Sen. Dutremble responded that the issue is not one of who's to blame, but that there is simply too much work for the time available. The Chair, Rep. Gwadosky, reminded Council members that most committees had devoted considerable time to the budget this year with no offsetting decrease in their bill workload.

Discussion then shifted to the pros and cons of carrying over bills. Rep. Paradis stated that the budget **should** be the committees' priority and supported carrying over bills, noting that it had worked well for the Judiciary Committee two years ago. There appeared to be consensus that allowing committees to carry over bills was the best approach; however, Sen. Dutremble noted that this could simply transfer the workload to the shorter session. He went on to suggest that the Council and others should consider a change in the Joint Rules to require any bill introduced in the Second Regular Session to have an emergency preamble, thus requiring adoption by a 2/3 vote. At this point, discussion shifted to how the Council should proceed with After Deadline bill requests.

Rep. Gwadosky, Committee Chair, drew members' attention to a policy establishing a Sick Leave Bank Committee which had been distributed to members in advance of the meeting. He noted that the Committee had spent considerable time developing the policy and represented a unanimous Committee recommendation.

Dear Representative Gwadosky and Council Members:

The purpose of this letter is to provide you with a report of the Commission's activities during the past six months and to bring several matters to your attention. Although the Commission has been meeting less frequently in order to preserve as much of our budget as possible for work on the State House, the importance of the issues before us has not diminished.

#### Vietnam Veterans' Memorial in Capitol Park

Pursuant to the Council's approval last November, we extended the contract with Pressley & Associates for the helping the Commission review the proposal from Mr. David Lovejoy. The total cost of that contract extension is \$2,393.55. We have formed a Subcommittee to ensure that the proposed enhancements to the Memorial are done in a manner that is consistent with both the original landscaping plan for the Park, developed by Frederick Law Olmsted, and with the intentions of those veterans' groups who were originally involved in the design of the Memorial. We have been fortunate to have Roger Richmond, who designed the Memorial, and members of the former Vietnam Veterans' Leadership Project (VVLP) participate in our review, as well as Mr. Lovejoy. A list of the Subcommittee is enclosed for your information.

The Subcommittee's activity has been on hold through the winter, pending the disappearance of the snow; however, a meeting is scheduled for May 20, and we expect to complete our work and submit a final proposal to the Council sometime in late May or early June so that any work can proceed during the summer. #### Priorities for Repairs and Improvements to the State House

The Commission continues to place the highest priority on developing a comprehensive plan for the maintenance, repair and restoration of the State House and its immediate grounds. We have just initiated the process for seeking and selecting a qualified firm to develop the Historic Structures Report as authorized by the Council last November. This project represents a major undertaking; and, given the severe limitation of funds it will probably have to be completed over a period of 2 - 3 years.

Members of the Commission note with concern the visible deterioration in and around many areas of the State House. We believe that the studies that we have sponsored provide the information required to proceed with work in some areas - areas that we are confident will be identified as priorities in the Historic Structures Report once it has been completed. These include:

1. Replastering and repainting the dome ceiling.

Estimated cost:	\$ 27,900
Structural reinforcement:	17,000
	\$ 44,900

2. Continued exploration of the buckling of the tile on the 1st floor.

Estimated cost: \$ 3,500

3. Repair and replacement of the cast iron fence and supporting stone wall.

Estimated cost: \$250,000

4. Repairs and reupholstering of furniture in public areas.

#### Proposal to Redesign Old Museum Area

The Commission has had some discussion about the Klir Beck nature dioramas. Our discussion was precipitated by a report from Joseph R. Phillips, Director of the State Museum and a Commission member, that both the lighting in the cases and the glass itself need to be replaced. We believe there is an opportunity to improve the public's access to these displays and to improve the functionality of the space for legislative use at the same time. We would like to present our ideas to you or a subcommittee that you may designate.

In closing, I would note that we all feel that the recent Commission meetings have been particularly productive, and the level of participation has been excellent. Designed to bring together members of the public, each having an impressive background in historic preservation, with representatives of the various state agencies whose missions include some direct responsibility for the State House, the Commission offers a unique resource to the Legislature. We look forward to continuing to work with you and would be happy to meet with the Council to discuss the priorities for work that we have identified, as well as the Commission's work in general.
