### CALL TO ORDER

The Chair, Rep. Gwadosky, called the Council to order at 3:24 pm in the Council Chambers.

### SECRETARY'S REPORT

The Summary of the August 16, 1993, meeting was approved and placed on file. (Motion by President Dutremble; second by Sen. Carpenter; unanimous).

## **EXECUTIVE DIRECTOR'S REPORT**

Sally Tubbesing reported that she had no items for Council action other than those that appeared elsewhere on the agenda.

## **REPORTS FROM COUNCIL COMMITTEES**

### **Personnel Committee**

This item was deferred, by unanimous consent of the Council, until all other business had been acted upon.

## **OLD BUSINESS**

**Item #1:** Request from Jt. Standing Committee on Audit & Program Review for Allocation of Resources to Support Committee's Interim Work Schedule (Tabled at July 14, 1993 meeting).

**Motion:** That this item be tabled. (Motion by Sen. Dutremble; second by Sen. Cahill; unanimous).

## **NEW BUSINESS**

**Item #1:** Cloture Date and Related Deadlines for Second Regular Session

The Chair, Rep. Gwadosky, noted that the Council's authority to approve bills for introduction to the Second Regular Session is proscribed by the Joint Rules. He drew members' attention to the proposed schedule of deadlines and Council meetings related to this process, noting that one objective of the schedule is to permit all bills to be drafted and printed by the time the Legislature convenes in January.

**Motion:** That the proposed schedule, as amended, be approved. (Motion by Speaker Martin; second by Sen. Carpenter; unanimous).

A copy of the schedule adopted by the Council is attached to this meeting summary.

**Item #2:** Notification of Sale of State Property by the Maine Forest Service pursuant to statute.

**Motion:** That the notification be accepted and placed on file. (Motion by Sen. Dutremble; second by Rep. Paradis; unanimous).

**Item #3:** Joint Select Committee on Rules: Submission of Report

**Motion:** That the Report be accepted and placed on file. (Motion by Speaker Martin; second by Rep. Paradis; unanimous).

**Discussion:** Senator Bustin, who co-chairs the Jt. Select Committee on Rules, noted that the Committee's report was innovated and creative. She stated that while it does not recommend the adoption of concept drafting, it does recommend relaxing the rules of confidentiality as they currently apply to bills introduced in the First Regular Session and that this would achieve many of the efficiencies identified by advocates of concept drafting. She encouraged Council members to read the report and direct their questions, comments and suggestions through Julie Jones, who staffs the Committee.

## EXECUTIVE SESSION

**Motion:** That the Council go into Executive Session for the purpose of discussing matters related to personnel. (Motion by Sen. Dutremble; second by Sen. Bustin; unanimous).

The Council proceeded to go into Executive Session at 3:35 p.m.

## RECONVENE

The Council reconvened in open session at 4:45 p.m. and proceeded to take up business related to the report from the Personnel Committee, which had been deferred earlier in the meeting.

**Motion:** That the legislative employees be treated similarly to employees in the executive branch with regard to compensation, with the exception that the schedule of furlough and/or shutdown days be determined by the Council. (Motion by Speaker Martin; second by Sen. Bustin).

**Discussion:** The Chair, Rep. Gwadosky, clarified that the effect of the pending motion would be to restore 3% and 2% to the salaries of employees from whom these had initially been withheld and award a 7% cost-of-living increase to all legislative employees. The shutdown days would partially offset the cost of this increase.

The vote was then taken, and the motion was approved 7-3.

The Council then proceeded to discuss issues related to the schedule of shutdown days. After some general discussion, members agreed that the Directors should develop a recommended schedule for consideration at the next Council meeting that incorporated the principle of designating certain employees as "emergency personnel" so that the legislative schedule would not be adversely affected.

**Motion:** That the 2% salary reduction and 3% cost-of-living increase which was originally withheld from the Constitutional Officers be restored and, further, that the Constitutional Officers be eligible for step increases on their next anniversary date. (Motion by Speaker Martin; second by Sen. Bustin).

**Discussion:** The Chair, Rep. Gwadosky, in response to a question from Sen. Cahill, clarified that because the pending motion did not include the 7% cost-of-living increase, it did not address shutdown days. Rep. Whitcomb then asked if these step increases would require Council action, and the Speaker responded affirmatively.

The vote was then taken, and the motion approved 8-2.

SUBJECT: Implementation of Rules Committee Recommendations  
Regarding Bill Drafting

The Report from the Joint Select Committee on Rules, which the Council adopted at its September 8 meeting, suggested that the elimination of various technical details currently included in initial drafts of bills would speed up the initial drafting process. As you know, the Rules Committee included the staff Directors in their discussion of these changes. We deeply appreciate the opportunity to have been involved in the discussions and have continued to meet to discuss how these changes could be implemented to support the more timely availability of initial bills without diminishing the information available to committees for their deliberation.

Before we proceed to implement the proposal, we want to confirm that this was the Council's intent in accepting the Rules Committee's report. The technical details that we would eliminate in initial bill drafts include:

- a. Cross reference checks to determine whether sections that the proposed bill would repeal are mentioned in other sections of law;
- b. Amending all affected sections of the statutes when a bill proposes a name change (e.g. agency or department name, program name, or job title); and
- c. Making style corrections in sections of current law that the proposed bill would amend.

These technical details all require significant research, drafting and proofreading resources. Implementation of these proposed changes would defer this technical effort until it is clear that the committee is going to take favorable action on a bill. The technical changes would, however, all be incorporated before bills are reported out from committee, and thus potentially increase the time required to process final committee amendments. Finally, we would propose to involve both committees and staff in evaluation of the effectiveness of these changes at the end of the Second Regular Session and present this information to the Council at that time.

Enclosed, please find a copy of the summary report on the First Roundtable Conference on Parole held 25 August 1993 along with the conferees guideline proposals answering agenda questions. Your comments on these materials will be appreciated.

Based on the success of this first conference, we have decided to sponsor a second conference on parole sometime in December and would like to invite you to attend. Due to the prevalence of scheduling conflicts arising over the timing of the First Conference, we are hopeful that this longer lead time will permit a consensus to be reached among prospective conferees as to the exact date of the Second Conference. Therefore, if you would like to attend the Second Conference on Parole in December, please contact me regarding the days and times most convenient to work into your schedule of commitments. The purpose of this Second Conference on Parole will be to work out the details of what revisions, clarifications and so forth will be necessary to develop and present in order to improve L.D.901's prospects of being passed into law during the 1994 Legislative Session.

Also, we would like to invite the entire Joint Select Committee on Corrections to the Maine State Prison on a day of your choice in November for an informal discussion on parole in order that the Committee's input, observations and comments may be incorporated into the proceedings of the Second Conference on Parole. Warden Magnusson made this suggestion during the course of the First Conference and the NAACP/Prison Chapter agrees that this would be a useful endeavor. As with the proposed Second Conference on Parole, we are leaving the actual date and time flexible in order to facilitate attendance. If this concept meets with your approval as Co-chair of the Committee, it would be most appropriate for you to arrange a suitable date among the committee members. Warden Magnusson has assured the NAACP/Prison Chapter's Board of Directors that the prison can make arrangements for any week day that is convenient to your Committee.

I will look forward to your reply.

Dear Chair Gwadowsky:

The Joint Standing Committee on Education is currently preparing a package of recommendations on education funding to the Second Session of the 116th Legislature. After considerable discussion and deliberation, we believe additional data on the status of Maine public schools will be required before we can complete our analysis and recommendations for reform. With the help of an independent researcher at the University of Southern Maine's Edmund S. Muskie Institute for Public Affairs, Prof. Josephine LaPlante, we have identified a number of gaps in available data that can be filled through a short term research project. They include the following:

- (1) Develop a profile of each district's resource availability, preferably on a school by school basis, and identify any pressing gaps
- (2) Evaluate the effects of level state spending on expenditure trends in districts of varying wealth
- (3) Develop a profile of student characteristics known to affect educational delivery costs, such as the percentage of children eligible for free/reduced lunches
- (4) Determine the extent of salary variations for teaching professionals and administrators with similar credentials across districts

(5) Assess the relationship between educational costs and school and school district size

Prof. LaPlante's work for the Governor's Task Force to Provide Recommendations Regarding School Funding Issues included preliminary study of these and other issues. We believe that completion of that work by collecting valid, statewide data on these subjects will provide an accurate base upon which to build a consensus for sound policy decisions.

We have calculated a cost of approximately \$6,000 for Prof. LaPlante to complete the research by January 1, 1994. The money will pay for computer programming time, a 10% overhead fee to the Muskie Institute and Prof. LaPlante's time. Prof. LaPlante will also donate a minimum of 10 hours per week by her graduate assistant to aid in the research project.

Given the bi-partisan support for this project on the Education Committee and knowing of your support for quality and efficiency in the public schools, we are requesting that the Legislative Council and the Governor's Office each contribute \$3,000 to this project. We believe this research is crucial to accurately evaluating the condition of public education in Maine, and will permit policy makers to act on facts instead of relying on assumptions and anecdotes. Your support, together with the support of the Governor, will send a strong message that the legislative and executive branches of government are committed to continuing the improvement of Maine schools.

We would be happy to meet with you at your convenience should you have any questions or require further elaboration. Thank you for your consideration of our request.


