### MEETING SUMMARY January 11, 1995

#### **Approved February 8, 1995**

#### **CALL TO ORDER**

The Chair, Senator Amero, called the Council to order at 10:55 a.m. in the Council Chamber.

#### **SUMMARY OF DECEMBER 29 COUNCIL MEETING**

The Meeting Summary was approved and placed on file. (Motion by Rep. Jacques; second by Rep. Mitchell; unanimous).

#### **EXECUTIVE DIRECTOR'S OFFICE**

Sally Tubbesing presented the following items for the Council's consideration:

#### Item #1: Report on Bills Filed by Cloture

Ms. Tubbesing deferred to Meg Matheson, Revisor of Statutes, who reported that 2084 bill requests had been filed by the cloture deadline the previous Friday, January 6, at 4 p.m. She noted that the total number filed represented a slight increase over the total number filed two years earlier; and that she expects the number to grow by as many as 200, since the deadline for receipt of Governor's and Department bills is not until February 4.

Rep. Mitchell asked if the Revisor's Office would be providing a revised list of bill titles that incorporates the requests filed since the "preliminary" cloture date of December 16. Ms. Matheson responded that she hoped to have the list available by the first part of the week.

No Council action was required on this item.

### Item #2: Notification of New Employees Hired to Fill Existing Vacancies Pursuant to Council Approval

Ms. Tubbesing drew Council members' attention to resumes in their agenda packets for Ms. Colleen McCarthy and Mr. Mark Knierim, who had been hired to fill vacant positions as an Analyst in the Office of Policy and Legal Analysis and Associate Law Librarian in the Law and Legislative Reference Library respectively. She noted that these individuals had been offered positions pursuant to approval from the 116th Legislative Council to fill two vacancies, but that it was customary to notify the Council once the selection process was complete.

#### Discussion

Council members raised the following questions with regard to the new employees:

Whether the individuals were already "on board". (Sen. Kieffer)

Ms. Tubbesing responded that both had established starting dates and had given notice to their current employers, but that neither had actually reported for work.

The impact of not filling the positions. (Sen. Bustin)

David Boulter responded that the Analyst position would be assigned to the Joint Standing Committee on Banking and Insurance and that the preliminary list of bill titles suggested that this Committee would have a workload of 100-125 bills which he could not otherwise cover. Lynn Randall noted that the Associate Librarian position in question would be assigned responsibility for providing reference assistance to Library users and keeping the Library's periodicals collection updated.

 Whether staff who had previously been assigned to the Audit & Program Review Committee should not be placed in these positions. (Rep. Whitcomb)

The Chair, Sen. Amero, noted that she had discussed this with David Boulter and understood that the employee in question was not interested in the position. David Boulter concurred, noting that he had explored this possibility as well.

No Council action was required on this item.

#### REPORTS FROM COUNCIL COMMITTEES

The Chair, Sen. Amero, reported that she and Rep. Mitchell had met on several occasions to organize the committees and announced that Council members would be receiving letters of appointment later that day. Recognizing the many demands on Council members' time, she expressed her hope that all would agree to serve.

#### OLD BUSINESS

None.

#### **NEW BUSINESS**

#### Item #1: Legislative Budget: Introduction

Sally Tubbesing drew Council members' attention to materials that summarized the various appropriation accounts under the Council's jurisdiction, and provided information related to expenditure history, current year budgets and budget requests for the FY 1996-1997 biennium. After reviewing these materials briefly, she deferred to the Secretary of the Senate, May Ross; the Clerk of the House, Joe Mayo; and each of the nonpartisan office directors -- Lynn Randall, Law Librarian; Margaret Matheson, Revisor of Statutes; John Wakefield, Director, Office of Fiscal and Program Review; Dave Boulter, Director, Office of Policy and Legal Analysis; and Dick Sawyer, Administrative Services Director. These individuals proceeded to describe the organization and staffing of their respective offices, including the positions they had eliminated recently or held vacant. They also described the primary functions of their offices.

These presentations were interrupted following the discussion of the Revisor's Office so that the Council could turn to other items on its agenda; and Council members agreed to continue the overview of the budget at the next Council meeting.

Motion: That the discussion of the budget be tabled to the next Council meeting. (Motion by Rep. Jacques; second by Rep. Mitchell; unanimous).

Item #7: Requests for Council Approval to Introduce Joint Resolutions and After Deadline Bills

This item was taken up out of order by consensus. The Chair, Sen. Amero stated that she thought it would be helpful to develop guidelines before the Council voted on any of the requests. Rep. Carleton suggested that those sponsors present should be given an opportunity to explain why they missed cloture. Speaker Gwadosky then explained that the Council had, in the past, asked sponsors of after deadline bills to first work with a committee to see if there was already a bill before the committee that could provide a vehicle for incorporating the intent of the after deadline request. He clarified that the Council would table the request until the sponsor had completed this. Discussion then turned briefly to Council procedures for considering Joint Resolutions.

The Council then proceeded to consider requests to introduce legislation to the Second Regular Session. A summary of the Council's action on these requests is attached to this meeting summary.

Item #2: Consideration of Salary for Attorney General pursuant to Statute

The Chair, Sen. Amero, asked Sally Tubbesing to review the Council's statutory authority with regard to setting salaries for the constitutional officers. Ms. Tubbesing drew members' attention to the copy of the law (3 MRSA § 162-B) that was in their packets.

Motion: That Items 2, 4 and 5 on the NEW BUSINESS Calendar be tabled until later. (Motion by Sen. Bustin, second by Rep. Jacques; unanimous).

Item #3: Recommendations from Committee to Study Organizational and Tax
Issues in Public Schools for Expending the Remainder of its
Budget

The Chair, Sen. Amero, reported that she had spoken with members of the Committee to Study Organizational and Tax Issues in Public Schools regarding their request and that they had all expressed their strong support for the \$3,000 "investment" in a school facilities inventory survey, on the basis that the State invests millions of dollars in school construction every year.

Rep. Mitchell, referring to her own experience on the Education Committee during the previous biennium, noted that the Committee had struggled constantly with the lack of data to make sound decisions. Sen. Kieffer expressed concern that a one-time survey would not really address the problem and asked what the long-term goal would be. Sen. Amero responded that the survey could be incorporated in another form that Superintendents are already required to complete annually. Sen. Kieffer reiterated his concern that the information be used once it is collected.

The discussion then turned to what would happen to the unexpended funds in the Committee's appropriation, and Ms. Tubbesing clarified that unexpended funds would lapse to the legislative account. Various Council members expressed concern about the Council's deciding to authorize expenditure of the unexpended balance, suggesting that if the projects proposed by the "Rosser Committee" were important, they should either a)be in the Department of Education's budget (Sen. President Butland) or b) come forward to the Council as recommendations from the Joint Standing Committee on Education (Rep. Jacques).

Motion: That the Chair send a letter to Dr. Rosser and the Committee thanking them for their work and their frugality and directing them to take their request to the Joint Standing Committee on Education for discussion and recommendation to the Council and the Legislature. (Motion by Sen. Lawrence; second by Rep. Carleton; unanimous).

The Chair, Sen. Amero, drew Council members attention to a second letter from Dr. Rosser that had been received just prior to the meeting, asking for an extension of the Committee's reporting deadline to February 13. Noting that this extension would require legislation, Speaker Gwadosky offered the following motion:

Motion: That a bill be drafted to extend the Committee's statutory reporting deadline. (Motion by Speaker Gwadosky; second by Rep. Carleton; unanimous).

Note: This bill is included on the attached list summarizing the Council's action on After Deadline bill requests.

#### **EXECUTIVE SESSION**

Motion: That the Council proceed into Executive Session for the purpose of discussing items related to personnel. (Motion by Speaker Gwadosky; second by Sen. Bustin; unanimous).

The Council proceeded to go into Executive Session at 12:37 p.m.

#### RECONVENE

The Chair, Sen. Amero, reconvened the Council in open session at 1:50 p.m. and then drew Council members' attention to Item #2, which had previously been tabled.

Item #2: Consideration of Salary for Attorney General pursuant to Statute

Motion: That the Council set the salary of the attorney General in Range 91, Step 5 pursuant to statute. (Motion by Sen. Lawrence; second by Rep. Carleton; unanimous).

Item #4: Consideration of Salary for the Secretary of the Senate

Motion: That this item be tabled. (Motion by Sen. Lawrence; second by Rep. Mitchell; unanimous).

Item #5 Review of Support Positions Previously Assigned to the Joint Standing Committee on Audit and Program Review

Motion: That the following positions be eliminated in the Office of Fiscal and Program Review effective February 1: one Principal Analyst and one Analyst position that have been assigned to the Joint Standing Committee on Audit & Program Review and one vacant Analyst position originally established to support the preparation of municipal fiscal notes. (Motion by Rep. Whitcomb; second by Sen. Kieffer; unanimous).

Note: The original motion was amended with a "friendly amendment" from Sen. Lawrence to include an effective date.

Motion: That the Council authorize John Wakefield to fill the vacant Analyst position. (Motion by Speaker Gwadosky; second by Rep. Whitcomb; unanimous).

Motion: That the Council defer action on the Senior Secretary position currently assigned to the Audit Committee until the next Council meeting. (Motion by Speaker Gwadosky; second by Rep. Mitchell; unanimous).

Item #6: Letter from William A. Pierce Regarding Joint Standing Committee on Audit and Program Review

Motion: That the letter be accepted and placed on file. (Motion by Rep. Jacques; second by Sen. Kieffer; unanimous)

#### ANNOUNCEMENTS AND REMARKS

The Vice-Chair, Rep. Mitchell, reported that she and Sen. Amero were working as quickly as possible to organize the TQM Subcommittee on Rules and asked Council members for their recommendations. Speaker Gwadosky suggested that they consider bringing in all new members.

The Council meeting was adjourned at 1:55 p.m.
