The Chair, Senator Amero, called the Council to order at 10:40 a.m. in the Legislative Council Chamber.

SECRETARY'S REPORT

Motion: That the Summary of the May 5 Council meeting be accepted and placed on file. (Motion by Speaker Gwadosky; second by Rep. Jacques; unanimous).

EXECUTIVE DIRECTOR'S REPORT

Sally Tubbesing presented the following items for the Council's consideration:

Ms. Tubbesing drew members' attention to the materials in their agenda packets, which had been included in response to a request from Sen. Kieffer at the last Council meeting. Ms. Tubbesing noted that, pursuant to enactment of statutory language by the 115th Legislature which assigns responsibility for oversight of Capitol Park to the Council, she had worked with the Director of Capitol Security and others to develop a process for reviewing requests to use Capitol Park. The current process has evolved from experience with various events since 1991. Organizations who wish to use Capitol Park complete an Activity Permit, as they would to have an event anywhere in the Capitol Complex. The Director of Capitol Security and his staff then screen these applications and review them with Ms. Tubbesing. Depending on the nature of the event, they will meet with the applicant to review the rules and to request that the applicant make additional provisions (e.g. sanitary facilities; security; etc.)

The Chair, Senator Amero, recognized Donald Suitter, Director of Capitol Security, and Norm Finley, Superintendent of Grounds. Chief Suitter stated that many groups want to use the Park and that he had taken it upon himself to say "no" to some groups, citing specifically a radio station who had proposed having a rock concert in the Park. He noted that the process that had been developed has worked well, particularly with groups having special requests.

In the brief discussion that followed, Speaker Gwadosky asked how many people had actually participated in the Prayer Vigil the previous fall. Chief Suitter estimated that the crowd had never exceeded 700 - 800 at any one time. The Speaker then thanked Chief Suitter for the "wonderful job he had done coordinating" on behalf of the State, adding that the process seems to work smoothly. Chief Suitter responded that he and his staff take great pride in the Park

He then noted that it was more difficult to process requests for use of the Park when the Legislature was not in session. Rep. Jacques responded that he would defer to Chief Suitter's judgment; and Rep. Whitcomb concurred, adding that he would encourage Chief Suitter to err on the side of conservatism in his reviews.

The Chair, Senator Amero, thanked both Chief Suitter and Mr. Finley for coming to the meeting.

No formal Council action was required on this item.

Note: The following items were deferred until the Council had completed its consideration of the rest of the agenda.

Item #2: General Status Report

Ms. Tubbesing drew members' attention to the Summary Report of the Status of Bills Remaining in Committee, noting that most committees had come very close to meeting the targets established by the presiding officers. She further noted that the presiding officers had set Friday, June 2, as the deadline for completion of work on all bills still remaining in committee.

In response to a question from Rep. Mitchell, Margaret Matheson reported that there were only 16 bills remaining in the drafting process, of which 5 were awaiting signature.

No Council Action was required on this item.

Item #3: Personnel Actions

Ms. Tubbesing reported that Richard Sawyer, Administrative Services Director, had decided to retire from the Legislature effective June 30, having worked as a state employee for more than 33 years, and a member of the non-partisan staff since 1977. She drew members' attention to the position description for the Administrative Services Director, noting that the responsibilities and duties are both significant and central to the effective and efficient operation of the Legislature. She requested that the Personnel Committee meet with her to discuss the opportunities for filling the position.

Sen. Amero stated that she had talked with Mr. Sawyer briefly since learning of his decision to retire and expressed appreciation for his service.

No Council action was required on this item.

Sen. Amero then recognized Mr. Dogherty, who expressed his interest in having a full-time presence in the State House. He noted that Foster's Daily Democrat covers several Maine towns; and Rep. Carleton affirmed that the paper has a "significant presence" in southern Maine.

Dear Sen. Amero, Rep. Mitchell and Members of the Council:

Early in the session the Kennebec Valley Medical Center filed an application for review of agency rules pursuant to 5 MRSA §11111. The request made in the application was for the committee to review the Principles of Reimbursement for Nursing Facilities, section 86.1, concerning reimbursement for nursing facility services.

The Human Resources Committee met on May 5 and considered the application. It heard presentations from the Kennebec Valley Medical Center and the Department of Human Services. During the course of the hearing, the department offered to amend the definition of hospital-affiliated facility in the Principles of Reimbursement for Nursing Facilities. The manner in which the department proposed amending the definition was discussed by committee members with the department and with the Kennebec Valley Medical Center. The amendment appears to meet the needs of the medical center and the department. It met with the approval of the committee members.

The Human Resources Committee terminated the hearing and voted to endorse rulemaking to amend the definition of nursing facility. The committee has received a copy of a department memorandum indicating that the rulemaking to amend the definition as agreed upon in the hearing will be undertaken. The committee understands that the Bureau of Medical Services has been fully occupied with issues before the Appropriations Committee and awaits rulemaking by the bureau when the pressure of other work subsides.

Dear Senator Amero & Legislative Council Members:

By meeting four days a week since March 27, the Judiciary Committee has completed work on a number of difficult and controversial bills. Our time commitment to these issues is summarized at the base of the enclosed chart.

Since mid-April, however, we have received 41 new bills, about twice as many as received by any other committee in the same time frame. As a result, we are now tied with Taxation for the largest number overall.

Public hearings for these new bills were promptly scheduled -- in some cases even before we received a reference from the floor. Last week we finished up our public hearings on these bills by holding 26 of them in three days. We also held a dozen work sessions.

Every bill still remaining in committee is now scheduled for work session in the four days left before June 2. We will do everything we can to report each of them out by the new deadline. With a little luck, we may succeed.

In the meantime, please understand that this recent accumulation of bills does not result from any lack of industry on the part of the Committee or its staff.

Dear Senator Amero and Representative Mitchell:

The Maine State Museum is responsible for historic artifacts in the Blaine House including four silver pieces which sailed aboard both the first and second ships called *USS MAINE*. These pieces have been on loan from the U.S. Navy to the State of Maine since 1922.

In 1994 the Navy offered to give three of these pieces to the state and to leave the fourth on loan until the commissioning of the new USS MAINE, the submarine SSBN741. The fourth piece is a loving cup with moose antler handles.

The Navy offer included the words "... the loving cup may remain on loan to the State until a new USS MAINE is commissioned or until arrangements regarding a contemporary silver service are made."

Governor McKernan signed the letter accepting this proposal on July 1, 1994 and the Naval Supply Systems Command has been proceeding on this basis.

Brigadier General Earl Adams is now heading the State's official participation in the Commissioning of the submarine on July 29, 1995. This event represents a proud moment in the long history of mutual respect and support shared by the U.S. Navy and the State of Maine.

If any discussion of official gifts for the submarine should come before the Legislative Council I request that General Adams and I be notified so we can provide accurate information on the status of the State's involvement.

Dear Mr. Phillips:

This responds to your letter of April 11, 1994 in which you assert ownership to four presentation silver pieces recovered from the battleship USS MAINE in the Havana Harbor following an explosion on February 15, 1898.

After careful review of our records, including documents dated 1922, we must inform you that the Department of the Navy owns the silver pieces. The enclosed letter of May 5, 1922 addressed to the then Governor of Maine, Percival D. Baxter, clearly indicates that the presentation silver was loaned to the State for an indefinite period. Because the transfer was only a loan, the two 1970 letters referenced in your letter viewed in context of the May 5, 1922 letter, do not support your assertion that the presentation silver is the property of the State of Maine.

However, in light of the long standing tradition of support by the people of the State of Maine for our naval forces, the Secretary of the Navy is willing to relinquish ownership of several pieces of silver while retaining title to one piece. Although we propose to retain title to the loving cup and transfer ownership of the remaining three pieces after execution of appropriate documents, the loving cup may remain on loan to the State until a new USS MAINE is commissioned or until arrangements regarding a contemporary silver service are made.

Dear Senator Amero:

We are writing on behalf of the Joint Standing Committee on Natural Resources to request permission for the committee to conduct a study during the up-coming interim on issues relating to dams.

We propose to study two major issues:

- 1. Issues related to abandonment of dams not now regulated by the FERC or the state DEP, including water level regimes, draw downs, effects on fisheries and revegetation planning; and
- 2. The costs and time involved in licensing and relicensing which my cause dam ownership and operation to become uneconomic and thus result in some form of abandonment, and what may be done to reduce these regulatory burdens or to facilitate dam transfer to government or other entities which are willing to manage the operation of these dams.

We would propose to meet no more than 4 times over the course of the interim. We would request the assistance of staff appointed by the Council.

In a separate letter (copy attached) we have requested to carry over LD 646, "An Act to Reinstate the Laws Governing Dam Abandonment". This bill would provide us a useful vehicle for reporting out our recommendations on these issues next session.

The committee is concerned because this bill deals with issues which are currently the subject of a pending court decision. The committee does not want to affect the court's decision with either an Ought to Pass or Ought Not to Pass report.
