

Item #1: Proposed Studies

Item #2: Discussion of Funding Available

The Chair, Senate President Lawrence, opened the discussion by asking the total cost of the proposed studies. Sally Tubbesing responded that, as proposed, they totaled \$290,000. Representative Murphy then asked whether money had been included in the Legislature's budget for Committee studies; and Senate President Lawrence replied that \$150,000 had been earmarked for interim committee work. Representative Saxl clarified that these funds had been included to support committees' oversight function and that it was important to reserve the resources for this purpose. He went on to inquire whether some of the proposed studies could be funded from external sources. The Chair, Senate President Lawrence, stated that the fundamental question is how much the Council wants to devote to studies. Representative Murphy agreed, noting that the decision of how many studies to approve needed also to take into account the availability of staff. Representative Saxl asked Ms. Tubbesing how many studies had been funded in 1998, following the 2nd Regular Session of the 118th Legislature; and Ms. Tubbesing responded that 18 studies had been approved at a total cost of approximately \$75,000.

Item #3: Structure and Organization of Study Commissions

Representative Saxl asked whether the Council was going to attempt to establish a consistent structure for all of the studies if approved, including the number of authorized meetings and number of legislative members. Senate President Lawrence added that the Council should also examine whether these commissions are authorized to report out legislation. Sally Tubbesing pointed out that several of the bills proposing legislation did not have emergency preambles so that the study committees would not even begin work until late August or September.

Item #4: Discussion of Funding Level

Senator Pingree proposed that the Council allocate \$140,000 for interim studies. Representative Campbell clarified that these funds would come out of the \$1 million that has been set aside for the table at the present time; and Representative Murphy reiterated his interest in taking advantage of the opportunity to tie some of the studies to the work of the Joint Standing Committee. Speaker Rowe expressed support for Representative Saxl's earlier comment that it is important not to tie committees to too many specific tasks that could divert their attention from the "big picture" – their oversight responsibilities. Senate President Lawrence asked Jim Clair how much was available for the Table; and Mr. Clair responded that if the Majority Report is enacted, the projected balance would be approximately \$8 million. Representative Saxl suggested that the Council allocate up to \$100,000 for studies, and further, that the Council agree on a target number of studies that it wanted to support.

Following general discussion, Council members proceeded to consider proposed studies. The Council agreed to meet again to complete its work on April 26. The Summary of its actions on studies is attached to that Meeting Summary.

Text of Joint Select Committee on the Psychiatric Treatment Initiative, written appropriately for a joint order

- Sec. 1. Committee established. The Joint Select Committee on the Psychiatric Treatment Initiative, referred to in this joint order as the "committee," is established to work with the interested parties in the community and to report regarding the actions taken by the Department of Mental Health, Mental Retardation and Substance Abuse Services regarding the recommendations for improved community services as described in the executive summary of the report "Maine Inpatient Treatment Initiative: Civil and Forensic."
- Sec. 2. Membership. The President of the Senate shall appoint 4 members from the Senate, 2 of whom are not members of the majority party. The Speaker of the House shall appoint 4 members from the House of Representatives, 2 of whom are not members of the majority party. In making the appointments, preference must be given to members of the Joint Standing Committee on Health and Human Services, the Joint Standing Committee on Appropriations and Financial Affairs and the Joint Standing Committee on Criminal Justice.
- Sec. 3. Appointments; chairs; convening of committee. All appointments must be made no later than August 1, 2000. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been made. The first named Senate member is the Senate chair and the first named House of Representatives member is the House chair. The first meeting must be called by the chairs no later than September 1, 2000.

Sec. 4. Duties. The duties of the committee include:

- 1. Overseeing the efforts of the Department of Mental Health, Mental Retardation and Substance Abuse Services to address the recommendations for departmental action detailed in pages 24 to 26 of the executive summary of the report "Maine Inpatient Treatment Initiative: Civil and Forensic";
- 2. Working with community hospitals, community psychiatric hospitals, community providers, consumers of mental health services and interested members of the public; and
- 3. Reporting on the actions taken by the Department of Mental Health, Mental Retardation and Substance Abuse Services to the Joint Standing Committee on Health and Human Services, the Joint Standing Committee on Appropriations and Financial Affairs and the Joint Standing Committee on Criminal Justice by November 1, 2000.

If the committee requires a limited extension of time to conclude its work, it may apply to the Legislative Council, which may grant the extension.

- Sec. 5. Staff assistance. Staffing may be provided by the Office of Policy and Legal Analysis by request of the committee to the Legislative Council, with secondary staffing provided by the Department of Mental Health, Mental Retardation and Substance Abuse Services. The department shall provide information, data and research services as reasonably required by the committee. The committee shall request the assistance of and shall invite to their meetings representatives of the Department of Mental Health, Mental Retardation and Substance Abuse Services, the Department of Human Services and the Department of Corrections.
- **Sec. 6. Compensation.** The members of the committee are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2, and reimbursement of necessary expenses incurred for their attendance at authorized meetings of the committee.

Preamble. Whereas, Maine is a state that upholds the dignity of every human being, promotes basic human rights and supports social and economic justice; and

Whereas, Maine is a state that believes employers should fairly compensate hard work, that the health and safety of working people should be protected and that all forms of unlawful discrimination and abuse should not be tolerated; and

Whereas, there are manufacturers in foreign countries that do not share Maine's support of human rights and justice and those manufacturers' employment practices are characterized by poverty wages, forced overtime, child labor, unsafe and unhealthy workplace conditions and often abusive working conditions; and

Whereas, established international standards for ethical manufacturing are routinely violated; and

Whereas, sweatshops have been and continue to be a direct cause of job loss and depressed wages for citizens of Maine, whose employers relocate for cheap labor or threaten plant closings to force lower wages and contract concessions; and

Whereas, Maine can make a significant contribution to the campaigns against sweatshop manufacturing by supporting the enforcement of established ethical codes of corporate conduct; and

Whereas, there exists widespread popular support in Maine for the principle that purchases and investments by the State ought to be made under ethical conditions of production; now, therefore, be it

- Sec. 1. Commission to Study Economically and Socially Just Policies on Investments and Purchasing by the State established. Resolved: That the Commission to Study Economically and Socially Just Policies on Investments and Purchasing by the State, referred to in this resolve as the "commission," is established; and be it further
- Sec. 2. Commission membership. Resolved: That the commission consists of 12 members as follows:
- 1. Two members from the Senate appointed by the President Of the Senate, one from each major political party;
- 2. Two members from the House of Representatives appointed by the Speaker of the House of Representatives, one from each major political party;
- 3. Two members from groups involved in social investments or human rights issues, one appointed by the President and one appointed by the Speaker;
- 4. Two representatives of retail business, one appointed by the President and one appointed by the Speaker;
- 5. One representative of the Department of Administrative and Financial Services, Bureau of General Services, Division of Purchases appointed by the Governor;
 - 6. One member of the public appointed by the Governor;
- 7. One representative of labor unions appointed by the Governor; and
- 8. One representative of manufacturing and industry appointed by the Governor; and be it further
- Sec. 3. First meeting; chair. Resolved: That when the appointment of all members of the commission is completed, the Executive Director of the Legislative Council shall call and convene the first meeting of the commission. The commission shall select a chair from among its members at its first meeting; and be it further
- Sec. 4. Duties. Resolved: That the commission shall study the subject of economically and socially just policies for foreign investment and foreign purchasing by the State. In examining the issue of economically and socially just policies

for foreign investments and foreign purchasing, the commission shall evaluate the policies of other states. In its report, the commission shall propose standards concerning foreign companies that do business with the State and foreign companies invested in by the State. The commission shall consider such factors as child labor and exploitation of workers under unhealthy conditions. The commission shall make recommendations with regard to whether the State should do business with and invest in foreign companies that oppress or mistreat their workers. The commission shall identify the possible positive and negative impact of proposed policies on Maine workers, Maine small businesses and Maine taxpayers; and be it further

- Sec. 5. Staff assistance. Resolved: That, upon approval of the Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the commission; and be it further
- Sec. 6. Compensation. Resolved: That the members of the commission who are Legislators are entitled to the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2, and reimbursement for necessary expenses incurred for their attendance at authorized meetings of the commission. Other members of the commission who are not otherwise compensated by their employers or other entities that they represent are entitled to receive reimbursement of necessary expenses incurred for their attendance at authorized meetings; and be it further
- Sec. 7. Report. Resolved: That the commission shall submit its report, together with any necessary implementing legislation, to the First Regular Session of the 120th Legislature no later than November 1, 2000. If the commission requires a limited extension of time to conclude its work, it may apply to the Legislative Council, which may grant the extension; and be it further
- Sec. 8. Budget. Resolved: That the chair of the commission, with assistance from the commission staff, shall administer the commission's budget. Within 10 days after its first meeting, the commission shall present a work plan and proposed budget to the Legislative Council for approval. The commission may not incur expenses that would result in the commission exceeding its approved budget. Upon request from the commission, the Executive Director of the Legislative Council shall promptly provide the commission chair and staff with a status report on the commission's budget, expenditures incurred and paid and available funds; and be it further

Sec. 9. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
