REPORTS FROM EXECUTIVE DIRECTOR AND STAFF OFFICE DIRECTORS

• Executive Director's Report

David Boulter, Executive Director of the Legislative Council reminded members that legislators were invited to a reception at the Maine State Museum that afternoon from 4:30 to 6:30 p.m. to preview the Maine Civil War flag exhibit.

Mr. Boulter also reminded members that most committee work was done and, therefore, most of the committee clerks will be concluding their session work on Friday, May 30, 2003.

No Council action required.

• Fiscal Report

Grant Pennoyer, Director, Office of Fiscal and Program Review, presented the following fiscal report:

1. General Fund and Highway Fund Revenue Variances

For the month of April, General Fund revenues were under budget by \$14.8 and under budget year-to-date by \$5 million.

Individual income tax revenues were under budget by \$22.9 million in April and \$14 million under budget year-to-date. Cigarette tax revenues, although \$0.6 million over budget for the month of April, are still under budget for year-to-date by \$3.7 million. Sales tax was over budget for April, but under budget year-to-date.

Insurance tax and estate tax revenues were over budget for the month of April and also over budget year-to-date.

Excluding the negative variance in the individual income tax for April, the General Fund revenue would be ahead of budget by \$6.9 million through the end of April. Mr. Pennoyer said the May individual income tax revenue was encouraging and he believed the negative variance could be reversed if the June individual income tax collections follow the same trend. If they do, the General Fund revenue would be close to budget for Fiscal Year 03.

The Highway Fund revenues were up for both April and for year-to-date. Receipts of the funds for the Healthy Maine Tobacco settlement are under budget by \$1.1 million.

2. Cash Pool Status

Mr. Pennoyer reported that transfers from the Rainy Day Fund and the Working Capital Reserve were made mid-month. Excluding the Tax Anticipation Note and the reserve balances, the General Fund Cash Balance was minus \$378.1 million. The General Fund Cash Balance average for May moved to a positive value because of the individual income tax processing.

No Council action required.

Office of Information Services' Report

Paul Mayotte, Director Legislative Information Services, reported to the Council the status of the migration – bill drafting system.

The Legislature has a contract with H-P to install a new bill drafting system for the Legislature to replace the Wang bill drafting system currently in use. Last fall the H-P system failed its acceptance test because of the poor performance of the new drafting system. H-P is recoding the software to improve the performance and correct the deficiencies with an expected completion date for programming on June 6, 2003. Upon completion of the software coding, H-P will begin testing the corrected software at their facility, running an extensive series of test through June 22, 2003. On June 23, 2003 the corrected software will be loaded on the Legislature's server and an extensive test cycle will begin at the State House concluding on July 15, 2003 only with user acceptance of the testing.

Mr. Boulter and Mr. Mayotte met with H-P senior management during the past week. They restated the position of the Legislature that H-P remains obligated to deliver a fully functioning system to the Legislature, and, therefore, rejected several proposed modifications requested by H-P to modify what had been earlier agreed to.

Information Systems is planning for the implementation of the new system to support bill drafting for the Second Regular Session of the 121st Legislature, focusing on user training, support to the users, updating the statutes database and transitioning carryover bills from the Wang system to the new system.

Sen. Treat asked the status of the remote access. Mr. Mayotte reported that the process does work, but does not work reliably at this time and so has not been made available to Legislators.

Sen. Gagnon questioned what changes in the contract H-P had requested. Both Mr. Mayotte and Mr. Boulter said that the request was to narrow the scope of our discretion with respect to acceptance of the system. Contract Amendment 4 is favorable to the Legislature and they are not agreeing to any changes that might weaken the Legislature' position.

REPORTS FROM COUNCIL COMMITTEES

• Personnel Committee

Rep. Richardson, Chair of the Personnel Committee, reported that the committee met earlier in the day. It considered and unanimously approved temporary disability income benefits for a full-time legislative employee in accordance with provisions of the personnel policies and guidelines for legislative employees. No further action by the Legislative Council is required.

• State House Facilities Committee

The State House Facilities Committee did not meet.

Item #2: Multi Year Plan for State House Facilities and Grounds

Mr. Boulter presented the Legislative Council with a proposed Multi Year Plan prepared by Richard Burt, Architect. The plan represents a proposed multi year plan for maintenance and improvements of the State House and grounds. It is intended to be a working document to help plan activities for necessary work. Although the building has been restored, ongoing attention is required. Mr. Boulter emphasized that although the building was fully renovated, the work on the exterior of the building had not been done.

The Multi Year Plan explains what needs to be done, why it needs to be done, and provides a general indication of the schedule and an estimate of the cost. Mr. Boulter recommended to the Council that it refer the plan to the State House Facilities Committee for review and recommendation.

Sen. Treat said the plan assumes a maintenance budget and asked if it was included in the legislative budget or would it require additional appropriations. Mr. Boulter said the plan would not require additional appropriations since the Legislative Council's budget includes funds set aside for this purpose, including the Reserve Fund for State House Preservation and Maintenance.

Motion: That the Multi Year Plan be referred to the State House Facilities Committee for review and recommendation. (Motion by Sen. Treat, second by Davis, unanimous).

The only business before the Legislative Council was to review the special study committees.

Item #1: Requests for Interim Studies

President Daggett requested that David Boulter, Executive Director of the Legislative Council, remind the members of the Legislative Council of the guidelines for the legislative studies.

Mr. Boulter referred Legislative Council members to the informational sheet in their material regarding the requirements and protocols relevant to studies in the First Regular Session for review of the study requests. A copy of the requirements and protocols is attached to this Meeting Summary.

Mr. Boulter requested further guidance on several study elements if the Council were to accept the suggested protocol. The policy issues needing decisions are:

- a) Number of authorized meetings and locations. The Legislative Council has generally authorized 4 meetings or less, unless the Council specifically authorized an exception. He suggested that the members may want to consider a similar approach for these study requests;
- b) Compensation of Members. Some studies compensate all members with a per diem and necessary expenses, and some do not. Consistent with the Council's guidelines, Mr. Boulter recommended that legislators receive per diem and reimbursement of necessary expenses, other members who are not otherwise compensated, receive reimbursement of expenses, and a per diem only a bona fide demonstration of financial hardship;.
- c) Studies conducted using non-General Fund monies. Director Boulter recommended that a study may not convene until sufficient funds are received to pay for the study; and
- d) Preferred legislative instrument for establishing study committee recommendation. Study committees can be through resolves. If a study is by a resolve, it requires passage, and the signature of the governor and, absent an emergency preamble, the study would not begin until 90 days following adjournment (September or October). joint study orders have been preferred by the Legislative Council in past years since. Joint orders take effect immediately and are controlled totally within the Legislature. Mr. Boulter recommended use of joint study orders when feasible.

Motion: That the Legislative Council adopt the recommendations of the executive director regarding the 4 policy issues to be decided (a - d of the handout). (Motion by Sen. Treat, second by Sen. Gagnon, unanimous).

Motion: That the Legislative Council adopted the Suggested Protocol for deciding legislative study requests (A through D of the handout). (Motion by Speaker Colwell, second by Rep. Duplessie, unanimous).

Sen. Treat asked who would be redrafting the studies to meet the guidelines or the joint rules and whether the joint standing committees would be consulted. Mr. Boulter replied that the redrafting would be a joint effort among OPLA, OFPR, Revisor, and the Executive Director's Office. Mr. Boulter said that generally the Council-authorized floor amendments for studies have been given to Council members (or the chair and vice-chair of the Council) and have not gone back to committees since the study requests at this stage in the process are within the purview of the Legislative Council.

1. General Fund and Highway Fund Revenue Variances for May 2003 (Reflects revised forecasts and legislation enacted as of this date) (See Attached Summary of May 2003 Revenue)

General Fund

Total General Fund revenue was over budget by \$9.8M in May, which brought the General Fund back to a positive variance of \$4.8M for FY-T-D. This positive variance was driven largely by the Individual Income Tax positive variance in May, which was over budget by \$8.5 million for the month reducing its negative variance to \$5.5 million for the FY-T-D through May.

Highway Fund

Under budget by \$1.5M in May (Fuel Taxes were under budget by \$2.2 million reflecting a timing issue between April and May) but the Highway Fund remains over budget for FY-T-D by \$6.0M

Meeting Summary June 5, 2003

Senator Gagnon, chair of the State House Facilities Committee convened the committee at approximately 1:30 p.m. to consider 2 matters.

Item 1. Proposed multi year plan for maintenance and improvements to the State House and grounds.

Executive Director Boulter summarized the proposed plan and outlined the activities scheduled for 2003.

Architect Rick Burt was present and answered several questions regarding the plan, use of contractors, budgets and pre-qualification of contractors. The members engaged in a general discussion about various aspects of the plan. Among other things, the plan called for budgeting of contingency funds for the projects. After some discussion, the members felt that a 15% contingency for projects would be appropriate. Director Boulter noted that at times, additional expertise, working on the owner's behalf, would be necessary to verity that the work is being performed satisfactorily. Mention was made of hiring, by contract as needed, owner's representative services to perform the specialized inspections. For 2003, the only project that appeared to require this expertise is the roof replacement, west wing. Members suggested that for 2003 this service be included as part of the replacement project, in lieu of a more generalized arrangement for owner's representative services.

P.11 N0 The committee then informally reviewed a suggested motion, that other things required notice to the Legislative Council when a project cost exceeded by more than 10% the total project cost or allowance, including project fees and contingencies. Members generally felt that 5% would be more appropriate until such time as the Legislative Council has had more experience working under the multi year plan.

Motion: That the Facilities Committee recommend to the Legislative Council that it adopt the Multi Year Plan for Maintenance and Improvement; direct the Executive Director to take necessary measures to implement the plan in accordance with the schedules contained in the plan, notify the Legislative Council of project costs that exceed more than 5% of the project budget or allowance and to annually present recommended modification and amendments to the plan to the Legislative Council for its consideration; and further that the expenditures for the projects in any given year may not exceed budgeted and available resources, except as expressly authorized by the Legislative Council. (Motion by Rep. Duplessie, second by Rep. Bowles, unanimous)

Item 2. Reinstallation of Dioramas

The committee reviewed the email dated June 4, 2003, from Museum employee Sheila McDonald. J.R. Phillips, Director of the Museum, was present to answer questions by members. In summary, 2 of the 4 dioramas are fully completed; the remaining 2 are well underway, although a June 14 completion date now appears unlikely. The museum suggested that the work would be completed in July. Sen. Gagnon inquired as to what is causing the delay. Mr. Phillips explained that 2 unexpected problems had arisen: moose snow and deer grass. The problems have since been resolved. Sen. Gagnon expressed the very strong desire of the committee that the museum's work on the dioramas be fully completed by the end of June, not July. Given the remaining work to be done in the underground connector once the dioramas are completed, it is important for the museum to complete its work as soon as possible. Mr. Phillips acknowledged the concern of the committee and said he would make every effort to complete the diorama work by the committee's deadline of June 30, 2003.

No further action by the committee was required.

With no other matters having come before the committee, the chair adjourned the committee meeting.

The Council is also required by Joint Rule 35 to decide all requests for Memorials (Joint Resolutions that memorialize another governmental agency or official) for introduction.

You should plan to attend this Council meeting or present your request(s) to a member of the Legislative Council prior to the meeting. The Council may, but is not obligated to, table a request until the following meeting if the sponsor is not present, so it will have the benefit of information from the sponsor when it votes.

The Council's review of After Deadline Requests is pursuant to Joint Rule. Please be advised that the Council now asks all sponsors to <u>first</u> research whether there is an existing bill or LR available to a committee that could accommodate their request. The review procedure then will be as follows:

- 1. The Council Chair, President Beverly Daggett, will read the name of the sponsor and the title of the request.
- 2. Once recognized to speak by the Chair, the sponsor will probably be asked:
 - Why the bill request is "late" (filed after the cloture date);
 - Why the bill request constitutes an emergency such that the Legislature needs to consider the bill this session; and
 - Whether the probable committee of jurisdiction has a bill already referred to it that could be amended to include the proposal.

Council members may also ask questions related to the content or the intent of the bill.

3. Council members vote on bill requests individually; a roll call vote is required pursuant to Joint Rule.

A complete list of the Council's action on After Deadline Requests is distributed to Council members and all sponsors as soon after adjournment of the Council meeting as possible. The roll call votes are available in the Executive Director's office if you should have any questions.
