SUMMARY OF THE SEPTEMBER 29, 2003 COUNCIL MEETING

REPORTS FROM EXECUTIVE DIRECTOR AND STAFF OFFICE DIRECTORS

Executive Director's Report

In the interest of time, David Boulter, Executive Director, did not make a report to the Legislative Council.

Fiscal Report

Grant Pennoyer, Director, Office of Fiscal and Program Review, referred Council members to his written fiscal briefing. No oral follow-up report was given at the Council meeting. President Daggett told members that if they had questions about Mr. Pennoyer's fiscal report the Council would be able to address those questions after the consideration of the requests to introduce legislation in the Second Regular Session.

Office of Information Services' Report

In the interest of time, Paul Mayotte, Director, Legislative Information Services, did not make a report to the Legislative Council.

• Office of Policy and Legal Analysis

David Elliott, Director, Office of Policy and Legal Analysis included in the Council members' material a Progress Report on Legislative Studies. No oral follow-up was given.

A copy of the Progress Report on Legislative Studies is attached.

REPORTS FROM COUNCIL COMMITTEES

• Personnel Committee

Representative Richardson, Chair, Personnel Committee reported that the Committee met earlier in the afternoon. The Committee considered a request by a legislative employee for temporary disability income benefits as provided for under the Legislature's personnel policies and voted unanimously to approve the request.

No further action by the Council is required.

The Personnel Committee also discussed a request that a Jewish holiday be included as state-paid holiday under the Legislature's Personnel Policies and Guidelines. No action on the request was taken and the Committee will continue its discussion at a later meeting.

OLD BUSINESS

Item #1: Authorization for Acceptance of Funds for a Legislative Study (Reconsideration)

- Resolve To Study Obesity and Methods to Decrease the Cost of Health Care and Increase the Public Health (letter and Certification Relating to Contribution for Study from John A. LaCasse, President and CEO, Medical Care Development)

Mr. Boulter reminded members that Medical Care Development had initially submitted a certification and statement about contributions for the study and sought the Legislative Council's acceptance of funds from outside sources. Subsequent to the initial discussion and decision of the Council not to accept the funds, Medical Care Development has submitted detailed information that identified the specific contributions and from whom they were received.

Rep. Bowles asked if more information was available for the contributor listed as Kennebunkport - \$1,000. Mr. Boulter said he had no other information; it was presumed the contribution was from the Town of Kennebunkport.

Motion: That the Legislative Council accept the funding as identified by Medical Care Development in support of the committee to Study Obesity and Methods to Decrease the Cost of Health Care and Increase the Public Health. (Motion by Speaker Colwell, second by Sen. Treat, 7-2, Rep. Bruno and Rep. Bowles, opposed).

NEW BUSINESS

Item #1: Suggested Procedure for Deciding Legislative Bill Requests

The agenda included a suggested protocol for deciding legislative bill requests. President Daggett summarized the suggested protocol as follows:

- A. The Legislative Council will review bill requests alphabetically by sponsor. An exception to this order of review will be made for bill requests for which an ASL Interpreter is required for persons who are deaf or hard of hearing. Those bills will be taken out of order at a time during the meeting when an interpreter is available.
- B. For procedural consistency, when voting on a bill request, the initial motion on a bill will be presumed to be a motion to accept the bill request for introduction into the second regular session along with a second to that motion. (Yea is to let in a bill; nay is to reject the bill for introduction).
- C. In order to review all legislative requests in a timely manner, voting will be by a show of hands, with each Council Member's vote on each bill being recorded. The record of each vote will be made available for public inspection following the meeting.
- D. If a bill request has been identified by the Revisor as requiring a ruling under Joint Rule 217, the Legislative Council may vote to accept that bill for introduction, conditional upon a subsequent ruling by the presiding officers. Absent a vote to accept the bill, the bill is presumed to have been turned down by a unanimous vote of the Legislative Council.

- E. Legislative sponsors and others are welcome to observe the Council's deliberations on the bill requests, but discussion of the requests will be confined to Council Members. Discussion of a bill request among Council Members will be limited to whether it is appropriate for introduction under Constitutional provisions for second regular session bills, and will not speak to the merits of the bill itself.
- F. If the Legislative Council turns down a bill request, a Legislator may appeal that decision, and at a subsequent meeting of the Legislative Council, the Legislator may speak briefly to the bill request under appeal.
- G. A legislative request that has been identified by the Revisor's Office as being closely related to another legislative request that was earlier filed (i.e., having been assigned a lower LR number) or to a carryover bill is presumed to have been turned down by a unanimous vote of the Legislative Council.

Motion: That the Legislative Council adopt the suggested protocol, A-G, for deciding legislative bill requests as set forth in the "Review of Legislative Bill Requests" document dated October 22, 2003. (Motion by Speaker Colwell, second by Rep. Richardson, unanimous).

Item #2: Requests to Introduce Legislation for Consideration in the Second Regular Session

The Council then proceeded to consider and vote on 348 bill requests in accordance with the adopted protocol, above.

RECESS

The Council recessed at 4:12 p.m. on the motion of the Chair.

RECONVENE

The Chair reconvened the meeting at 4:25 p.m. and continued with consideration of the remaining bill requests and other items on the agenda.

The Council authorized 109 bill requests for introduction in the 2nd regular session of the 121st Legislature. The bills authorized by the Council for introduction is included on the attached list.

Item #3: Proposed Fee Schedule for Document Service for the Second Regular Session of the 121st Legislature

Clerk of the House Millicent MacFarland requested that the Legislative Council approve the proposed document fee schedule for the 2nd Regular Session.

Motion: That the Legislative Council approve the Fee Schedule for Document Service for the Second Regular Session of the 121st Legislature. (Motion by Rep. Bruno, second by Rep. Duplessie, unanimous).

Fiscal Briefing for the Legislative Council

November 18, 2003 Meeting

1. General Fund and Highway Fund Revenue Variances for October 2003 (See attached summary)

General Fund

Total General Fund revenue was under budget by \$2.5M in October, decreasing the positive variance for the Fiscal Year-to-date revenue to \$18.6M. Individual Income Tax was under budget by \$4.7M, but remained over budget for the Fiscal Year-to-date. Sales Tax was again over budget in October, now at \$5.7M over budget through October.

• Highway Fund

Total Highway Fund revenue was over budget by \$0.4M in October; increasing the positive variance to \$4.1M through October.

2. Revenue Forecasting Committee Recommendations

- Consensus Economic Forecasting Commission (CEFC) met on Friday, October 3rd at 12:30PM in the Appropriations Committee Room (Room 228, State House)
- CEFC made only minor adjustments to the economic forecast
- Revenue Forecasting Committee (RFC) met on Friday, November 14th (Room 228, State House) and concluded its fall forecast update. Presented below are the total change in the revenue forecasts by fund:

^{*} General Fund revenue revisions do not include amounts forecasted downward by the tax models for individual income tax and sales tax that totaled \$27.4 million for the 2004-2005 biennium. RFC wanted to wait for results of tax amnesty and holiday sales results.

• These adjustments to revenue for the Highway Fund and the Fund for a Healthy Maine put these funds out of balance for the 2004-2005 biennium. Highway Fund has a shortfall of approximately \$1.1 million. Fund for a Healthy Maine has a shortfall of approximately \$1.3 million.



Re: EXTENSION FOR OBESITY STUDY

Thank you for our recent appointment as chairs of the Commission to Study Public Health. Upon reviewing the enabling legislation for the study, we have come to the conclusion that a thorough and thoughtful analysis of the problem of obesity and its impact on public health and health care costs will not be possible within the constraints of the December 3, 2003 deadline contained within the legislation. We believe that the importance of the subject matter warrants enough time for careful consideration.

To this end, we respectfully request an extension of the deadline to December 31, 2003. Before that date, we propose to accomplish two tasks: to convene an organizational meeting of the Commission to Study Public Health on December 5, 2003, at which the Commission would create a plan for collecting, analyzing and addressing the 9 detailed areas of information that comprise the Commission's duties; and to submit legislation to the Second Regular Session of the 121st Legislature enabling the Commission to continue its work in the interim after the Second Regular Session and submit a report, including recommended legislation, no later than December 1, 2004.

Thank you for your consideration of this proposal.


Re: Request for Extension - Logger Payment Study

Date: October 27, 2003

The Joint Standing Committee on Agriculture, Conservation and Forestry has met twice during the interim to hear testimony and discuss issues relating to the payment of loggers. Joint Study Order H.P. 724, as amended by S-263, directed the committee to conduct the study during authorized interim committee meetings. We had planned to meet twice instead of 4 times to stay within the budget for interim meetings yet allow us to meet in Ft. Kent. With permission of the Presiding Officers, we met in Ft. Kent on September 12th. The focus of the meeting was receiving testimony from truckers and loggers in the St. John Valley.

We held our second meeting last Friday, October 24th, in Augusta. Although the Maine Department of Labor did provide information at this meeting, not all of the committees' questions were answered. Specifically, MDOL could not tell us the number of Canadian bonded workers actually employed in the logging and trucking of forest products in Maine. We are also seeking more detailed information on logging costs.

We are requesting that the December 3, 2003 report deadline established in the Joint Study Order be extended to April 1, 2004. The committee proposes to meet in early January to receive additional information pertinent to the study and allow testimony from landowners who have asked to address the committee. The committee anticipates devoting time on regularly assigned committee days during the 2nd Session to complete the study. We respectfully request that the deadline for the report and any legislation necessary to implement recommendations be extended to April 1, 2004.

Pursuant to Resolve 2003, Chapter 84, Section 9, we respectfully request an extension beyond the December 3, 2003 reporting deadline to permit the Task Force sufficient time to complete its examination of the behavioral, developmental, social, emotional and educational needs of deaf and hard-of-hearing children and adolescents who are not receiving adequate services. We request an extension of the reporting deadline for this Commission to January 23, 2004.

Our extension request is based on the fact that the Task Force will not be convened until November 20th and in recognition of the reality that the Task Force requires a reasonable amount of time to consider the complex policy issues involved in this study. Due to the "bilingual" nature of our communications with Task Force members, interested parties and the public, we are required to provide American Sign Language ("ASL") Interpreter services for Task Force meetings. This dynamic challenges the ability of the Task Force to conduct its business in a timely manner since it takes more to time to ensure that all involved in the Task Force meeting have access to these proceedings. In addition, Maine does not have an abundance of qualified ASL Interpreters and the availability of ASL Interpreter services is a significant issue as we schedule our meetings.

Simply put, these factors will confront Task Force members as we attempt to schedule the three remaining authorized meetings and complete our deliberations. The Task Force requires sufficient time to consider these issues and a reasonable opportunity to deliberate as we prepare our findings, conclusions and recommended legislation as required by law.

Establishing an early deadline for submission of major substantive rules

The Issue:

If the Legislative Council anticipates an adjournment of the Second Regular Session that is earlier than the statutory adjournment date of April 21, 2004, does the Council want to establish an early deadline for the filing of major substantive rules by state agencies that require legislative review in order to provide enough time to complete review of those rules before adjournment?

Background:

Major substantive rules are a type of administrative rule and when proposed by state agencies must be submitted to the Legislature for authorization prior to being finally adopted. Agencies will be filing new major substantive rules with the Legislature over the next few months. If rules are timely filed or late-filed rules are accepted for review, the Legislature <u>must</u> act on the rules next session or they go into effect without legislative authorization.

Under the Administrative Procedure Act, agencies generally may submit provisional rules for legislative review anytime up to 45 days before the statutory adjournment date. In the Second Regular Session of the 121st Legislature, the statutory adjournment date is April 21, 2004 so absent any change by the Legislative Council, the deadline for filing rules for legislative review is Friday, March 5, 2004.

The Council is authorized by statute to set an earlier deadline for submission of major substantive rules if it decides an earlier submission date is necessary to assure that the Legislature will have sufficient time to hear, work, draft and debate rules review legislation before it adjourns. Under the law, the Legislative Council may set a new filing deadline of up to 75 days before statutory adjournment if an early adjournment is anticipated.

Memo to Legislative Council Re: Deadline for major substantive rules November 13, 2003

It is my understanding that an adjournment date about 2 weeks earlier than the statutory date of adjournment is anticipated for the Second Regular Session.

Shortening the time for review by 2 weeks would have a noticeable effect given the lead-time necessary for advertising and holding public hearings on the rules. Committee work on rules review typically consists of publication of notice, public hearing and at least one work session before making a committee report. Historically, the Legislature has required some change to up to 2/3 of the rules filed for review.

The Options:

If adjournment is to be early -- on or about April 7th, 2004 -- the Council has the following options:

- A. Leave the current deadline of March 5th in place, in which case the available time for legislative review and action on the rules would be shortened by about 2 weeks (from 45 to 31 calendar days); or
- B. Establish an earlier deadline that is anytime between 75 days (February 6th) and the normal 45 days (March 5th) before statutory adjournment that would restore some or all of the time normally available for review of the rules.

Suggested New Deadline:

The Legislative Council may want to consider establishing a filing deadline of **Friday**, **February 20, 2004** (2 weeks early) which would allow the committees adequate time to complete their rule reviews by the time work on most other bills will have been completed. If the Council authorizes an alternative filing date, this office will notify affected agencies of the changed schedule for filing provisionally adopted rules.

Under the terms of the Maine Constitution, Section 1 of Article IV, Part Third, Legislative Power, the business of the second regular session must be limited to budgetary matters; legislation in the Governor's call; legislation of an emergency nature admitted by the Legislature; legislation referred to committees to study and report by the Legislature in the first regular session; and legislation presented to the Legislature by written petition of the electors (direct citizen initiative).
- 2. Under the 121st Legislative Council's Rules of Procedure, any action of the Council requires the affirmative vote of at least 6 members.
- 3. Under Rule 203 of the Joint Rules of the 121st Legislature, any vote of the Legislative Council to accept or reject a bill or resolve for introduction under the procedures established under the Joint Rules must be taken by the yeas and nays, and that vote must be recorded and made available for public inspection.
- 4. Under Rule 217 of the Joint Rules, a bill that has been introduced and finally rejected in a regular or special session may not be introduced in a subsequent session of the same Legislature except by a vote of 2/3 of both chambers. Therefore, determinations as to the relevancy of Rule 217 are within the purview of the presiding officers, not the Legislative Council.

Suggested Protocol for deciding appeals

- A. The Legislative Council will review appeals alphabetically by sponsor.
- B. For procedural consistency, when voting on an appeal of a bill request that was denied, the initial motion on a bill will be presumed to be a motion to accept the bill request for introduction into the second regular session along with a second to that motion. (Yea is to let in a bill; nay is to reject the bill for introduction).
- C. In order to review all legislative appeals in a timely manner, voting will be by a show of hands, with each Council Member's vote on each bill being recorded. The record of each vote will be made available for public inspection following the meeting.
- D. Legislators who appeal a decision of the Legislative Council will be given a brief opportunity to make their case to the Council. A time limit of 3 minutes will be observed for Legislators making an appeal. Only by leave of the Chair of the Legislative Council may a person who is not a Legislator address the Council.
- E. Discussion of a bill request will be limited to whether it is appropriate for introduction under Constitutional provisions for second regular session bills, and will not speak to the merits of the bill itself. If a bill was turned down because it is closely related to another legislative request or to a carryover bill, the burden is on the Sponsor to convincingly distinguish his or her bill request from the closely related one.
