The bill would not authorize the expungement of the records of convictions of violent crimes and domestic violence, sexual abuse or abuse of a minor.

Comment: Under current law, a school that receives tuited students who are enrolled in regular school day career and technical educational programs at career and technical education centers, satellites or regions may charge only a tuition rate of up to 2/3 of the maximum tuition rate, which has no correlation to the actual cost of educating a student at a career and technical education center, satellite or region. This bill would require the calculation of the per-pupil cost to the State of funding the career and technical education system through essential programs and services and require schools with tuited students to pay that per-pupil cost when sending a student to a career and technical education center, satellite or region.

It would also provide funding for districts and schools to partner with community organizations to deliver place-based climate education programming.

Title: An Act To Enhance Access to, Education Regarding and Patient and Community Safety in Maine's Medical Use of Marijuana Program

It would address patient access inconsistencies, clarify the certification of minor patients, bringing statute in line with current process and procedure, and require a medical provider who certifies a minor patient to provide the parent or guardian with the means to contact the provider. It would clarify the definition of "medical provider" and ensure access to telemedicine procedures for all patients. It would require the release of monthly sales data from the Department of Administrative and Financial Services, Bureau of Revenue Services and allow citizen access to this data.
