Wednesday, January 11, 1961

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Roger Blinn of Gardiner.

The journal of yesterday was read and approved.

Papers from the Senate

ORDERED, the House concurring, that the following statement of legislative ethics be incorporated in the 1961 edition of the "Senate and House Registers":

"Any public office holder is charged with responsible conduct commensurate with the trust placed in him by the electorate. In a free government the official is entrusted with the security, safety, h e alth, prosperity, and general well-being of those whom he serves. With such a trust high moral and ethical standards producing the public's confidence, with the reduction to a minimum of any conflict between private interests and official duties, should be observed. No state legislator will accept any employment which can possibly impair his independence and integrity of judgment nor will he exercise his position of trust to secure unwarranted privileges for himself or for others. The Maine legislator will be ever mindful of the ordinary citizen who might otherwise be unrepresented, and will endeavor conscientiously to pursue the highest standards of legislative conduct." (S. P. 54)

ORDERED, the House concurring, that there be paid to the officers of the Senate and House of Representatives as advances on account of compensation, amounts included in fortnightly lists, certified to the State Controller by the Secretary of the Senate and the Clerk of the House, respectively, and that the final payrolls of such officers at the end of the session bear the approval of the Joint Standing Committee on Appropriations and Financial Affairs (S. P. 85)

To the Committee on Appropriations and Financial Affairs will be assigned in the place of the gentleman, Mr. Fogg, the gentleman from Lewiston, Mr. Jalbert.

And on the Committee on Election Laws will be assigned the gentleman from Madison, Mr. Fogg.

The SPEAKER: The Chair now lays before the House the first tabled and today assigned matter, Joint Order — Relative to amending Joint Rule 19B (Cloture Rule), House Paper 81, tabled on January 4 by the gentleman from Pittsfield, Mr. Baxter, pending passage.

Thereupon, on motion of Mr. Baxter of Pittsfield, the Joint Order received passage and was sent up for concurrence.

The SPEAKER: The Chair lays before the House the second tabled and today assigned matter, House Order — Relative to amending Rule 8 and adding new Rule 31A (Committee on Rules and Business), tabled on January 4 by the gentleman from Lewiston, Mr. Jalbert, pending passage.

The Chair recognizes the gentleman from Pittsfield, Mr. Baxter.

Mr. BAXTER: Mr. Speaker, Ladies and Gentlemen of the House: It appears that these rules need considerable more study, I think not only by the new members but by the old members as well, before action is taken on them. In the meantime, we need to have some idea what we are operating under, and we also need very badly to get our Senate and House register published, which contains these rules. We have not only the two rules in question here under tabled items numbered two and three, but we have many more rules which will come to us from the Senate. We also have a batch of amendments here today, which you notice that we have to cope with.

And so, it appears that this has developed into a large and rather complicated subject. For this reason we have a feeling that perhaps the best solution to this problem is to refer these proposed rules to the Joint Committee on State Government for hearing and reporting back out to us with their recommendation later on in the session. To allow both parties to caucus on these questions, I am now going to move that item number two, on the table, House Order relative to amending Rule 8 and adding Rule 31A, be tabled unassigned.

Thereupon, the House Order was tabled unassigned pending passage.

The SPEAKER: The Chair lays before the House the third tabled and today assigned matter, House Order — Relative to adding House Rule 35A and amending House Rule 36 (Debate and Amendments), tabled on January 4 by the gentleman from Lewiston, Mr. Jalbert.

Thereupon, on motion of Mr. Baxter of Pittsfield, the House Order was tabled unassigned pending passage.

The SPEAKER: Now the Chair would like to say at this time, that the Speaker is always available to the members of the House; and perhaps later on I will set a regular time when I will be there. But I would like to think that we are always available, and I think you will usually find the door is always open except if we happen to be changing our clothes at that particular time. So we hope that you will drop in any time, and I know you have a lot of problems to solve. If I can't solve them, perhaps I can direct somebody that will. And when I say that, of course I include all the one hundred and fifty members of the House. I have been very pleased with the mem-bers of both the Republican and Democratic party, who have been dropping in and discussing matters. And I think we have got to work jointly along state matters and I am sure that we are going to.

Now, when we adjourn here, we are going to discuss these legislative plates, if necessary, for a few moments.
