## HOUSE

Tuesday, January 17, 1961

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Anson Williams of the Riverside Congregational Church, Vassalboro.

The members stood at attention during the playing of the National Anthem.

The journal of the previous session was read and approved.

The SPEAKER: The Chair recognizes the gentlewoman from Lebanon, Mrs. Hanson.

Mrs. HANSON: Mr. Speaker, I wish to announce that the Representative-elect from Kennebunkport, the Honorable Elmont S. Tyndale, is present and ready to receive the oath necessary to qualify him as a member of the House of Representatives of the 100th Legislature.

The SPEAKER: The gentlewoman from Lebanon, Mrs. Hanson, moves that the gentleman from Kennebunkport, Mr. Tyndale, be escorted to the Governor for the purpose of taking the oath necessary to qualify him for the performance of his duties. Is this the pleasure of the House?

The motion prevailed.

The SPEAKER: Pursuant to that motion, the Chair will appoint the gentlewoman from Lebanon, M r s. Hanson, a committee of one to escort the gentleman from Kennebunkport, Mr. Tyndale, to the Governor, and will also request th a t the Sergeant-at-Arms escort the two.

Subsequently the gentlewoman from Lebanon, Mrs. Hanson, reported she had performed the duty with which she was charged, and that Representative-elect Tyndale had taken and subscribed the oaths necessary to qualify him to enter upon his duties.

#### Orders

Mr. Knight of Rockland presented the following Order and moved its passage:

WHEREAS, In connection with the proposed examination by the House Committee on Elections into the ballots cast in the general election of November 8, 1960 for the House seat from the Class towns of Durham and Lisbon, certain questions have arisen with regard to the contest by Andrew Karkos of Lisbon, Maine of the seat certified to Frank M. Bowie of Durham, Maine; and WHEREAS, Hearing was held in

this matter on Wednesday, January 11, 1961, at which time Mr. Bowie appeared specially in order to contest the jurisdiction of the Committee to hear the merits of

this dispute; and WHEREAS, The Committee de-cided that it should hear all the available evidence, while at the same time reserving to Mr. Bowie his right to a determination of Committee jurisdiction; and

WHEREAS, Evidence showing the following sequence of events was received and acknowledged as accurate by both parties to this contest:

(1) Mr. Karkos sent the notice of contest to Mr. Bowie by registered mail, return receipt requested.

(2) Mr. Karkos placed the said notice in the United States Mails on December 19, 1960.

(3) This notice was addressed to Mr. Bowie at Durham, Maine, whereas Mr. Bowie's mailing ad-dress was Auburn, RFD No. 1.
(4) The return receipt indicated

that Mr. Bowie received this said notice December 27, 1960, less than ten days before the organization of the House of Representatives; and the Committee on Elections may be without jurisdiction to inquire

into the certified results; and WHEREAS, It is Mr. Bowie's contention that Mr. Karkos has

failed to comply with the provisions of Chapter 5, Section 89 of the Revised Statutes, relating to the service of said notice, which section is as follows:

"When any person intends to contest before the House of Representatives the right of any other per-son to his seat therein, he shall serve notice thereof upon such person which notice may be served at any time after the election and shall be served at least 10 days prior to the organization of the House of Representatives. He shall present his petition to the House of Representatives within 3 days after its organization, stating the grounds upon which he proposes to contest such seat, and all testimony on either side shall be by depositions taken in the manner authorized by chapter 117 in cases of contested senatorial elections, or by parol evidence, and shall be presented to the House of Representatives within 3 days from the commencement of the session. If this law is not strictly complied with, except in extreme cases where injustice would be done if a continuance were not allowed, the party neglecting shall be denied a postponement, and the committee on elections shall proceed to determine the case by the testimony before them."; and

WHEREAS, It appears to the members of the House of Representatives of the One-Hundredth Legislature that questions of law have arisen which make this occasion a solemn one;

NOW THEREFORE, be it ordered, that in accordance with the provisions of the Constitution of the State, the Justices of the Supreme Judicial Court are hereby respectfully requested to give this legislature their opinion on the following questions:

In an election contest such as the one outlined above, has the contestant complied with the provisions of Chapter 5, Section 89, of the Revised Statutes when he deposits the notice of contest in the United States Mails within the prescribed time limit, but the notice is not received until after the expiration of that limit? Π

If the answer to question number I above is in the negative, does the Committee on Elections have any jurisdiction to entertain the contestant's petition?

In what way, if any, would the answers to either of the above questions be affected if it is shown that Mr. Bowie was informed orally, before the expiration of the time limit, that Mr. Karkos intended to contest his election to the House of Representatives?

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Knight.

Mr. KNIGHT: Mr. Speaker, very simply stated, this is asking the Supreme Judicial Court to render an opinion as to whether our Committee had authority to conduct a hearing, and also to render an opinion as to whether the Committee on Elections had jurisdiction or has jurisdiction to entertain the contest that was placed before it. I would now move that House Rule 46 be suspended and that the House act on this Order today.

act on this Order today. The SPEAKER: The gentleman from Rockland, Mr. Knight, has moved that House Rule 46 be suspended. Is this the pleasure of the House?

The motion prevailed.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Philbrick.

Mr. PHILBRICK: Mr. Speaker, I don't have my copy of the 99th Legislature's rules, and if we could have Rule 46 read to us, I think we would be in a better position to vote on it.

The SPEAKER: The Chair recognizes the gentleman from Woodstock, Mr. Whitman.

Mr. WHITMAN: I would be very happy to comply with that request, Mr. Speaker.

The SPEAKER: The gentleman may proceed.

Mr. WHITMAN: Rule 46, a proposition to require the opinion of the Judges of the Supreme Court as provided by the Constitution, shall not be acted upon until the next day after such proposition is made. The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Knight.

Mr. KNIGHT: Mr. Speaker, all that we are attempting to do here is to speed up the matter of seating a member in this House, a fellow member to represent the class towns involved, rather than wait for the matter to be placed before the House tomorrow.

The SPEAKER: The Chair would like to remind the House that Rule 46 has been suspended. Is it now the pleasure of the House that this Order receive passage?

The motion prevailed.

# House Reports of Committee on Elections

The following Report:

The Committee on Elections to which was referred the return of the votes cast for Representative to the Legislature have had the same under consideration and beg leave to report that it appears from their canvass of said returns that the several persons named in the communication of the Secretary of State addressed to Harvey R. Pease, Clerk of the House of Representatives of the Ninety-ninth Legislature, and dated January 4, 1961, made in compliance with Section 1, Chapter 10 of the Revised Statutes, were duly elected Representatives to the Legislature and should be declared to be legal members of the Legislature, with the exception of four Representatives representing the Legislative Classes of 1. Arrowsic, Phippsburg, Topsham, West Bath, Woolwich, 2. Auburn, 3. Durham and Lisbon, 4. Portland.

That of the four contested seats your Committee is filing today its reports covering two of the contests.

As a result of its canvass your Committee recommends, therefore, that the House declare as legal members of the House all persons listed in the communication of the Secretary of State made in compliance with Section 1, Chapter 10 of the Revised Statute except T. Tarpy Schulten of Woolwich, Fernand L. Pontbriand of Auburn, Frank M. Bowie of Durham and John R. Hanscomb of Portland.

#### The Report was read.

On motion of Mr. Berman of Auburn, the Report was accepted, its recommendations adopted, all persons listed in the communication of the Secretary of State made in compliance with Section 1, Chapter 10 of the Revised Statutes were declared as legal members of the House, except T. Tarpy Schulten of Woolwich, Fernand L. Pontbriand of Auburn, Frank M. Bowie of Durham and John R. Hanscomb of Portland.

The Committee on Elections to which was referred the petition of Carlton Day Reed, Jr. of Woolwich, praying that he may be admitted to the seat now held and claimed by T. Tarpy Schulten of Woolwich, from the class district composed of the towns of Arrowsic, Phippsburg, Topsham, West Bath, and Woolwich, having had the matter under consideration, and after hearing the evidence in the case and the arguments of coun-sel, beg leave to report that the said T. Tarpy Schulten received 1592 votes and that the said Carl-ton Day Reed, Jr. received 1578 votes, and that therefore the said T. Tarpy Schulten of said Wool-wich was legally elected as Rep-resentative from the said class district to the One-Hundredth Legislature of Maine and shall be seated as said Representative and from henceforth be and become the duly accredited Representative from said class district.

The Report was read.

On motion of Mr. Berman of Auburn, the Report of the Committee was accepted and T. Tarpy Schulten who was listed in the communication of the Secretary of State, dated January 4, 1961, of names and residences of representatives-elect, was declared to be a member of the House representing the class towns of Arrowsic, Phippsburg, Topsham, West Bath, and Woolwich.

The SPEAKER: The gentleman from Woolwich, Mr. Schulten, was present at the time the House was organized, and therefore did take the oath at that time. However, the Chair will assign the gentleman to seat 18. The Chair will also assign the gentleman from Woolwich, Mr. Schulten, as the sixth ranking member on the Joint Standing Committee on Natural Resources.

The Chair recognizes the gentleman from Woolwich, Mr. Schulten.

Mr. SCHULTEN: Mr. Speaker, I would like to express my thanks to the 100th Legislature for the action they have now taken.

The SPEAKER: The Chair understands that the gentleman from Woolwich, Mr. Schulten, asked unanimous consent of the House and that it was granted, to express his words of appreciation. (Applause)

The SPEAKER: At this time, the Chair will assign the gentleman from Portland, Mr. Briggs, as the seventh ranking member on the Joint Standing Committee on Legal Affairs.

Mr. Berman of Auburn was granted unanimous consent to address the House out of order.

Mr. BERMAN: Mr. Speaker, the Committee on Elections wishes the record to show that the action it took in certifying T. Tarpy Schulten was unanimous action on behalf of all members of that Committee.

The SPEAKER: The Clerk will make a note of that.

The Committee on Elections to which was referred the returns of the votes cast for Representatives to the Legislature, and the communication from the Secretary of State transmitting the letter of Fernand L. Pontbriand, have had the same under consideration and beg leave to report that; According to the official canvass of the contest for Representative to the Legislature from the city of Auburn Charles E.
