Therefore, I move that this order be tabled and specially assigned for tomorrow to give you an op-

portunity to study this.

The SPEAKER: The gentleman from Bridgton, Mr. Haughn, has moved that this order be tabled and specially assigned for tomorrow pending passage. Is this the pleasure of the House?

The motion prevailed.

House Reports of Committees Ought Not to Pass

Mr. Brown from the Committee on Election Laws reported "Ought not to pass" on Bill "An Act Changing the Date of the Primary Election" (H. P. 70) (L. D. 112) Report was read.

The SPEAKER: The Chair recognizes the gentleman from Madison, Mr. Fogg.

Mr. FOGG: Mr. Speaker, I would like to request that this item one lie on the table until the next legislative day pending acceptance of the Committee Report.

The SPEAKER: The gentleman from Madison, Mr. Fogg, moves

that this item be tabled until the next legislative day pending acceptance of the Committee Report. Is this the pleasure of the House?

The Chair recognizes the gentleman from Woodstock, Mr. Whitman.

Mr. WHITMAN: Mr. Speaker, I

would request a division.

The SPEAKER: The gentleman from Woodstock, Mr. Whitman, has requested a division. Will all those who favor the motion of the gentleman from Madison, Mr. Fogg, to table this item until tomorrow or the next legislative day, please rise and remain standing until the monitors have made and returned their count.

Mrs. HENDRICKS of Portland: Mr. Speaker, may I ask a question?

The SPEAKER: For what purpose does the gentlewoman arise?

Mrs. HENDRICKS: I would like to know whose bill that is.

The SPEAKER: The gentlewoman from Portland, Mrs. Hendricks, has asked a question through the Chair and anyone may answer it who chooses.

The Chair recognizes the gentleman from Madison, Mr. Fogg.

Mr. FOGG: Mr. Speaker, that is Mr. Jalbert's bill, the gentleman from Lewiston. The only reason why I am tabling it is because the Committee Report is coming out and he is not present —

The SPEAKER: The gentleman from Madison, Mr. Fogg, is debating the tabling motion and may not proceed along that line.

Did the gentlewoman from Portland, Mrs. Hendricks, have her question answered?

Mrs. HENDRICKS: I believe I understand that that is Mr. Jalbert's bill.

The SPEAKER: The question now before the House is the motion of the gentleman from Madison, Mr. Fogg, that this bill be tabled and specially assigned for the next legislative day. A division has been requested. All those in favor of the tabling motion please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Thirty-two having voted in the affirmative and one hundred four having voted in the negative, the tabling motion did not prevail.

Thereupon, the "Ought not to pass" Report was accepted and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Pittsfield,
Mr. Baxter.

Mr. BAXTER: Mr. Speaker, so that this order can receive the study it deserves and so that the members of the House can be properly informed as to its implications in the operation of the House, I now move that this order be referred to the House Committee on Rules and Business.

The SPEAKER: The gentleman from Pittsfield, Mr. Baxter, moves that this item be referred to the Committee on Rules and Business of the House. Is this the pleasure of the House?

The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I wonder if I could approach the rostrum and ask that you request the gentleman from Pittsfield, Mr. Baxter and the gentleman from Madison, Mr. Fogg, to also approach the rostrum?

The SPEAKER: The gentleman may do so.

(Conference at rostrum)

The SPEAKER: The motion pending before the House is the motion

of the gentleman from Pittsfield, Mr. Baxter, that item number one be referred to the House Committee on Rules and Business of the House. Is this the pleasure of the House?

The motion prevailed.

On motion of the gentleman from Pittsfield, Mr. Baxter, the House voted to take from the table the second tabled and unassigned matter, House Order Relative to adding House Rule 35A and amending House Rule 36, tabled on January 11 by that gentleman pending passage.

On further motion of the same gentleman, the Order was referred to the House Committee on Rules and Business of the House.

On motion of the gentleman from Lewiston, Mr. Jalbert, the House voted to take from the table the third tabled and unassigned matter, Joint Order Relative to adding new Joint Rule No. 23, Senate Paper 52, tabled on January 12 by that gentleman pending passage. In the Senate, Senate Amendment "A" was adopted and referred to the Committee on State Government.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I would for a moment refer myself to the courtesy extended to me by the gentleman from Madison, Mr. Fogg, when I wasn't where I should have been a few moments ago, on a bill of mine concerning the election laws with a straight "Ought not to pass" Report on it. I am not particularly anxious to have these measures referred to the State Government Committee. was in hopes as a member of the interim committee that they would be given their proper explanation on the Floor of the House. means that we go to the State Government Committee now and rehash it, and the two measures that I am now taking from the table and referring to the Committee just means exactly what happened to me personally this morning. In spite of the fact that my good colleague was extending me a courtesy, if I had known what I was voting on, I would not have

arisen in favor of tabling because if I can't convince one out of a Committee of ten, how am I going to try to convince one hundred and

fifty-one?

That is exactly what we people were discussing. We are going to now have to go into the rules of House Business and rehash two years work, go into the State Government Committee and also again rehash the whole thing all over again. I think that possibly sometime deep in May some of shadows might remind some members that possibly these rules might have been adopted and we might have gotten home a little earlier. I hope I am wrong, but I don't think I will be.

The SPEAKER: The Clerk will read Senate Amendment "A."

Senate Amendment "A" was read

SENATE AMENDMENT "A" TO Order adding Joint Rule 23 to provide a manual for the guidance of joint standing committees.

Amend said Order by deleting

paragraph 3 on page 2

Further amend said Order by deleting paragraph 8 and replacing with the following language: "No member shall be permitted to vote on any question in either branch of the Legislature, nor in committee, whose private right, distinct from public interest, is immediately involved."

Further amend said Order by deleting under paragraph 13, page 6, section "B", the following words: "except in the case of ONTP reports which shall be reported to the Joint Committee on Rules and Business."; and by replacing the comma after the word "Legislature" with a period.

Further amend said Order in paragraph 16, by deleting the seventh and eighth sentences, beginning with the words "A unanimous ONTP report," and ending with the words "reported back to the house of origin.

Further amend said Order by deleting the second sentence in paragraph 18, beginning with the words, "This is an attempt" and ending with the words, "delaying disposition of bills.

Further amend said Order by deleting the second sentence of paragraph 19, beginning with the words, 'Financial obligations'', and ending with the words "in the form of an Order."

Senate Amendment "A" was adopted in concurrence.

Thereupon, on motion of Baxter of Pittsfield, the Joint Order as amended by Senate Amendment "A" was referred to the Committee on State Government in concurrence.

On motion of the gentleman from Lewiston, Mr. Jalbert, the House voted to take from the table the fourth tabled and unassigned matter, Joint Order Relative to amending Joint Rules No. 1, No. 10 and No. 11, Senate Paper 53, tabled on January 12 by that gentleman pending passage. In the Senate, Senate Amendment "A" was adopted and referred to the Committee on State Government.

Senate Amendment "A" was read by the Clerk as follows:

"A" Senate Amendment adopted in concurrence.

On motion of Mr. Jalbert of Lewiston, the Joint Order as amended by Senate Amendment "A" was referred to the Committee on State Government in concurrence.

The SPEAKER: The House is proceeding under Orders of the Day.
