Tuesday, January 31, 1961

Ratification of Amendment to the Constitution of the United States Relating to the Granting of Representation in the Electoral College to the District of Columbia.

In the Year of Our Lord One Thousand Nine Hundred and Sixty-One.

RESOLUTION, Ratifying the Proposed Amendment to the Constitution of the United States Relating to the Granting of Representation in the Electoral College to the District of Columbia.

WHEREAS, the Eighty-sixth Congress of the United States of America, at the second session begun and held at the City of Washington on Wednesday, the sixth day of January, one thousand n i n e hundred and sixty, by a constitutional two-third vote in both Houses adopted a Joint Resolution proposing an amendment to the Constitution of the United States, to wit:

Joint Resolution

Proposing an amendment to the Constitution of the United States granting representation in the electoral college to the District of Columbia.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled (two-thirds of each House concurring therein), th a t the following article is hereby proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution only if ratified by the legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

"ARTICLE---

"SECTION 1. The District constituting the seat of Government of the United States shall appoint in such manner as the Congress may direct:

"A number of Electors of President and Vice President equal to the whole number of Senators and Representatives in Congress to which the District would be entitled if it were a State, but in no event more than the least populous State; they shall be in addition to those appointed by the States, but they shall be considered, for the purposes of the election of President and Vice President, to be electors appointed by a State; and they shall meet in the District and perform such duties as provided by the twelfth article of amendment.

"SECTION 2. The Congress shall have power to enforce this article by appropriate legislation."

THEREFORE, be it

RESOLVED, that the Legislature of the State of Maine hereby ratifies and adopts this proposed Amendment to the Constitution of the United States.

RESOLVED, that the Secretary of the State of Maine notify the President of the United States, the Secretary of State of the United States, the President pro tempore of the Senate of the United States, the Speaker of the House of Representatives of the United States, the Administrator of General Services of the United States, and each Senator and Representative from Maine in the Congress of the United States of this action of the Legislature by forwarding to each of them a certified copy of this Resolution.

House at Ease

Called to order by the Speaker.

House Report of Committee on Elections

The following Report:

January 26, 1961

The Committee on Elections to which was referred the petition of Andrew A. Karkos, Sr. of Lisbon, praying that he may be admitted to the seat now held and claimed by Frank M. Bowie of Durham, from the class district composed of the towns of Durham and Lis-bon, having had the matter un-der consideration, and after hear-ing the evidence in the case and the arguments of counsel, the Committee conducted a recount of ballots which was held on January 26, 1961. The recount was conducted by Representatives of the Committee and under the supervision of the Secretary of State, in which it was determined that Frank M. Bowie received 1320 votes and Andrew A. Karkos, Sr. received 1318 votes. In addition, 179 ballots were set aside at the request of the parties as being disputed. The Committee inspected and made the

determination that 98 votes were for Andrew A. Karkos, Sr. and 72 were for Frank M. Bowie, and that 9 were void; therefore, the that 9 were void; therefore, Committee has determined t h a t Frank M. Bowie received a total of 1392 ballots and Andrew A. Karkos, Sr. received a total of 1416 ballots, and therefore, the Committee unanimously reports that the said Andrew A. Karkos, Sr. of said Lisbon was legally elected as Representative from the class towns of Durham and Lisbon to the 100th Legislature of the State of Maine and should be seated as Representative of said class district and from henceforth be and become the duly elected Representative of said class district in the 100th Legislature of the State of Maine.

COMMITTEE ON ELECTIONS (Signed) By JOHN L. KNIGHT John L. Knight, Chairman

The Report was read.

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Knight.

Mr. KNIGHT: Mr. Speaker and Ladies and Gentlemen of the House: In the matter of the contest of the seat of Frank M. Bowie by Andrew Karkos of Lisbon, the parties appeared before the Elections Committee of the House, and it was claimed that the committee had no jurisdiction to decide this matter whereas Mr. Karkos had failed to give notice of his intention to contest the election to Mr. Bowie.

In an effort to be entirely fair, the committee formed a set of questions concerning this technicality and you, the Members of the House, sent these questions to the Supreme Judicial Court for an opinion.

The opinion came back that Mr. Karkos had not complied with the statute involved and therefore had not given proper notice. The Court went on further, however, and stated that even though Mr. Karkos did not comply with the statute the committee still had jurisdiction to entertain his petition.

The Supreme Court said, "It follows therefore that the Committee on Elections, like the House for which it acts, may in an appropriate case disregard technical non-

compliance with the statutory notice and determine a case upon its merits. The test would be whether substantial justice would be established by hearing and determining the case."

When the opinion was received, the committee determined this case as they felt upon its merits. There were no allegations of fraud, and therefore the ballots were counted, and the man with the most votes was elected.

Certain ballots were disputed for the reason that they were in ink. The Supreme Court has already answered the question about these, and in an opinion of the Justices in 124 Maine, Page 489, it says in effect ballots marked in in k should be counted.

Certain ballots were disputed because the lines were extended beyond the squares. These ballots should be counted.

Now we have counted the ballots fairly and honestly; and we have before us the fact that we should determine the vote by the opinions expressed at the polls by the people from Lisbon and Durham and not by our own political opinions, not from our own feelings, and not from any other expression except the expression of the voters.

It is not easy to sit in judgment of one who has been seated among you for some four weeks, and find against him. The Committee on Elections and particularly myself sympathize most sincerely with Mr. Bowie, but under the circumstances could act in no other way.

I move that the Committee report be accepted.

The SPEAKER: The gentleman from Rockland, Mr. Knight, moves that the Committee report be accepted. Is it the pleasure of the House?

The motion prevailed.

Mr. Knight of Rockland thereupon presented the following Resolution, and moved its adoption:

House Resolution

BE IT RESOLVED, that it is the judgment of this House that Frank M. Bowie, the sitting member from the class district composed of the Towns of Durham and Lisbon, in the County of Androscoggin, was not legally elected and shall not longer act as the Representative from said class district and that Andrew A. Karkos, Sr. of said Lisbon was legally elected as Representative from the said class district to the One-Hundredth Legislature of Maine and shall be seated as said Representative and henceforth be and become the duly accredited Representative from said class district.

The Resolution was adopted.

The SPEAKER: At this time the Chair would like to make a few remarks: We have had an unusual situation in this session. It didn't happen in the 99th session, and I don't know when it has happened before; but we have had four situations of, we will say, more or less contested elections. One of them being the situation in Auburn of the gentleman from Auburn, Mr. and the gentleman Pontbriand, from Auburn, Mr. Waterman. In that case, the very fine gentleman from Auburn, Mr. Pontbriand, conceded. And then the case in Portland, we had a contest between the gentleman from Portland, Mr. Hanscomb, and the gen-tleman from Portland, Mr. Kellam. And in Woolwich, the gentleman from Woolwich, Mr. Reed, and the gentleman from Woolwich. Mr In this case, the very Schulten. fine gentleman from Woolwich, Mr. Reed, conceded.

And now we have this situation here, the contest between the gentleman from Lisbon, Mr. Karkos, and the gentleman from Durham, Mr. Bowie. Two of the cases they conceded because, after counting the votes, it was easily determined that one should concede. In the other two instances there was a question. And so it went to decision. At this time I would like to compliment the Committee on Elections for the very fine work that they have done on these contests in addition to the work they are doing on the Judiciary Committee. And furthermore, I would like to state that many of these papers have been prepared by the Clerk and by members of the Clerk's Office; and his long experience in the Legislature has come in very handy at this particular time, because he could go back through the pages and find where we have had other disputed elections in this State and use them for the preparation of the papers.

The Chair will appoint the gentleman from Lewiston, Mr. Jalbert, as a committee of one to take the gentleman from Lisbon, Mr. Karkos, to the Governor, in order to take and subscribe the oath necessary to qualify him to enter upon the performance of his duties. I will have to state at this time that the Governor is not available at the moment, and it may be necessary that the report be made of the swearing in by the gentleman from Lewiston, Mr. Jalbert, tomorrow. But as soon as the Governor is available they will have the gentleman from Lisbon, Mr. Karkos, sworn in and he will be seated.

Now up to this time I know my own delegation, at least I myself speak for myself, are not informed of the costs of what is applied to our budget. So therefore, to have ample time to take it up with our caucus and County delegation. with our Ŧ move this Bill be tabled pending acceptance of the third reading until Thursday, February 9, for the purpose of going into it a little deeper.

Orders of the Day

Mr. Fogg of Madison was granted unanimous consent to address the House.

Mr. FOGG: Mr. Speaker and Members of the House: First, I would like to commend the Committee on Elections on the way it has performed its duties during this legislative session. I realize they have had some very difficult decisions to make and I feel that they have been fair about making them.

Now what I would like to call to your attention is this green booklet which has been put on your desks today. This is Problems and Prospects for the mentally retarded in Maine. This is the Annual Report of the Maine Committee on Problems of the Mentally Retarded. I was recently appointed to this committee and even though I must confess I don't know as much about its functions as I hope to later on, I have been asked to call this report to your attention and sort of just briefly review it as far as to the functions of the Committee.

On page 5 of this report is the introduction. That covers the origin of the Committee and a brief history. It tells you why the Committee was first created and about the activities of the Committee and what their aims are as far as the mentally retarded. On page 7 through 9 is a review of the public responsibility towards the mentally retarded, not only from the standpoint of Christianity, but also from the standpoint of society. That is, these people are handicapped, and if we don't sympathize with their problems and help them, they can become delinquents.

One of the bits of information which has been revealing to me is that three percent of the child population is retarded to some extent: five out of every six of these retarded children are what they call educable, that means that they can receive knowledge when it is imparted to them under the proper circumstances and by the proper people. One out of every seven is trainable, that is, they can be trained to do simple things, to look after themselves. One out of every thirty is to be kept in custody, they have to be looked after.

Pages 10 through 14 reviews the work of the committee; tells what it has done in the past and what it hopes to do in the future and the impact that the committee has upon the society as a whole.

Pages 16 through 28 is the report of the committee accomplishments and findings. That goes on even further telling what the committee has done, studies it has made and the changes that have been brought about in the State.

Pages 33 through 56 cover the public laws and amendments pertaining to the mentally retarded. Pages 57 through 60 is a list of the publications which come from the Pine State Hospital for the mentally retarded. As I understand, this list of publications is something which is unusual. Very few states have a mental hospital which has these publications, and I have gathered so far in my connection with this Committee that the State of Maine has progressed to the point where it is considered one of the more advanced states in the handling of its mentally retarded people.

As I say, I hope to know more about the problems of the mental-ly retarded after I have been on this Committee, but the Executive Secretary asked me if I would call your attention to this booklet with the hope that you would go through it thoroughly and read it. Thank you.

The SPEAKER: The Chair does not like to read names from the not like to read names from the rostrum. However, this is impor-tant, I would say. There are a few bills and private and special laws in the office of Sam Slosberg, the Director of Legislative Research, and there is a time limit on those, they have to be in here trader. they have to be in here today. I am not going to read the names but there are six names on here, there are six to be picked up, so you better check. If you have any question as to whether your name is on the list or not, you can pick it up here immediately following the session or I will tell you whether your name is on it or not. There is a time limit on these, they must be in today.

The SPEAKER: The Chair has the sad duty of announcing the death last night in the Augusta General Hospital of one of our colleagues, and fellow legislators, Lester E. Brown of Cape Elizabeth. Last summer, Lester and I had the pleasure of going to the Hebron Sanatorium in Hebron and making an inspection of that facility. That simply typifies his interest in State and Legislative matters.
