Mr CURTIS: Mr Speaker, Ladies and Gentlemen: I wish that you might read this L. D. 62. Now we find that under the laws of this State in getting licenses to sell intoxicating beverages in a municipality, that the Liquor Commission has, before they issue these licenses, they have to consult with the municipal officers. Of course they know these people applying for licenses and they know them much better than the Liquor Control Board does. And so it seems only fair and right, and in the wisdom of the Legislature this law was conceived and brought forth.

Now on the renewal of these licenses, this does not have to take place; they are just renewed. Now I am not going to call names, but I can tell you that it is one of my towns that I represent. A man moved in there and bought a little store, with the sole idea I think, of selling intoxicating beverages, which was perfectly legal and perfectly okay. But he went a little mite farther than that, he would sell on Sunday to those who would buy

their groceries from him; a n d some of the other people who were selling intoxicating beverages in a grocery store, why they came to me and wanted to know what I could do about it. And I said, I am not a liquor inspector. I said, report it. They said they had, but nothing had been done. Well, they made such a plea for it that I went up and looked around, but it wasn't my place as Representative to do that sort of thing, to become a liquor inspector. But I was satisfied that this man was so doing and so reported it; and eventually he was put out of business. But he carried this on for a year or so, and now his license was renewed because they only last a certain length of time during that time. Now everybody in the town knew what was going on, but it just seems that no one could catch him at it. But as I say, finally they did.

Now had this been a case where the renewal of licenses, why the town officials could have put up a plea and really made the liquor control inspection setup get after him a little mite more. Now, it is perfectly legal to sell intox-icating beverages, and I am not trying to say that they should not be sold; but I think this would be a good bill and would be very helpful in a great many cases, prob-ably not in every case but there are some cases it would be very helpful in. I know it is almost impossible to get any law passed to affect the sale of intoxicating beverages because there is so much money involved. We make great cry about what it costs for education, but it costs the State of Maine some ten or twelve million dollars for education, yet we sold year before last, I haven't the figures for last year, some fifty-two million dollars' worth of intoxicating beverages wholesale which probably retailed seventy-five million. And a great deal of that is the profit to the people who sell it and to the people who make it. And we are getting some tax out of it, of course, we're getting some seven million dollars in taxes. But I think if you really look into the situation you will find it cost about thirtynine million dollars to clean up the debris that this makes.

And yesterday we had a bill being heard on Aid to Dependent Children, and so I looked up some statistics on that, and I find that seventy-six per cent of our children who are in need of aid are caused by broken homes and about seventy per cent of broken homes are caused by too much alcoholic beverages.

So, I would like at this time to move that we accept the Minority "Ought to pass" Report. And I ask a division.

The SPEAKER: In the winter if in fact Smokey the bear is out of hibernation, we would like to have two of the pages bring Smokey down to the well of the House so that we can really see him.

Whereupon, Smokey the bear was escorted to the well of the House.

The SPEAKER: The Chair recognizes the gentle-bear from Maine, Mr. Smokey.

Mr. SMOKEY: Well, it certainly is nice for me to have a chance to get out of hibernation and visit all you folks here in the House.

You know, I spend most of my time travelling around the State of Maine talking to not only the boys and girls, but grown-ups too, telling everyone how we help in preventing forest fires. Even last year I had to learn to talk French so I could talk to some of the French-Canadian workers in the pulp camps up north. Do you know, that every year Maine has from two hundred and fifty to nine hundred and fifty forest fires, and even last year we had four hundred and ninetyone. Isn't that terrible? Unfortunately, ninety percent of our forest fires are caused by people who are careless, so you can see we still have a big job in helping to prevent forest fires and helping to Keep Maine Green.

I hope all of you will remember to help me in 1961, this year. I'll be seeing ya. Thanks for invitin me ta be here. (Applause)

The SPEAKER: Smokey is an unusual bear in that he never goes into hibernation, because he has a twelve months' task of educating people in fire prevention. He represents the 76,000 persons in this State who own lots of land less than five hundred acres, and he also represents the landowners in this State who own over ten million acres of land comprised of plots larger than five hundred acres each. So when Smokey leaves here, he will not go into hibernation, but on his twelve months' tour to educate in fire prevention.

The SPEAKER: The Chair recognizes the gentleman from Pittsfield, Mr. Baxter.

Mr. BAXTER: Mr. Speaker, out of respect for the funeral of our good friend, Lester E. Brown, to be held tomorrow afternoon from 2:00 to 2:30, I move the House adjourn until 2:30 tomorrow afternoon.

Whereupon, the House stood adjourned.
