Dear Mr. Speaker:

On May 20, 1960, I received a message from Governor J. Lindsay Almond, Jr., Governor of the Commonwealth of Virginia, with accompanying Senate Joint Resolution No. 28, passed by the General Assembly of the Commonwealth of Virginia.

The Resolution passed by the Senate and House of Delegates, commemorates the adoption of a series of resolutions by the General Assembly of Virginia on January 18, 1861, calling for a Peace Convention of all the States to meet in Washington, D. C. on February 4, 1861.

As a result of the adoption of these resolutions, the Peace Convention met in an effort to restore the Union and prevent the outbreak of the Civil War.

Governor Almond has requested that I bring this matter to the attention of the Maine Legislature, asking that it join with Virginia in commemorating the 100th Anniversary of the Washington Peace Convention on February 4, 1961.

I am herewith attaching a copy of Senate Joint Resolution No. 28, and refer the matter to the 100th Legislature for its consideration.

might be interested. I will run down through them quickly.

At the end of the fifth week of the 99th Legislature the following was the situation: 541 items had been referred to committees for hearings, of these 541 items the committees had reported out 46 items. At the end of the fifth week of the 100th Legislature, the following was the situation: 1252 items had been referred to committees for hearings, of these 1252 items the committees had reported out 125 items or exactly ten percent.

Next week, I will announce once more, it has been announced before, our Tuesday session will be the regular Tuesday morning session, and at one o'clock Dr. Sly, who made up the tax report for the Legislative Research Committee, will preside at a meeting beginning in the House at one o'clock. It will be a joint meeting of the House and the Senate and interested persons from the citizenry. He will speak for about forty minutes to an hour on his final report and then will answer questions long as anybody wishes to ask them. On Wednesday we will have the usual session in the morning and hearings in the afternoon, and on Thursday, hearings in the morning and the session will be in the afternoon.
