Mr. HUGHES: Mr. Speaker, due to the fact that this matter still

doesn't seem to be straightened out to the satisfaction of others, I would move that it be retabled until tomorrow morning.

Thereupon, the Bill was retabled pending passage to be engrossed and specially assigned for tomorrow.

The SPEAKER: The Chair recognizes the gentleman from Ellsworth, Mr. Anderson.

Mr. ANDERSON: Mr. Speaker, Ladies and Gentlemen of the am emphatically op-House: Ι posed to a bounty on bear. I feel very strongly they should be controlled and protected in the same manner as our deer herd. As an outdoor man and a guide, I know from personal observation the damage they do to blueberry crops and orchards is greatly exaggerated, that the destruction of sheep in sections of Maine laid to them is more often committed by dogs. As a registered guide, I know that out-of-state hunters would much rather take a bear home on the fenders of their cars than a deer. From the financial point of view it could be a serious loss in revenue for the State if this bill

should be enacted, for this magnificent game animal would soon be decimated.

From one to four cubs, usually two, are born in a hibernation den in the spring. A professional bounty hunter has these dens spotted and it is an easy matter for him to destroy the entire family. I witnessed the slaughter of a bear family a few years ago, when there was a bounty on these animals. Frankly it turned my stomach. Had I known that cubs would be slaughtered, I would have not accompanied the bounty hunter on this expedition. The mother bear was shot and three fuzzy little cubs, hardly bigger than kittens, were clubbed to death. The bounty hunter was paid for the extermination of four bear-four that license-paying hunters were deprived of.

Again, let me say that I am definitely opposed to a bounty on bear. On bobcats, yes, for I know that from personal experience, they are a serious menace to our deer herd. I feel that if we let this bill pass we will have deprived the State of a good source of revenue and sounded the death knell of a much prized game animal. I now move that the Minority Report "Ought not to pass" be accepted.

The SPEAKER: The Chair recognizes the gentleman from Farmington, Mr. Jones.

Mr. JONES: Mr. Speaker, Ladies and Gentlemen of the House: I bear with our brother from over in the other part of the state very heartily. His remarks are full of human interest and we all hate to see animals devastated in certain ways, and it seems a shame to observe the killing of these poor innocent cubs in such a cruel manner. However, if he could have been at my place in Industry a few years ago and gone into my pasture with me, and seen twentyeight of the best lambs that anyone ever looked at laying around the orchard with their toes to the sun, I think he would have had a little different idea and feeling about this situation.

Now this bill came out of the Committee on a divided report seven to three "Ought to pass." I

think the facts that were given before this committee were extensive
and very concrete and very true.
And I think the committee when
they decided on the basis of facts
that were presented to them, I
think they used excellent judgment.
If we accept the Minority Report
"Ought not to pass" and, of course,
that's the measure before you now,
if you vote in favor of the committee report why you will defeat
the bill.

Now the bill is a good bill. It should pass. There are upwards of between fifty and sixty thousand members of the Maine Sheep Breeders Association, the Maine Livestock Association, and your Maine State Grange; they have all voiced their opinions and feelings as going on record of being in favor of this bill. Now I think that warrants very careful consideration on your part when you express yourselves here in voting this morning.

In my own particular town, we have five breeders of sheep there who are obliged to enclose those sheep every night in order to avoid their being killed by bear. Now in this manner of raising sheep it is not good for the animals because sheep should feed during the evening and during the night, that is a part of their nature. We have another area, many of who have gone out of the business, as I said before, because of the damage being done by bear. My good colleague has referred to the fact that sometimes he feels that the blame is put upon the bear for the death of these animals. However, I don't believe that point is exaggerated overly.

Now your bill, as it states now, covers a bounty on bear killed from May 1st to October 4th only. Previously when there was a bounty on bear it covered for the entire season, but this bill is designed this way and I think that is the reason why you got a report from the committee, the divided report in favor of "Ought to pass", is because of the fact that we have the bounty payable on bear from May 1st to October 1st. Now in this manner when one is having trouble, same as I have had, like many others, why there

is an incentive for a trapper to come into the area and spend some time to try to kill that predatory animal. Without the bounty there won't be any incentive and everyone has to work for a living and therefore the trapper isn't interested in making a catch during the summer months because there is no reward for his efforts. therefore, that is why we designed the bill in this manner and I think it is a good bill and we have a lot of support for it and we should vote to deny the "Ought not to pass'' Report. I think we should vote it down. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Jay, Mr. Maxwell.

Mr. MAXWELL: Mr. Speaker, Ladies and Gentlemen of the House: I have been a guide, a trapper, a hunter, all of my life. I have shot and killed nine of these vicious animals. I don't want to see any bounty.

First, a bounty system has never, anywhere it has been used, brought about the results it was intended to: it is a foolish, unnecessary waste of public funds that could be used for other things. could go on and name several things that are on the agenda this year that we could use some of this money for, but I won't take your time. There is no evidence whatsoever, evidence that can be proven as a scientific fact, that because of no bounty on bear there is a larger number of them. Sure, a few bear become killers, but an open season yearthere is round and the Department of Agriculture pays for damage done by them. It is a very interesting fact to note that payments for same have steadily decreased and, I repeat, they have decreased over the past three years when we have had no bounty. And remember, there has been no bounty for that The repeal was done by the Ninety-eighth Legislature, we were the forty-seventh state that saw the light and did away with a costly unwanted subsidy to a few trappers and, if you will, sellers of bear to out-of-state hunters.

A real sportsman from out-ofstate gets a much larger thrill out of shooting and taking back home a bear than any other game animal we have. As I said before, I have personally killed nine of them and never with a bounty in mind. I know of no conservation club that advocates a bounty as a means of control. There are more and more out-of-state hunters, bear hunters, coming into the state both fall and in the spring. To quote Claude Kelley, president of Wildlife, The National Federation of Wildlife, "Through education we have succeeded in eliminating most all bounties in the United States. The bear is a valued game animal.'

I stated that bear do on rare occasions become killers. If that happens in your area, notify your local game warden, he will gladly assist in trapping. I could go on here for the next hour and tell you about the black bear. I have a reprint from the Outdoor Life, The Bounty Hoax,—the Million Dollar Throwaway, by Ben East. Millions are wasted in bounties and don't increase game or curb predators, only fraud flourishes. The evidence makes it plain as long as sportsmen tolerate bounties they will be the losers.

Then back about four or six years ago, the State Legislature authorized through an act, the Department of Inland Fisheries and Game to study the black bear in the State of Maine. Take time to go over to the Department, pick up the "Black Bear and its Status in Maine," and you will certainly vote against any bounty. Thank you, ladies and gentlemen.

The SPEAKER: The Chair recognizes the gentleman from Casco, Mr. Moore.

Mr. MOORE: Mr. Speaker and Members of the House: I realize that bounty is kind of a dirty word. I guess we should change it to reward, since we see so many shows on television we picture everyone that would shoot a bear as a criminal. Unfortunately I have spent a lot of time in the woods hunting and trapping and in the north country where I have seen the actual damage that bear do to the farmers, and if I hadn't seen it myself, I might agree with these last two gentlemen here, Mr. Maxwell and Mr. Anderson. But I am

as much of a sportsman, I think I am, as anyone in this House to-But I also am interested in the farmers. I think that each one of us in the cities or from the cities that belong to sporting clubs, and we are opposing this bill, are overlooking the fact that the farmer is the fellow who supplies us with the land to hunt on. Now he has the problem, and I think it is in all fairness that we should pass this amended bill as it is. We had a big hearing there; it lasted for two hours, and there were men from the Maine State Grange from the Farm Bureau, and the Cattle Breeders Association and from the Sheep Breeders Association, and they were serious men, they weren't down there asking for something that wasn't so. They were telling us the facts.

Now I am more interested in keeping our farmers in this state than I am in getting some out-of-state hunter in here to shoot a bear. Now I have hunted a lot around and seen a few bear and I haven't shot many, and if the men don't want to come into this state to hunt the deer, as far as I am concerned, I will keep the farmers and let them stay in Massachusetts or where they are.

I went over to the Department of Agriculture this morning to see what this probably would cost the Department of Agriculture. In the last two years that they paid a bounty, during that season from May to the first of October in '55 and '56 they paid \$3330, that is what it would cost. In the year '56 and '57, that fiscal year it cost \$2565. Now if we can keep the farmers back on the farms and let —we have enough deserted farms in this area now, and we have enough posted land in this area, in this state, and the sportsmen's clubs are always complaining because the farmers are posting their land. Let's show them that we are interested in the farmers' problem and vote against this motion of the gentleman from Ellsworth, Mr. Anderson. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Farmington, Mr. Jones.

Mr. JONES: Mr. Speaker and Members of the House: We bear with my brother Maxwell and I think from what he said, it is indicative of the fact that he is in favor of passing legislation here more to the interest and in favor of the people living without our state limits who want to come in here and hunt the big animal, the big bruin.

I might say that this bill only pertains to bounty on animals within organized townships. It doesn't cover for areas outside of that and, therefore, we have plenty of wildlands in the state, and I am sure that even though this bill passes there will still be ample number or large population and enough bear to interest those out-of-state sportsmen. So I move for a division at this time.

The SPEAKER: The gentleman from Farmington, Mr. Jones, has requested a division.

The Chair recognizes the gentleman from Guilford, Mr. Dodge.

Mr. DODGE: Mr. Speaker, in regard to the damage that bear may do, back when they had the CCC camps under Mt. Katahdin, they had to hire a professional hunter to go in there to get rid of the bear that were causing so much damage breaking into the camps. I think he killed or trapped about seventeen bear. They can be and do a lot of damage at different times. Now as far as a bounty controlling animals, we have various kinds of bounties. We have a bounty paid by the State, you have a bounty paid on a beaver skin by some buyer of fur. Now if you should take all the protection off from beaver, how long would they last? We don't have animals just to go out in the woods and kill them. We hunt them for some reason. We hunt them because we eat the deer. We hunt the beaver or trap it because we get the fur, and we did trap the fox as long as his fur was worth anything. At the present time the fox is overrunning in many parts of the State because there isn't any bounty of any kind, either on the fur or by the State.

I am in favor of this bill. I think it is going to help the farmers that are handling sheep. We have many abandoned farms in this State. Now these farms are growing up to hazel bushes and

stuff like that, and more and more farmers — people come in there and raise sheep. In my area they have a big — we almost might call it a sheep ranch, where they raise many sheep. Now if bear get into places like that, it is going to cause a lot of trouble; and more and more people want this business to come into the State. It is becoming a large business and will be larger, and it needs some protection.

The SPEAKER: This might be an opportune time to mention that under the rules, each member is entitled to speak twice on a matter before the House, and if they speak for a third time, they have to get permission from the House to do so.

The Chair recognizes the gentleman from Ellsworth, Mr. Ander-

Mr. ANDERSON: Mr. Speaker. Ladies and Gentlemen of the House: I just want to say one word in rebuttal, that the State of Maine saw the light in 1957 and New Hampshire five years ago.

The SPEAKER: The Chair recognizes the gentleman from Stetson, Mr. Merrill.

Mr. MERRILL: Mr. Speaker and Members of the House: I went along with the Majority Report on this bill and I think it is a good bill. I think that we get several bounties on different animals, and I will refer back to 1949: I introduced a bill here on bounties on porcupine and it got killed. In 1951 it came out, and it has been a wonderful thing for the State. I think these people that are off in these sections that are trying to raise sheep and their fruit, I don't know why they are not entitled to this bill. I think it is fair. It won't cost the State much money, and I am in favor of this bill.

The SPEAKER: The Chair recognizes the gentleman from St. Albans, Mr. Hughes.

Mr. HUGHES: Mr. Speaker and Members of the House: This problem like many others, of course, has two sides. I am a hunter to some extent. I have never seen any bear in the woods, let alone shot one, so I am probably not a very good hunter; but I would like very much to shoot a bear, but not at the expense of the farmers, so I would be opposed to the motion that is before the House.

The SPEAKER: The Chair recognizes the gentleman from Sangerville, Mr. Edgerly.

Mr. EDGERLY: Mr. Speaker, Ladies and Gentlemen  $\mathbf{of}$ House: I am probably a pretty poor bear trapper, but I have caught a few, and I have seen a good many of them in the woods. won't bother you much because would talk too long, but I am talking now for the trappers. I am a trapper and I know lots of other trappers, and they are enjoying this very much to see the bounty not put on bear now until they can get up where they can reap a harvest collecting the bounty. They are gaining every year and by and by you will have years coming when the State has got to put on a bounty. Then they pay just as much or more, add the years together as they would if they had kept a bounty on all the time. I want to get that on the record so they can look back and see that I didn't prophesy wrong.

SPEAKER: The pending question before the House is the motion of the gentleman from Ellsworth, Mr. Anderson, that the House accept the Minority "Ought not to pass" Report. A division has been requested.

The Chair recognizes the gentleman from East Machias, Mr. Dennison.

DENNISON: Mr. Speaker. this bounty on bear, now I think if every person in this Legislature had the opportunity to see one of these animals in a trap, I don't think they would ever vote for a bounty on bear; because when an animal of this size is in a trap and you want to catch him in the summertime when it is hot, why they have got to stay there until they die, they have got to choke to death. They are maimed. In my mind it is the most cruel of all things that anyone can do is to trap a bear.

The SPEAKER: I will put the motion again. The question before the House is the motion of the gentleman from Ellsworth, Mr. Anderson, that the House accept the

Minority "Ought not to pass" Report on Bill "An Act Providing for Bounty on Bears," House Paper 17, Legislative Document 36. All those in favor of the motion to accept the Committee "Ought not to pass" Report, please rise and remain standing until the Report, please rise monitors have made and returned the count.

A division of the House was had. Fifty-three having voted in the affirmative and seventy-four having voted in the negative, the motion did not prevail.

The SPEAKER: The Chair recognizes the gentleman from Ellsworth, Mr. Anderson.

Mr. ANDERSON: Mr. Speaker, I would like to ask for a roll call.

The SPEAKER: The gentleman from Ellsworth, Mr. Anderson, has requested a roll call. For the Chair to order a roll call, it must have an expression of a desire for a roll call by at least one-fifth the members of the House. Will all those who favor a roll call, please rise and remain standing until the monitors have made and returned their count. Obviously, less than one-fifth having arisen, a roll call is not ordered.

Is it now the pleasure of the House to accept the Committee Majority "Ought to pass" Report?

The motion prevailed, the Majority "Ought to pass" Report was accepted and the Bill read twice.

Committee Amendment "A" read by the Clerk as follows:

Amend said Bill by adding after the underlined word "killed" in the 7th line the underlined words 'between May 1st and September 30th'

Committee Amendment "A" was adopted and the Bill assigned for third reading tomorrow.

The SPEAKER: We are proceeding under Orders of the Day.

On further motion of the same gentleman, the Bill was referred to the Committee on Towns and Counties in concurrence.

Mr. Haughn of Bridgton was granted unanimous consent to address the House.

Mr. HAUGHN: Mr. Speaker and Members of the House: It has been my custom once each term to have a day in this House known as "Sucker Day" and today seems to be the day, and on behalf of the gentleman — of course I do mean candy suckers, so on behalf of the gentleman from Bridgton, I wish each and every member of the House a Happy Valentine's Day. (Applause)

Mr. Estey of Portland was granted unanimous consent to address the House.

Mr. ESTEY: Mr. Speaker, it has come to the attention of some of us from Cumberland County, that one of our colleagues, the honorable Leonard Stevens from Portland, was injured seriously in an automobile accident on his way to the State Capital this morning. We haven't all the facts yet, but we do understand that he is at St. Mary's Hospital in Lewiston. Therefore, Mr. Speaker, out of order, would move that Mr. Stevens be excused for the duration of his recovery.

The SPEAKER: Is it the pleasure of the House that the gentleman from Portland, Mr. Stevens. be excused for the duration of his illness?

The motion prevailed.

Mrs. Knapp of Yarmouth was granted unanimous consent to address the House.

Mrs. KNAPP: Mr. Speaker, I notice on all the lady-legislators' desks a valentine heart filled with chocolates. We would like to know where they came from and at the same time express thanks, thanking you from all the ladies.

The SPEAKER: The Chair would like to remind the House that in case of a motion made by the gentleman from Portland, Mr. Estey, that the order really should have been in writing. However, we made an exception in this case due to our great concern for the gentleman from Portland, Mr. Stevens, who has been injured.

The SPEAKER: On last Thursday, the Speaker was presented with a potato pie made from Maine potatoes. The Speaker took the pie home and I could say perhaps, that on behalf of the House,

the Chair and his family ate the potato pie, and found it to be very, very delicious. (Applause)

Mr. Storm of Sherman was granted unanimous consent to ad-

dress the House.

Mr. STORM: Mr. Speaker, for the record, I think we should correct the remarks that were just made. I believe those were Aroostook potatoes.
