Ought to Pass Indefinitely Postponed

Report of the Committee on Business Legislation reporting "Ought to pass" on Bill "An Act Changing Name of Portland Symphony Orchestra to Maine Symphony Orchestra" (S. P. 103) (L. D. 248)

Came from the Senate with the Report read and accepted and the Bill passed to be engrossed.

In the House, the Report was read.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Minsky.

Mr. MINSKY: Mr. Speaker, Ladies and Gentlemen of the House: I realize this probably is not the most momentous bill that will come before this body in this session; however, some of us do feel that there is some principle involved. That basically is loaning the official State name to any local ac-tivity. Now the Portland Symphony Orchestra I know to be a very fine symphony orchestra, but there are also two other symphony orexisting in chestras the State. There is one in Waterville and there is one in Bangor. I know a little of the background of the Bangor orchestra. I would like to inform the House of that.

The Bangor orchestra was formed in 1896. It is now the third oldest continuing orchestra in the United States. In addition, it is now in its sixty-fifth year. In addition to that, I would point out that the Bangor Symphony, although it very happily retains the name Bangor Symphony, h a r dly represents only that community. I would like to point out that the members of that orchestra come from Carmel, Waterville, Brewer, Ells w or th, Castine, Farmington, Orono, Bar Harbor, Dexter, as well as from Bangor. So there is represented in the Bangor Symphony Orchestra ten different communities and four different counties.

I am sure something very similar takes place in Waterville, for their orchestra, no doubt, represents individuals from many different communities and several different counties. As I said, I don't really believe that any activity taking place in one part of the state should bear the state name.

Now the Legislature many years ago provided that before the state name was to be used they had to each receive permission from this body. I think that was done with cause. I would like to quote, if I could just briefly, one sentence made in the Senate by the chairman of this committee. He said this, "I think they also felt that this was on a first-come first-served basis," and this was the explanation why it received the report that it did. I respectfully submit that I don't think the use of the state name should be on a first-come first-served basis. I don't believe that the Bangor Symphony Orchestra is entitled to the name Maine Symphony Orchestra, I don't think the Waterville Symphony Orchestra is entitled to the name Maine Symphony Orchestra. And likewise, I don't think the Portland Symphony Orchestra is entitled to the name Maine Symphony Orchestra.

On this grounds, I would like to move that this Report be indefinitely postponed.

Mr. SPEAKER: The question before the House is the motion of the gentleman from Bangor, Mr. Minsky, that this report be indefinitely postponed.

The Chair recognizes the gentleman from Portland, Mr. Estey.

Mr. ESTEY: Mr. Speaker, Ladies and Gentlemen of the House: I would like to speak to this issue for just a moment, if you please. Mr. Minsky pointed out that this was a request on a first-come firstserved basis. This bill has been through the entire process of both the House and the Senate without opposition until it reached the Senate for enactment.

The Portland Symphony Orchestra is probably, without a doubt, one of the greatest cultural assets

this State has. A few years ago they reorganized and through some re-financing have built their orchestra with a New England reputation. They have played a number of concerts under the guest directorship Mr. of Gregorian from the Boston Symphony. And they are playing state-wide conthe near future their certs. In itinerary will take them outside of the State of Maine for guest appearances. The Portland Symphony Orchestra now pays its members for rehearsals and for travel as well as for concerts. This is a highly professional cultural group. They recruit their members from all over the State of Maine serving with membership from a number of counties. There is a direct conflict and the reason for this bill is that there is conflict in the promotion and the publicity of this orchestra with the Portland. Oregon Orchestra. With the Waterville and the Bangor Symphonies, there is no direct conflict because they serve principally as a community concert group.

I would also call your attention that this is not to be known as the State of Maine Symphony, but only the Maine Symphony Orches-tra. Recently, I understand that their orchestration has been rated as fine as that of the Rochester Philharmonic. Now I know that there are many large city orchestras of world-wide reputation, the Philadelphia Philharmonic, the New York Symphony, and the Boston Symphony, but there is no conflict again in the names of these orchestras, and they have world-wide reputation.

I would therefore, Mr. Speaker, move for a division.

The SPEAKER: The Chair recognizes the gentleman from Bridgton, Mr. Haughn.

Mr. HAUGHN: Mr. Speaker, Ladies and Gentlemen of the House: With all due regards to my colleague from Bangor, Mr. Minsky, I will have to concur with the remarks made by my colleague from Portland, Mr. Estey, because in the State of Maine we have several cases where the word Maine is used for industry and other purposes, but does not state "the State of Maine;" so therefore, I do not believe we are infringing upon their rights and principles up in Bangor or Waterville and I have high regards and respect for their orchestras, but the points have been brought out I think very clearly by both Mr. Estey and Mr. Minsky, and I hope that the motion before this House does not prevail.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Wellman.

Mr. WELLMAN: Mr. Speaker. Ladies and Gentlemen of the House: I will not take much of your time but I would like to point out that one of the problems that is facing the Portland Symphony Orchestra, and it is a problem, is the use of the name Maine. Now from time to time it has been suggested, and it was sug-gested at the hearing, that per-haps Southern Maine or some such word might be usable by them. This suggestion was rejected by them. So, therefore, I join with my colleague from Bangor and, to hasten harmony in this House, I also move for a division.

The SPEAKER: The Chair recognizes the gentleman from Casco, Mr. Moore.

Mr. MOORE: Mr. Speaker, Ladies and Gentlemen of the House: I think there is a little skulduggery afoot here. Been a pretty active morning. Mr. Minsky from Bangor says it's the principle involved. I think the principle involved is that he didn't think of it first. I wouldn't be too surprised, in two years from now, to see a bill introduced by the Bangor boys to change theirs to the State of Maine if we don't get this through. I hope you will vote against indefinite postponement.

The SPEAKER: The Chair recognizes the gentleman from South Portland, Mr. Brown.

Mr. BROWN: Mr. Speaker, Ladies and Gentlemen of the House: It seems in this bill the Symphony in Portland is only asking for a corporate name, which is available to any groups or anybody in the State. I notice in the telephone book, Lewiston-Auburn, there a r e quite a few listings under the heading of Maine. I do not wish to go through them, but there a re

over a dozen of them. So it does seem to me that it is quite permissible for them to ask for this.

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Knight. Mr. KNIGHT: Mr. Speaker, La-

Mr. KNIGHT: Mr. Speaker, Ladies and Gentlemen of the House: As a matter of information for this House, I think they should know there is a bill that has received the unanimous "Ought to pass" in this session, that if it is enacted into law will prohibit two organizations with the same corporate name. It was placed in the hopper at the request of the Attorney General's office, so if one group receives a certain corporate name no other group, if this bill is enacted, can ever have that same corporate name.

The SPEAKER: The Chair recognizes the gentleman from Lubec, Mr. Pike.

Mr. PIKE: Mr. Speaker, Ladies and Gentlemen of the House: It has been a puzzle to me why this hassle should blow up when it seemed very simple to keep from confusion with Portland, Oregon, which was named after Portland, Maine, on a close vote they didn't know whether to call it Portland or Boston, and they ended up with Portland. They ought to call it just the Portland, Maine Symphony Orchestra and that ought to make the Bangor boys happy and keep the Portland boys from being too upset over the confusion with their sister city out on the west coast. It is not legal to introduce an amendment, but it seems that ought to clear up all the difficulty.

The SPEAKER: The question now before the House is the motion of the gentleman from Bangor, Mr. Minsky, that the "Ought to pass" Report on Bill "An Act Changing Name of Portland Symphony Orchestra to Maine Symphony Orchestra," Senate Paper 103, Legislative Document 248, be indefinitely postponed, and a division has been requested.

All those in favor of the indefinite postponement, please rise and remain standing until the monitors have made and returned the count.

A division of the House was had.

Seventy-two having voted in the affirmative and sixty-seven having voted in the negative, the motion prevailed and the Report and Bill were indefinitely postponed in noncurrence and sent up for concurrence

The SPEAKER: The Chair recognizes the gentleman from Milbridge, Mr. Kennedy.

KENNEDY: Mr. Speaker Mr. and Ladies and Gentlemen of the House: I would like to smooth my way by first apologizing for imposing upon your time this imposing upon your time this morning. However, none of us like to lose a bill, and it distresses me to no end that this report was signed by my good colleague, the gentleman from Lubec, Mr. Pike. It does seem to me that some other member of that Committee could have signed this bill "Ought not to pass." This bill does have some merit, but I won't debate the merits of the bill. They may be strong and they may be weak, but I do remember this, that yesterday the members of this House smiled favorably upon a bounty bill. I might belabor this to some length and perhaps the House would again smile favorably for me, but I don't think that I will take your time for that. It retake your time for that. minds me of the eminent philosopher who hearing the water running in the bathroom was con-siderably disturbed and rushing to the head of the stairs, he finds his son cupping it up; the good philosopher stands there and is considering what best to do and best to say, and his son speaks up and says Dad, this is no time for physiological or - I can't pronounce it, thinking, so get the mop and let's get to work.

I have watched this bill, probably like you have yours, more or less with the nervous tension of an expectant father, hoping that it might get a good report. I could belabor it at length; perhaps I could even ask the House to table this bill for me at this time. I might be able to table this until May 30th, and then it wouldn't be dead, it would still be alive. Ladies and Gentlemen, I am not going to do this because I feel that I am a responsible legislator, and every tabled bill that is on our calendar is a legislative expense. Therefore, I don't feel that I should put the taxpayers of the State of Maine to this expense. I am not going to do that and if there is any moral to this story, I think it would be, that why should we table bills unless there is a specific reason for doing it and in your best judgment that something can develop that will be beneficial to the State of Maine.

Now, Mr. Speaker, I move that we accept the Report.

Therefore, I do not call this "peanuts," and I was opposed for that reason. Mr. Speaker, I move acceptance of the Minority Report and request a division.

The SPEAKER: The Chair recognizes the gentleman from Poland, Mr. Dunn.

Mr. DUNN: Mr. Speaker and Ladies and Gentlemen: What my good friend, the gentleman from Washington, Mr. Finley, has said, is all true; this is a department bill and it is simply an increase from twenty-five to fifty cents for issuing a duplicate license, keeping in line with other states, the majority being fifty cents. Massachusetts for this same thing charges \$1.50 and there is one other state which charges \$2.00.

Mr. WHEATON: Mr. Speaker, in answer to the gentleman from Perham, this does eliminate the one room. Anybody that has a room to rent has to pay the tax on it. I might elaborate on several other things that are in the bill. If anybody rents a room for twentyeight days or more, they are excluded from the tax; and another thing that is mentioned in the bill, if anyone operates a tenting ground, there is a tax on that now, the same as on trailer parks or anything like that. This bill was to clarify certain things, and it was actually a department bill. It was not for increasing revenue, it was just for clarification.

The SPEAKER: Does the gentleman from Perham, Mr. Bragdon, consider his question answered?

Mr. BRAGDON: Mr. Speaker, in view of the answer, I think I would request that this bill be tabled so that we may take a further look at it, until Wednesday of next week I think would be satisfactory.

My first amendment that I laid on your desk yesterday morning, that I did not present, would have restored that privilege. However, one of the very esteemed members of the House discovered that if it was passed, even with that amendment, his wife could not kill a mouse with a broom and do it legally. I believe this amendment will restore peace and harmony for everybody.

The SPEAKER: The Chair recognizes the gentleman from Harrison, Mr. Morrill.

MORRILL: Mr. Mr. Speaker. Ladies and Gentleman of the House: This initial number plate bill covers all types of special plates and these plates are not limited to any special class. They can be purchased by any person in the State

of Maine. Now this bill came from the committee with an "Ought not to pass" Report, and the reason for this report was that there were objections from the Secretary of State, Paul MacDonald. He was opposed to the bill because of a book listing the number plates and owners that was used by State Police. This objection has been overcome and they find that they can print a book that can be used by the State Police. Now this bill has a fee for these plates and it is not force taxation, it's optional, anybody who wants to take advantage of it can buy these special plates.

The income that can be derived from this bill, working in accordance with states that have this initial license plate, the first year the income would be approximately a hundred thousand dollars and within three years it would be around a quarter of a million dollars income.

So at this time I move that we substitute the bill for the report.

The SPEAKER: The question now before the House is the motion of the gentleman from Harrison, Mr. Morrill, that the House substitute the bill for the report. All those in favor of the motion please say aye; those opposed, no.

A viva voce vote being doubted by the Chair, a division of the House was ordered.

The Chair recognizes the gentleman from Bridgton, Mr. Haughn:

Mr. HAUGHN: Mr. Speaker, to clarify the minds of several who may be in doubt on this particular bill, there was an objection raised by Mr. Wood who runs the mailing service in Auburn, which sup-plies the state and all New Eng-land states and in fact all over the country with this necessary infor-mation. That objection now on the part of Mr. Wood, if this provision is made for the information of State Police and with an index of initial number plates, he has removed his objection in regards to this. So I hope that when the vote is taken, they will consider his objection is removed with an amendment which will be possibly coming in to clarify and take care of their issues.

Mr. MacDonald's objection, with this amendment that will be coming in will clarify it to the satisfaction of all. So I hope you will take that into consideration. Those objections which were brought before the committee, if it had been recommitted, might have brought out a different report. So I hope you will take that into consideration.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Briggs.

Mr. BRIGGS: Mr. Speaker, Ladies and Gentlemen of the House: I recently took a trip through New England with some people in the car. This is the type of license plates we saw coming toward us from several states. One of them said HAM, the other one said JAM, another one said DAM, and everybody in the car laughed their heads off. This is the type of plates we will probably have if we have these initial plates.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Berry.

Mr. BERRY: I would like to retable this item until Thursday, February 23.

The SPEAKER: The gentleman from Portland, Mr. Berry, moves that this item be tabled and specially assigned for Thursday, February 23, pending the motion of the gentleman from Harrison, Mr. Morrill, that the Bill be substituted for the "Ought not to pass" Report.

All those in favor of the tabling motion please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Eighty-one having voted in the affirmative and twenty-eight having voted in the negative, the tabling motion did prevail.

The SPEAKER: I have the pleasure to announce that tomorrow in the rotunda on this floor, a former Governor and now United States Senator Muskie will be here for the ceremonies pertaining to the unveiling of his picture in the rotunda, and we hope that everyone can be here at eleven o'clock tomorrow to attend the ceremonies.
