Tabled — February 16, by Mr. Brown of South Portland.

Pending — Motion of Mr. Curtis of Bowdoinham to Indefinitely Postpone.

The SPEAKER: The Chair recognizes the gentleman from Bowdoinham, Mr. Curtis.

Mr. CURTIS: Mr. Speaker, Ladies and Gentlemen: Perhaps nothing that I can say may change the opinions of some who may have already made up their minds, but for those who have not and those who have perhaps, I wish you might consider this as it is.

Now we are here considering many tax hikes, and we want we will be considering income tax, we are going to consider sales tax, cigarette tax, and what have you, and yet at the same time we are saying to these people here we are going to cut your wages. I was just wondering just how you add that up, and I would remind you that this minimum wage law didn't please everybody, and that if you start in picking at it a little here and a little there — now there are not too many of these people who can stand up and fight for themselves, very few, because if they say too much or perhaps anything why they could easily lose their job. So you and I as legislators sent up here have their fate in our hands, and I hope that you really consider it, and really consider the whole law.

It seems to me that one dollar per hour or eight dollars per day is small enough under the present conditions, let alone with more taxes, which undoubtedly when this legislature ceases to exist. there will be more taxes, so I wish that you might consider seriously the condition of these men and perhaps some women who are driving these, because it is a fact, and perhaps you have noticed it, that before we had a minimum wage law affecting these people that some people were driving these taxis which I don't think you would be too happy to ride with, but I think we have a pretty good number, a pretty good outfit driving these because they are getting a fair wage, and if you are going to start cutting the wage we will just simply drop back where it will be quite unsafe, perhaps in some cases, I don't say in every case, but it could be in some cases, but because the need is there, and these men do need this wage, I move this be indefinitely postponed.

The SPEAKER: The Chair recognizes the gentleman from Friendship, Mr. Winchenpaw.

Mr. WINCHENPAW: Mr. Speaker, Ladies and Gentlemen of the House: I talked on this bill the other day and my thinking hasn't changed, and I think that if we did not pass this bill, that the

taxi drivers might be worse off than they are now. Right now some of them get thirty-eight percent of the gross, some get thirty-five percent of the gross, and not too many of them are covered anyway, because if you own three taxis, you are not covered by the minimum wage. So I move for a division when the vote is taken, and I certainly hope the motion made by the gentleman from Bowdoinham, Mr. Curtis, does not prevail.

The SPEAKER: A division has

The SPEAKER: A division has been requested. The question before the House is the motion of the gentleman from Bowdoinham, Mr. Curtis, that Bill "An Act Exempting Taxicab Drivers from the Minimum Wage Law," House Paper 1056, Legislative Document 1265, be indefinitely postponed. If that motion does not prevail, then the bill will be on its way to be passed to be engrossed. Therefore, if you favor indefinite postponement of this bill, you will rise on the first vote. All those in favor of indefinite postponement of this bill please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Five having voted in the affirmative and one hundred seventeen having voted in the negative, the motion did not prevail.

Thereupon, the Bill was passed to be engrossed and sent to the Senate.

The Chair laid before the House the third tabled and today assigned matter:

HOUSE ORDER — Relative to Bills and Resolves Carrying Appropriations to be Placed on Special House Calendar.

The Chair laid before the House the fourth tabled and today assigned matter:

ployees of the University of Maine and their Salaries.

Tabled — February 22, by Mr. Baxter of Pittsfield.

Pending - Passage.

The SPEAKER: The Chair recognizes the gentleman from York, Mr. Rust.

Mr. RUST: Mr. Speaker, Gentlemen and Gentlewomen of the House: As an alumnus of the University of Maine, this particular bill has come to my attention—I should say House Order, and I personally feel that there is no need for it. The expense of printing and distributing it as far as I am concerned is unjustified, and I would also like to say at this time that anyone who has a particular interest in any particular salary of any particular individual at the University of Maine, may get such information from the Budget Office because they have a copy there of the salary of every individual at the University, and therefore at this time, I would move that this House Order be indefinitely postponed.

The SPEAKER: In reference to item four on page seven, the question now before the House is the motion of the gentleman from York, Mr. Rust, that this Order be indefinitely postponed.

The Chair recognizes the gentleman from Harrison, Mr. Morrill. Mr. MORRILL: Mr. Speaker, La-

Mr. MORRILL: Mr. Speaker, Ladies and Gentlemen of the House: I believe with the increases we have coming in the appropriations for the University of Maine that we should study some of these figures. I believe they are somewhat different than they were two years ago and four years ago, and I hope that you will not go along with the indefinite postponement of this Order.

The SPEAKER: The Chair recognizes the gentleman from Bridgton, Mr. Haughn.

Mr. HAUGHN: Mr. Speaker and Ladies and Gentlemen of the House: Three weeks ago on the Floor of this House I presented a Joint Order to divulge the salaries for the payrolls of the state employees of the State of Maine, their classifications and the names. Now there is no difference in this particular order than what we have already adopted for the state em

ployees. We have a payroll plan before us for them. We have an expenditure by the State of Maine in large amounts. To me there is no differential, and this House should be fully informed before expenditures are made as to what they are being made for, and I hope the motion of the gentleman from York, Mr. Rust, does not prevail.

The SPEAKER: The Chair recognizes the gentleman from York, Mr. Rust.

Mr. RUST: Mr. Speaker, I request a division on this vote.

The SPEAKER: A division has been requested. The question before the House is the motion of the gentleman from York, Mr. Rust, that this House Order be indefinitely postponed. All those who favor the motion to indefinitely postpone this order please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Twenty-four having voted in the affirmative and one hundred and one having voted in the negative, the motion did not prevail.

Thereupon, the Order received passage.

The Chair laid before the House the fifth tabled and today assigned matter:

Bill "An Act Providing a State-Wide Limit on Certain Fish." (S. P. 69) (L. D. 169) — In Senate Passed to be Engrossed.

Tabled — February 22, by Mr. Perry of Easton.

Pending — Passage to be Engrossed.

The SPEAKER: The Chair recogognizes the gentleman from Princeton, Mr. Wheaton.

Mr. WHEATON: Mr. Speaker, Ladies and Gentlemen of the House: I would like to retable this bill for the purpose of preparing an amendment to it pending passage to be engrossed. I suggest we table it until March 2.

The SPEAKER: The gentleman from Princeton, Mr. Wheaton, moves that this Bill be tabled to March 2 pending passage to be engrossed. For what purpose does the gentleman arise?

Mr. PERRY of Easton: Well, Mr. Speaker, Members of the House: I had an amendment here that I presented and I wondered if I could speak about it at this time.

The SPEAKER: A tabling motion is not debatable. You will have an opportunity to present an amendment later. Is it the pleasure of the House that this item be tabled and specially assigned for Thursday, March 2?

The motion prevailed and the Bill was so tabled and specially assigned for Thursday, March 2, pending passage to be engrossed.

Mr. FOGG of Madison was granted unanimous consent to briefly address the House.

Mr. FOGG: Mr. Speaker and Members of the House: As you all know we've now finished our eighth week in this session. Due to the very capable management of our Speaker, Representative Good, we seem to be setting an unprecedented rate of progress here in the House. I think that he deserves commendation for the job that he is doing.

When the session first started, I was asked, the question was put to me as the leader of the Minority Party, what our policy would be in this Legislature. My reply was, I was going to make it just as constructive as possible. I stated that we would offer criticism when we felt that criticism was due, and that we would offer any constructive suggestions which we could think of. It has always been our utmost desire not to appear obstructionists and we certainly have hoped that we would never appear as a group who was just looking for something to complain about.

I feel that we have adhered to this policy very religiously and I feel that our conduct so far has been well beyond reproach.

Now we have reached a period in this Legislature when a series of financial problems is going to start to rear its head. We have listened to the Governor's Budget and we have read it and as a result of that there's certain observations which our steering committee has asked me to put before this body. These observations have been drawn up in the form

of a statement, and I could take considerable time to read that statement, but I know everyone is anxious to go home, and this statement has been distributed to you, everybody has a copy of it. I would like to introduce that as part of my remarks.

Mr. Anderson of Ellsworth was granted unanimous consent to address the House.

Mr. ANDERSON: Mr. Speaker, Ladies and Gentlemen of the House: I hope you won't think me presumptuous when I say that I feel we should discuss at every available moment the Budget Message so ably delivered by his Excellency, Governor Reed. It certainly is not a matter that can be digested in a few hours or a few days, it will require long and serious consideration.

At every opportunity, we should inject into our thoughts and opinions, into our discussions in the House, in the corridors, or at the dinner table. If we all do this, I am sure, as the session wears on, with this exchange of views, we will come up with intelligent, honest, constructive legislation.

As I remarked in caucus a short time ago, "The will of the people is the legitimate foundation of government." I'd like to add that it is a contrivance of human wisdom to provide for human wants — it is a trust, and we, as representatives are trustees.

As a freshman Legislator, I am confused and bewildered by the staggering increase in amounts that highways, education, institutions and all functioning departments of the State are asking for in the coming biennium.

I am reminded of a runaway horse dashing crazily down a street until he crashes into some insurmountable obstacle and destroys himself and the load behind him. But if some courageous bystander should reach out and snatch his bridle as he sweeps by and bring him to a halt, both horse and load would be saved from destruction.

I don't think I am far out of line when I say that every member here in campaigning for this office promised economy to their constituents. Let's not betray that trust — let's keep our promises.

There was a time when thrift was a virtue — but now, apparently, it seems to be un-American to save. We should spend, spend some more and keep on spending.

Let's dedicate ourselves to the revival of thrift — keep it breathing for posterity. Let's go down in Maine history as the 100th Legislature that stopped the runaway horse. (Applause)

The SPEAKER: We are proceeding under Orders of the Day. The Chair recognizes the gentlewoman from Falmouth, Mrs. Smith.

Mrs. SMITH: Mr. Speaker, and Members of the House: You will find on your desks a copy of the potato pie recipe. This started out to be a promotion for the potato people here. I'm not sure it's not going to be a promotion for me, but anyway it's on the table. (Applause)

Mr. Anderson of Greenville was granted unanimous consent to briefly address the House.

Mr. ANDERSON: Mr. Speaker, Ladies and Gentlemen of the House: As you well know in the near future we will have "Welcome Back Day" for ex-members of this House. The plans are going along, just how fast I don't know. The forms have been printed for you to send out to the Legislators who served in your district or who may have served in another district and are now living in yours.

For those of you who have not sent out invitations, the printed invitations, I would advise you that there will be additional information that will be available Tuesday next. And you may want to wait until such time as you get that information to enclose with the invitation that you send to the Legislators.

The SPEAKER: The Chair wishes to take just a brief moment to announce, before adjournment, some of the statistics we have on hand here at the end of the eighth Legislative week. Reported out of committees two years ago were two hundred twenty-eight items; report-

ed out of committees and to the end of this, the eighth week in the 100th Legislature, compared to the two hundred twenty-eight items, we have reported out four hundred. Two hundred twenty-eight to four hundred.

The Chair would like to remind the members of the House that there will be a session next Friday at nine o'clock in the morning.
