Friday, March 17, 1961

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Edward F. Allen of Augusta.

The journal of the previous session was read and approved.

Papers from the Senate

From the Senate: The following Order:

ORDERED, the House concurring, that free additional telephone service be provided for each member of the Senate and House to the number of twenty-five (25)calls of reasonable duration from Augusta to points within the limits of the State of Maine, and that each member of the Senate and House be provided with a card to be certified to by the Secretary of the Senate and Clerk of the House, respectively; charge for this service to be paid to the New England Telephone and Telegraph Company at regular tariff rates (S. P. 494)

THAANUM: Mr. Speaker Mr. and Ladies and Gentlemen of the House: I have been requested to make a little explanation about this before we proceed to vote on it. The request for leave to withdraw on House Paper 507, Legislative Document 706, should be granted because at the hearing before the Labor Committee, the Commissioner of Labor and Industry indicated that any individual engaged or employed by a non-profit organization operating for the assistance of either children or the aged is already exempt under the minimum wage law under the definition of employee found in Chapter 30, Section 132b, sub-section 3, sub-section d. I think that perhaps explains it. Thank you.

Mr. RUST: Mr. Speaker, Ladies and Gentlemen of the House: I think it is only right that this matter should be brought to the attention of the House because this bill substantially changes the law as it relates to blind persons.

Under the existing law a blind person using a recognized and well-known white cane has a right to make certain signals and a motorist must stop in order to let this blind person cross the street. This particular bill will do away with the white cane and substitute any light metallic cane. All I can say is, from here on if you see anybody waving a light metal cane, you better stop because you might get pinched. Thank you.

No physician or surgeon shall operate an amber blinker or flashing amber signal light upon such motor vehicle except while actually enroute to the scene of an emergency requiring his professional services.' The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Wellman.

Mr. WELLMAN: Mr. Speaker, Ladies and Gentlemen of the

House: I presented this bill that we have before us now because under the tax statutes that we now have in this State, all scientific and literary institutions such as colleges, are exempt from the local property tax. Now way back in 1887 this matter was before this Legislature again, and the point that the people brought before the Legislature at that time was that they felt that it was unfair for these institutions to be engaged in commercial activities and receive the same tax exempt privileges that the institutions received for their scientific engaging in and literary endeavors. So a compromise was worked out whereby any real estate that was devoted to this commercial activity would be rebated to the extent of \$1500 per year to each institution. This is the law as it now reads with all the lines drawn through it that you will find in L. D. 1440 if you wish to turn to it.

I presented this bill because I believe deeply that we must reconsider our tax statutes. We must think carefully why we are giving exemptions. What is the basic purpose that we are sitting here in this Hall, why are we giving these exemptions?

I brought this bill before the Taxation Committee. I have received some support on that Committee. I have received some support from some of my colleagues here in the Hall. I don't wish to belabor this point any more. I hope that I have brought it to the attention of this body, and I now move the acceptance of the Majority Report.

Pending — Acceptance of Report. The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Jameson.

Mr. JAMESON: Mr. Speaker, Ladies and Gentlemen of the House: The renegade from Bangor would like a word with you. On Febru-ary 8, I presented this bill to the Agriculture Committee. I sincerely believed as I believe right now and I think you will if you study this, the consumers, the that wage earners are paying too much for milk. When I went before that Committee, and at no time did I injure or say anything that would injure the producer, the farmer, the man who works sixteen to twenty hours a day. God knows I would not want to hurt him. My bill is confined chiefly to abolish price controls in the wholesale and retail markets. Now this committee I have all the admiration in the world for, of course I was new, and I did not believe before I came to this Legislature that I could ever listen to anybody over twenty minutes. This wonderful Agriculture Committee listened to milk bills for four hours and forty minutes while I sat there, yes I got to listen too, so, I realized when I left there that it was the most patient group of people that I ever met in my life. So again I have the greatest admiration for them.

Now I will take a little of that back though, I did not have too much admiration for the report on my bill. Therefore, that is why I am here. Now ladies and gentle-men, this bill was enacted in 1935 as an emergency measure. Is there any greater an emergency than right now, with thirty-one thousand or more unemployed, each with two or more maybe large families, urged and required to furnish one quart of milk per child to produce a good strong healthy body? I ask you, can these unemployed with five or six children, pay twentytwenty-seven, six, twenty-eight. twenty-nine cents a quart for milk? I am not going to keep you here all day, I know you want to get home, so I am going to make this as brief as I can.

Not only the thirty odd thousand who are unemployed, but the average consumer, I sincerely believe that they pay too much for milk. I do not want to see the producer's level hurt in any way, shape at all, but I would ask you to consider

all the different things that come into this bill. I think it is an important bill. For so many people today, everybody uses milk.

When I left that Agriculture Committee, I was approached even until midnight that night, all the next day, to withdraw the bill. And each one that approached me convinced me that this bill was more important than I realized at the beginning. I was coaxed, teased and inveigled in every which way, in fact, I was offered a couple of drinks, (Laughter) not milk, (Laughter) but I went home and thought it over, ladies and gentlemen, and when I got home the previous weeks, I was condemned from the top to the bottom for introducing such a bill. But after this appeared in the paper, that weekend I was congratulated from all over the county, not only the seven thousand two hundred people that elected me here. Everybody was calling me from everywhere - distributors — not distributors, I'll take that back - I wish to withdraw that statement. (Laughter). The producers, farmers everywhere said it is time that this racket was broken up. You realize more and more as you read the papers now that the Government is prosecuting different firms for price-fixing, violation of the anti-trust laws through price-fixing. Well the same thing applies right here I think. Only it is legalized here in Maine, price-fixing.

In Massachusetts right now they are selling milk anywhere from fifteen to twenty cents a quart by the gallon. Why, ladies and gentlemen, can't it be done here? I will explain why it cannot be done in my neighborhood. And this is the truth, if a producer over there advertises milk fifteen to seventeen cents, come and get it, bring your own containers, one of the two dairies are going to tell him off but quick that they no longer need his milk. He is sucked into this racket and he cannot get out. What is he going to do with five or six hundred quarts of milk a daydump it? No, he cannot do that. But he must sell it to H. P. Hood of Boston for three or three and one-half cents a quart. He cannot

stay in business long that way, can he?

Now I have been threatened, this would bring in a price war—a milk war. Before I went into that committee, ladies and gentlemen, I wish to assure you that I talked with two of the very leaders of the Agriculture Department. And they assured me that this all powerful committee could stop a price war awful quick. Gave me more confidence with this bill.

Now again folks, instead of going through all of this data I have here, I just ask you to stop and think before you vote, realize what you are voting on, that you are voting for everybody in the State of Maine, not only your own community alone, every consumer of milk. Please consider the wage earners, and particularly the thirty-five thousand who are out of work today.

Mr. Speaker, I wish to substitute the bill for the report.

The SPEAKER: The question now before the House is the motion of the gentleman from Bangor, Mr. Jameson, to substitute the bill for the report.

The Chair recognizes the gentleman from Bowdoinham, Mr. Curtis.

Mr. CURTIS: Mr. Speaker, Ladies and Gentlemen of the House: I having been a producer of milk for twenty-five years and a dealer for some twenty years, I want to go on record that I agree very much with the gentleman who just spoke in regard to this bill.

I think perhaps things contained in this L. D. affects more people than any L. D. that has been presented or will be presented to this present Legislature. I just want to point to one thing that where some might think it will take away the minimum price support for the consumer, that it would be chaos as it has been in some other states, but you will find in section 8 that this bill says "Consumer price fixing. The price charged consumers and others for milk by distributors shall not be fixed by the board unless the board shall determine. either upon complaint or upon its own initiative, after public notice and hearing, that the public health is menaced, jeopardized or likely

to be impaired or deteriorated by the loss or substantial lessening of a supply of milk of proper quality in a specified market."

Now with that in there, which is part of this L. D., why, no one needs to fear that great injustice will be done to anybody. I have always been for this control board, it was back as has been stated in the early '30's, and that was surely chaos. I sold milk, I was just a producer at that time, and I sold milk in Lewiston, Maine for fortytwo cents a hundred; ladies and gentlemen, there are forty-six and one-half quarts in a hundred pounds. And so this control board has done much for the dairy industry and for the people in Maine. But the time has come, I believe, when we should have a little more regulation because as I iust checked with some of my neighbors who are producers, this week, I find that they are receiving eleven cents a quart for their milk, while you folks are paying twentysix or twenty-seven. The spread is too great, and the only way we can do it is by this legislation; and that it will not harm the dealer, I do not believe, because it will still be under the control board. If he thinks he is being hurt why he can come up and show the reasons why and the control board will have the power to regulate the consumer prices.

Therefore, I believe we all should make a greater study of this thing, because we are all affected, we all use milk. And that we might have a little more time to study this thing, I am going to ask you that we might table it again until Wednesday next when everybody can look over the situation and vote intelligently upon this thing. Because the last thing I would hate to see is the dairy industry harmed in any shape or manner. Because as far as farming is concerned in this State, it is the only real thing that we have got to pay our bills with—is the dairy industry—and while the boat industry somehow has grown wonderfully. but you never can tell because the prices are so fluctuating-they are coming in and going out all the time.

I believe this is fine legislation, and I hope that you will table it until you make a further study and then vote as you see fit.

The SPEAKER: In reference to item 2, Legislative Document 648, House Paper 448, Bill "An Act relating to Price Controls on Milk," the gentleman from Bowdoinham, Mr. Curtis, moves that this Bill be tabled until March 22, pending the motion of the gentleman from Bangor, Mr. Jameson, to substitute the Bill for the Report. Is this the pleasure of the House?

The motion prevailed.

The Chair laid before the House the third tabled and Wednesday assigned matter of unfinished business:

Bill "An Act Requiring the Humane Slaughtering of Livestock." (S. P. 483) (L. D. 1475)

Tabled — March 10, by Mr. Brown of Fairfield.

Pending — Passage to be Engrossed.

The SPEAKER: The Chair recognizes the gentleman from Fairfield, Mr. Brown.

Mr. BROWN: Mr. Speaker, after some weeks with the Department of Agriculture, I find that many of my objections have now been removed, my principal reason for tabling this bill was the method by which the bill sought to eliminate certain practices. I believe it is the fundamental duty of any Legislature to make the laws as they should be made and not depend upon a commission to hold hearings and promulgate regulations. I feel as though any bill should be made by the Legislature and spell out the conditions and terms. However, in view of the study of the Federal Humane study of the Federal Humane Slaughter Act, I now move that this bill be passed to be engrossed.

Thereupon, the Bill was passed to be engrossed and sent to the Senate.

The Chair laid before the House the fourth tabled and Wednesday assigned matter of unfinished business:

Bill "An Act relating to Night Hunting of Wild Birds." (H. P. 879) (L. D. 1214) Tabled — March 10, by Mr. Moore of Casco.

The SPEAKER: The Chair recognizes the gentleman from Bath, Mr. Brewer.

Mr. BREWER: Mr. Speaker. Ladies and Gentlemen of the House: L. D. 798. was reported out committee with of а Majority "Ought not to pass" Report. Since that time the sponsor has requested that the Committee hear further testimony. This being agreeable with the committee, I will move that this bill and the report be recommitted.

Thereupon, the Bill and Report were recommitted to the Committee on Claims and sent up for concurrence.

The Chair laid before the House the second tabled and today assigned matter:

The SPEAKER: The Chair recognizes the gentleman from Lubec, Mr. Pike.

Mr. PIKE: Mr. Speaker, we are still having drafting difficulties with this bill, and I would request that it be retabled and specially assigned for next Wednesday, March 22.

Thereupon, the Bill was retabled and specially assigned for Wednesday, March 22. The Chair laid before the House the third tabled and today assigned matter:

The SPEAKER: The Chair recognizes the gentleman from Farmington, Mr. Jones.

Mr. JONES: Mr. Speaker, Ladies and Gentlemen of the House: The wording of the original bill was such that it was not fully clear; therefore in order to clarify the bill, I lay before you House Amendment "A" and move its adoption, to clarify the terminology in the bill.

The SPEAKER: The gentleman from Farmington, Mr. Jones, offers House Amendment "A" and moves its adoption.

House Amendment "A" was read by the Clerk as follows:

The Chair laid before the House the fourth tabled and today assigned matter:

An Act Permitting Bars in Taverns. (S. P. 235) (L. D. 639) Tabled — March 14, by Mr. Chapman of Norway.

Pending — Passage to be Enacted.

The SPEAKER: The Chair recognizes the gentleman from Norway, Mr. Chapman.

Mr. CHAPMAN: Mr. Speaker, I move that this bill be indefinitely postponed.

The SPEAKER: The question now before the House is the motion of the gentleman from Norway, Mr. Chapman, that L. D. 639 be indefinitely postponed.

The Chair recognizes the gentleman from Winslow, Mr. Dostie.

Mr. DOSTIE: Mr. Speaker and Members of the House: I feel that this is a good bill. All it does is just to give stools to these taverns. I think we only have eight in the State, and I think it came out of committee eight to two in favor. I feel that if we had more taverns in this State of Maine and less beer parlors, we would have less divorces. Where men would go in by themselves and drink beer. So I move division when the vote is taken.

The SPEAKER: A division has been requested. The question before the House is the motion of the gentleman from Norway, Mr. Chapman, that this bill be indefinitely postponed.

The Chair recognizes the gentleman from Lewiston, Mr. Malenfant.

Mr. MALENFANT: Mr. Speaker, I am very much against this bill. The stools in the taverns are going to keep the drunk there longer. The way it is now as soon as they begin to feel pretty good, they go home. If this bill goes through they will stay there until they fall asleep and fall off the stool.

The SPEAKER: The Chair recognizes the gentleman from Bowdoinham, Mr. Curtis.

Mr. CURTIS: Mr. Speaker, Ladies and Gentlemen: I can see no use—benefits to be gained by putting stools in these taverns. In fact, if you remember when we adopted — legalized the sale of alcoholic beverages in the United States, we were promised that we would have no more things like that. In Maine, when we finally did away with prohibition, they said that we would never have anv more of those old taverns where people sit around in half a stupor and - as the gentleman from Lewiston has said-and probably go to sleep and fall off the stools before someone takes them home. So I think the indefinite postponement of this thing would do everybody good and nobody any harm. And I think it would do the people good who go there to have alcoholic drinks; in other words, they would stand up and as they commence to feel wobbly on their feet they could start and go home rather than sit down and fall off the stool eventually.

The SPEAKER: The Chair recognizes the gentleman from Lubec, Mr. Pike.

Mr. PIKE: Mr. Speaker, never having been in one of these taverns, I would yield to the broad experience recently related by those who apparently know all about them. However, it does seem to me sort of silly that in the so-called beer parlors where people of both sexes and all ages over twenty-one are forbidden to stand up, do have to sit down with the terrific results that we have just had related to us, that it is sort of queer that in a place for men only a man is forbidden to stand up and cannot sit down. Now as I say, I am quite inexperienced in these matters, but it does seem a contradiction in terms.

The SPEAKER: Is the House ready for the question? The question before the House is the motion of the gentleman from Norway, Mr. Chapman, that Bill "An Act Permitting Bars in Taverns" be indefinitely postponed. A division has been requested.

All those in favor of the indefinite postponement of this bill please rise and remain standing until the monitors have made and returned the count.

A division of the House was had.

Fifty-six having voted in the affirmative and sixty having voted in the negative, the motion did not prevail.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Berry.

Mr. BERRY: Mr. Speaker, I noted that we had members who

did not vote, do they have a legitimate excuse?

The SPEAKER: The Chair would like to mention that everyone is requested to vote.

requested to vote. Thereupon, the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

Mr. Baxter of Pittsfield was granted unanimous consent to address the House briefly.

Mr. BAXTER: You will notice on your notices that have been passed around that Harold Grimes, who has worked here for thirtyfive years as a fireman and whom I am sure quite a few of you know, died yesterday on the job of a heart attack. A collection has been provided for in the Clerk's office and I am sure that any little thing that anyone would like to leave would be much appreciated by his family.

The SPEAKER: We are on unassigned matters at this time. If there are any bills you wish to take off the unassigned calendar, this is the time to do it.

Mr. Crockett of Freeport was granted unanimous consent to address the House briefly.

Mr. CROCKETT: Mr. Speaker, our colleague, Mr. Anderson, the gentleman from Greenville, called me about ten o'clock from Portland, and asked me if I would present an Order for him, so I therefore, now, ask out of order to present the following Order and move its passage.

Pending — Acceptance of Either Report.

On further motion of the same gentleman, the Majority "Ought not to pass" Report was accepted in concurrence.

On motion of Mr. Kennedy of Milbridge, the House voted to take from the table the eleventh tabled and unassigned matter:

Bill "An Act Regulating Vaccine Dealers and Distributors." (H. P. 956) (L. D. 1323)

Tabled — March 7, by Mr. Kennedy of Milbridge.

Pending — Passage to be Engrossed.

Mr. Kennedy of Milbridge offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to H. P. 956, L. D. 1323, Bill, "An Act Regulating Vaccine Dealers and Distributors."

Amend said Bill in the 3rd line by striking out the following underlined numeral "3" and inserting in place thereof the following underlined numeral "4".

Further amend said Bill by striking out the single quotation mark at the end and inserting the following underlined paragraph:

"This section shall not apply to registered pharmacies."

House Amendment "A" was adopted, the Bill passed to be engrossed as amended by House Amendment "A" in non-concurrence and sent up for concurrence.

Mr. Hinds of South Portland was granted unanimous consent to briefly address the House.

Mr. HINDS: Mr. Speaker, Ladies and Gentlemen of the House:

For the House's information on action taken earlier today in the House, that I stood up here onwhat I would like to say to the House is this, this committee reported this bill out "Ought to pass" and a number of the members of this committee were not notified of this meeting or not notified of this action of the committee, in fact I found five House members who knew nothing of this action until it was brought up here this morning. And I would — that was my reason for standing up and no other. I do think that members of the committee should be consulted before a bill that has been recommitted by this body is brought out before it again.

On motion of Mr. Johnson of Smithfield, the House voted to take from the table the twelfth tabled and unassigned matter:

An Act Revising the Law on Tax on Transient Rentals. (H. P. 551) (L. D. 748)

Tabled — March 7, by Mr. Johnson of Smithfield.

Pending — Passage to be Enacted.

The SPEAKER: The Chair recognizes the gentleman from Smithfield, Mr. Johnson.

JOHNSON: Mr. Mr. Speaker, using the words of the gentleman from Pittsfield, Mr. Baxter, inasmuch as this bill has come this far, and it has been studied and thought out and hashed over, it is not my intent to stand in its way from becoming enacted. I would like to point two things out in this bill: number 1, it removes the tax on those that stay in hotels and so forth up to ninety days, and reduces it to twenty-eight days, which is palatable to the larger operators of transient resorts, hotels and so forth. However, what it does do is it now removes the three or less apartments that are generally run by people who have not a great many dollars in the business. To my way of thinking, we are now compounding a four tax law; however, as I have said it is not my intent to stand in the way of this bill, and I now move that it be passed on to be enacted.

(Off Record Remarks)

Emergency Measure

An Act Revising the Law on Tax on Transient Rentals (H. P. 551) (L. D. 748)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a twothirds vote of all the members elected to the House being necessary, a division was had. 96 voted in favor of same and 18 against, and accordingly the Bill failed of enactment.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I move a roll call vote, and I move that my motion be tabled until Wednesday next.

Wednesday next. The SPEAKER: A request for a roll call cannot be tabled. A request for a roll call would be in order at this time. Does the gentleman request a roll call at this time?

Mr. JALBERT: I move that we reconsider our action whereby this measure failed of two-thirds passage, and I move that motion be tabled until Wednesday next.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, moves that the House reconsider its action whereby it failed to pass this bill to be enacted and that the motion to be reconsidered be tabled until Wednesday next.

The Chair recognizes the gentleman from Pittsfield, Mr. Baxter.

Mr. BAXTER: Mr. Speaker, as House Chairman of Taxation, I move a division.

The SPEAKER: A division on the tabling motion has been requested.

All those in favor of the motion to reconsider and that that motion be tabled, please rise and remain standing until the monitors have made and returned their count.

A division of the House was had. One hundred six having voted in the affirmative and seven having voted in the negative, the tabling motion prevailed.

The SPEAKER: We are proceeding under unfinished business.

The Chair would like to call to your attention the progress made in the past week. I know that at this particular time being the end of the eleventh legislative week, you are wondering whether or not our acceleration has slowed down or not, and the answer to that question is that the acceleration has not slowed down. And I will point that out to you in a moment.

that out to you in a moment. At the end of the eleventh week the committees had reported out 540 items, they had done that in the 99th Legislature — 540 items. At the end of the eleventh week in the 100th Legislature, we have reported out 739 items. In other words we have reported out 199 more items at the end of this week than had been done two years ago. And we had a gain of over last year in the one week of 16 items reported out.

Now the progress of this Legislature from now on will depend to a great extent on the number of bills being reported out of committee. As far as the legislative sessions are concerned, we are up to the chalk line. We have cleaned up all of our unfinished business, and all of our assigned matters. We do have a sizeable unassigned calendar, but it is not too bad. We hope that it does not get any larger. But as far as the Legislative sessions are concerned, we are up to the chalk line. If we are to extend beyond the chalk line, it will have to be through the committees reporting out more bills.

I am also conscious, however, that the committees are so busy that I know a lot of the members do not even have time to eat. So I feel that you are progressing as rapidly as possible. However, I do wish to say that if we are to progress any faster and our entire progression is going to depend upon the work of the committees.
