Monday, November 27, 1961

This being the day designated in the proclamation of the Governor for the meeting of the One-Hundredth Legislature in extra session, the members of the House of Representatives assembled in their hall at four o'clock in the afternoon and were called to order by the Speaker.

Prayer was offered by the Rev. Mr. Alton E. Maxell of Augusta. The members stood at attention during the playing of the National Anthem.

The following Proclamation:

STATE OF MAINE PROCLAMATION BY THE GOVERNOR

WHEREAS, it appears advisable that the Legislature of this State should meet in special session for

the following purposes:
To consider legislation for the appropriation of funds for the educa-

tional foundation program;

To consider legislation to revise Chapter 81 of the Resolves of 1961 entitled, "Resolve, to Apportion One Hundred and Fifty-one Representatives Among the Several Counties, Cities, Towns, Plantations and Classes in the State of Maine";

To consider legislation to provide for the entitles of provide the constitution of the con

for the creation of an educational television network in the State of Maine:

To consider any other legislation to promote the general welfare of the State.

NOW, THEREFORE, I, JOHN H. REED, Governor of the State of Maine, by virtue of the power vested in me as Governor, convene the Legislature of this State, hereby requiring the Senators and Representatives to assemble in their respective chambers at the Capitol at Augusta on Monday, the twenty-seventh day of November 1961 at four o'clock in the afternoon in order to receive such communication as may then be made to them and to consider and determine on such measures as in their judgment will best promote the welfare of the State.

The Proclamation was read by the Clerk and ordered placed on file.

The Clerk thereupon called the roll of the House. 143 members answered to their names and accordingly a quorum was found to be present.

There were eight absentees.

ORDERED, that a Committee of seven be appointed to wait upon His Excellency, the Governor, and inform him that a quorum of the House of Representatives is assembled in the hall of the House for the consideration of such business as may come before the House.

In compliance with Section 1 of Chapter 10 of the Revised Statutes, I hereby certify that special elections were held on October 10, 1961 for the purpose of filling vacancies in the following Representative Districts:

A special election was held in the Town of Fort Fairfield for the purpose of filling a vacancy caused by the death of Harold H. Hopkinson. The vote was duly canvassed by the Governor and Council and John F. Averill of Fort Fairfield received 417 votes; Louis E. Ayoob of Fort Fairfield received 439 votes; and Louis E. Ayoob, having received a plurality of the votes cast, appears to have been elected.

A special election was held in the Towns of North Yarmouth and Yarmouth for the purpose of filling a vacancy caused by the resignation of Minnie E. C. Knapp of Yarmouth. The vote was duly canvassed by the Governor and Council and Frank S. Rand of Yarmouth received 358 votes; Herbert L. Donaldson of Yarmouth received 165 votes; and Frank S. Rand, having received a plurality of the votes cast, appears to have been elected.

Subsequently Mr. Prince reported that the Committee had attended to the duty to which it was assigned.

The SPEAKER: The Chair makes the following committee assignment: to the House Committee on Elections, the gentleman from Bangor, Mr. Minsky.

The SPEAKER: The Chair will announce at this time that since this is a special session and we wish to expedite the business of the session as speedily and efficiently as possible, the Chair will not entertain a motion for unanimous consent to briefly address the House until the Speaker has been appraised of the matter prior to the request. Now the purpose for this is so that the Speaker can arrange these talks at the most advantageous time for the transaction of business.

At this time, a message was received from the Senate, borne by its Secretary, proposing a Joint Convention to be held forthwith in the Hall of the House of Representatives for the purpose of listening to an address by His Excellency, Honorable John H. Reed, Governor of Maine.

The Clerk was charged with and conveyed a message to the Senate informing that body that the House concurred in the proposal for a Joint Convention.

The Clerk subsequently reported that he had delivered the message with which he was charged.

House at Ease

The Senate then entered the Hall of the House and a Joint Convention was formed.

Subsequently, Mr. Erwin for the Committee reported that the Committee had discharged the duty assigned to it, and that the Governor was pleased to say that he would attend forthwith.

Thereupon, the Honorable John H. Reed, Governor, announced by Major General Edwin W. Heywood, Adjutant General, and accompanied by the Executive Council and Paul A. MacDonald, Secretary of State, entered the Hall of the House of Representatives amid prolonged applause, the audience rising.

Governor Reed then addressed the Convention as follows: Mr. President, and Members of the 100th Legislature.

It is my privilege this afternoon to welcome you back to Augusta for the purpose of considering matters which are of serious importance to the people of Maine.

As you are well aware, it is the prerogative of the Governor to call the Legislature into special session if he determines legislative action is necessary on matters of an emergency nature, which cannot reasonably await the next regular session of this body.

My decision to call you back was made only after much deliberation and after consultation with our most competent legal authorities When it became apparent that certain problems I shall presently outline could not be resolved without legislative authority, I felt it was in the best interests of the people of Maine to request your action on them at this special session.

The proposals you will be asked to consider impose responsibilities upon both the Governor and the legislature; and we owe it to the citizens of Maine, whether they are directly or indirectly affected, to give these proposals that full consideration which can be given only in a legislative session.

I would respectfully state that I believe you should continually bear in mind the accepted purpose of a special session — namely, that it be limited to emergency measures.

Currently scheduled for your consideration are sixty-two matters. In addition to the three items in my official proclamation, your legislative leaders have selected fiftynine measures deemed to be of an urgent nature.

In our approach to these problems, let us not be divided by party lines or factions, but from the outset let us resolve to turn to the task at hand in a workmanlike manner and accomplish our assignment with efficiency and dispatch.

Education Foundation Allowance

The first matter I would direct your attention to is the necessity of providing funds for the educational foundation program. Your approval of Legislative Document 1206 at the regular session clearly indicated your intent concerning this measure. However, inadvertently the money was not appropriated. Fortunately the sum of \$1,-210,971 is currently anticipated for allocation to this account.

In order that our municipalities may be assured this money will be available to them when they qualify for it, I strongly recommend that one of your first acts be the passage of this bill.

Legislative Apportionment

Let us now turn to the subject of legislative apportionment.

I am absolutely certain that no member had the slightest intent of disenfranchising a single Maine voter. Again, through a human error, a number of our people were faced with that possibility.

Since this oversight can only be corrected by legislative action, I am confident you will want to rectify the situation by prompt enactment of the appropriate legislation.

Educational Television

The third matter I wish to discuss with you is educational television.

Since your adjournment in June no other state issue has evoked as much public discussion as this. I am sure that a great deal of your time here will be spent on this program.

Because I am aware that you are already familiar with the merits of this great new educational medium, I do not feel it necessary to reiterate its many advantages.

One of the most impelling reasons we should act favorably on this proposal now is the distinct possibility that one or more of the remaining very high frequency channels may become permanently assigned for commercial use. The preponderance of evidence reaching my desk indicates we do need Channel 7 in Calais as well as Channels 12 in Orono and 10 in Presque Isle, to fully implement the network.

During recent months I have been in frequent contact with the Federal Communications Commission in an attempt to save Channel 7 for educational television purposes. It is my firm opinion the time has now arrived when we must demonstrate to the Commission that we are more than passively interested in an educational television network.

I feel sure the conclusion you reach will have a definite bearing on the Commission's final decision.

A phase of educational television that concerns all of us is the overall cost, both from the standpoint of original investment and future operational expenses.

In order that we might have the most accurate cost estimate possible I appointed a ten member committee to thoroughly research the question of costs quite apart from the merits of educational television.

This group of well-qualified Maine people have done an outstanding job and I know you will want to carefully study their report.

They unanimously agreed on an estimate of \$1,400,000 for capital expenditures to establish the remainder of the Maine network. They further agreed that organizational costs would approximate \$50,000 per year.

On estimated annual operating expenses for 35 to 40 hours of televised programs per week the committee was divided. Eight members estimated \$280,000, while two believed the figure would be \$415,000 annually. These figures are exclusive of debt service.

After studying the cost reports and weighing the factors involved, I have concluded that a bond issue of \$1,500,000 to be retired in ten years, would adequately finance the original installations and other needs until the next regular legislative session.

With the adoption of this plan, and with July 1, 1962 as the date of the bond sale, \$22,500 should be appropriated from the unappropriated surplus of the General Fund to meet the interest payment for the current biennium.

Since the question of bonding must be submitted to referendum, all voters would have an opportunity to express themselves on educational television.

The implementation of an educational television network for the State of Maine will undoubtedly be one of the greatest contributions to education in our era. I stand solidly in support of this proposal and respectfully urge your favorable consideration in order that all Maine people may receive the advantages of this revolutionary new educational medium. The opportunity is now in your hands!

Status of General Fund

At this point, I feel it is appropriate to review briefly the current financial condition of the State particularly in respect to revenues. I am certain you will want to know precisely where we stand before allocating any funds.

Current Operations:

During the first four months of the current fiscal year, the actual general fund undedicated revenue has exceeded estimates by \$457,-527. This is a 2.15 percent increase over estimates. Included in this amount are agricultural stipend funds of \$150,221 as of November 15, 1961, which will be withdrawn and credited to the Department of Agriculture for distribution to those agricultural fairs qualifying for stipend moneys. Also included is an amount of \$71,129 which will be returned to the race licensees. After this deduction, the General Fund balance will be \$236,177, or a 1.11 percent increase of revenues over estimates.

The foregoing clearly indicates how close estimates are to actual receipts. What is not indicated, however, is the significant fact that three of our basic and most productive sources of revenue are showing minus balances for the four month period ending on October 30, 1961.

These three sources are the sales and use tax down \$396,290; the cigarette tax, down \$90,800; and the net profit received from liquor and beer, down \$96,959.

Obviously in view of these facts, any attempt to again increase revenue estimates would be fiscally unsound and would not meet with my favor.

Surplus:

The balance of general fund unappropriated surplus available as of June 30, 1961 is \$1,487,453. From this amount we must reserve \$450,000 to replenish the contingent account. Also a sum of \$86,500 must be reserved for the Group Life Insurance Fund. There are balances of \$80,904 in the General Fund that if allowed to lapse would bring the total balance to \$1,031,857.

It is my firm opinion that appropriations at this special session should not exceed \$1,031,000.

Urgent Major Legislation

There are a limited number of other measures I would like to comment on at this time. I have selected these because I believe they are either state-wide in na-

ture or affect large numbers of Maine people.

Municipal Sewerage Grants:

The first request is to provide additional funds for state grants to municipalities for sewage treat-

ment plants.

During the regular session you appropriated \$630,000 for this purpose. However, due to the fact an increased number of communities are in the process of, or will be constructing treatment plants it is anticipated the demands on this account will exceed the amount available. It is estimated by state officials that \$500,000 will be needed to meet our share.

Surely all of us are pleased to see substantial progress made in the orderly abatement of pollu-tion in Maine waters. In order tion in Maine waters. In order that we keep faith with our municipalities who qualify for treatment plant funds I definitely favor a sufficient appropriation to this account.

Civil Defense:

An area in which the priority of need has increased immensely since we last met is that of Civil Defense and Public Safety. aggressive forces of Communism are challenging and testing our will and strength as a nation with a determination that exceeds anything in our experience.

Our national security can be tremendously improved and present crucial gap in our defenses closed by a truly effective Civil

Defense program.

Although the Federal Government has a major function in the objective of adequate Civil Defense for every American, nevertheless, it is evident federal officials are looking for action at the state, local and individual level.

It is abundantly clear our state must take positive action to establish a suitable emergency operating center to house state government and Civil Defense under disaster conditions.

The recommended site for this center is at Farmington State Teachers College. The proposed structure has been designed so it can eventually be converted into a foundation for a college building. It has been estimated the cost of this facility to the state will be \$193,200.

We hope it will never be needed, but we cannot risk the chance that it will not.

I strongly recommend the passage of this legislation.

Sardine Season:

The sardine packing industry which provides a major source of income to many of our coastal communities is experiencing very unsatisfactory season.

It is estimated the pack this year is approximately 30 percent of normal. Many Maine workers depend upon employment in the packing houses for their livelihood and the adverse season is working a great hardship on them. Also when our supply is exhausted Maine sardines will lose their shelf space in the markets of the nation to the foreign product and this shelf space will be difficult to regain in another year.

While there is a difference of opinion in this matter, our State Department of Sea and Shore Fisheries recommends an extension in the season. I concur with

that recommendation.

Additional Legislation

There are a number of other worthy measures dealing mostly with local problems and a few of more general interest. These items, together with those I have discussed, are included in the legislative documents the legislative leaders of both parties arranged for advance printing.

Since these are now in your possession it would not seem logical to discuss each of them in detail

this afternoon.

State Employees Pay Plan

There is one other problem to which I wish to direct your atten-

At the regular session, this legislature voted to implement certain features of the new pay plan for state employees. Because of insufficient funds, inequities have resulted affecting a large number of our deserving state workers.

I am certain we all agree our loyal state employees should be adequately and fairly compensated for their services.

I urge your cooperation in resolving this matter by appropriate legislative action.

Since this message was printed, a solution to the problem has been developed. This will be presented to you in the form of a joint order stating that it is your intent that the matter be accomplished by appropriate legislative action. I recommend your approval of this joint order.

Conclusion

It is my sincere hope you will find it possible to limit legislation to measures of a genuine urgent nature and refrain from introducing proposals which, while desirable, can await a regular session.

If we can quickly agree on the problems outlined, provide the funds and adjourn, the best interests of the public will have been served.

We have just had the privilege once again of observing Thanksgiving, one of our most beloved holidays.

Soon we will be busy with the activities of the Christmas season when the spirit of "peace on earth, good will toward men" prevails

I urge you to allow this spirit to permeate this session, forget personal differences, forget party lines and work together to prove to our citizens that we are here to serve the welfare of our state and for no other reason.

By adopting this attitude you can accomplish the task before you in a limited time and return to your homes knowing you have faced responsibility and completed the job in a satisfactory manner.

At the conclusion of the address, the Governor and his suite retired, amid applause of the Convention, the audience rising.

The purpose for which the Convention was assembled having been accomplished, the Convention was dissolved, and the Senate retired to the Senate Chamber.

In the House

The House was called to order by the Speaker.

The SPEAKER: The Chair at this time will assign the gentle-

man from Yarmouth, Mr. Rand, to seat number 90 and the gentleman from Fort Fairfield, Mr. Ayoob, to seat 105.

The Chair will also make committee assignments to these gentlemen: the gentleman form Yarmouth, Mr. Rand, to the Committee on Health and Institutional Services, and the gentleman from Fort Fairfield, Mr. Ayoob, to the Committee on Agriculture, the eighth ranking position; Mr. Rand had the ninth ranking position.

Also the Chair will assign the gentleman from Greenville, Mr. Anderson, to a vacancy on the Committee on Legal Affairs, to the eighth ranking position.

And on behalf of the 100th Legislature, the Chair extends to the gentleman from Yarmouth, Mr. Rand, and to the gentleman from Fort Fairfield, Mr. Ayoob, our most hearty and cordial welcome; and we hope that you will be very successful in your duties as legislators to the 100th Legislature. (Applause)

Paper From the Senate

From the Senate:

The following Order:

ORDERED, the House concurring, that unless received by unanimous consent in both branches, the only bills and resolves to be considered at this Special Session, shall be those designated Legislative Documents Nos. 1640 to 1701, inclusive.

This order shall not apply to such bills or resolves as are intended only to facilitate the business of the Special Session (S. P. 621)

Came from the Senate read and passed.

In the House, the Order was read.

Chair SPEAKER: The The recognizes the gentleman from Madison, Mr. Fogg.

Mr. FOGG: Mr. Speaker, I want to go on record as being opposed to this order for the reason that in our screening committee I think that there were some bills that were screened out which were as important as some of the bills which were put in, and I think there might possibly be other things which have arisen. I think this setting a cloture on this right now is premature. Furthermore. I would like to point out that we do have two new legislators in this body who have not been in a position to introduce any bills up until today, and I feel that by passing a cloture order at this time, we will be excluding them from any right to introduce any bills, and I don't feel that we should leave out those municipalities which they represent. that reason, I would like to go on record as being opposed to this order, and I ask for a division.

The SPEAKER: The Chair recognizes the gentleman from Pittsfield, Mr. Baxter.

Mr. BAXTER: Mr. Speaker, I would like to go on record as favoring the passage of this order. The remarks of the gentleman from Madison, Mr. Fogg, seem to me a little bit odd in view of the fact that the procedure under which the admission of bills was carried out was the procedure which was carried out during the administration of a Democratic Governor of the State, Governor Clauson, at the time of the last legislative session, special session. It seemed to work very well for that Governor. As a matter of fact. Governor Clauson, as I understand it, actually sat in on the screening committee hearing at the time that it was held prior to the last special session.

It seems to me that this is quite obviously a political gesture. have talked with members of the minority party and I know that they are just as anxious, many of them, to carry out the work of this session promptly and finish it and get home as are the members of the Republican Party. However, it does seem as though they need to go on record for some reason as opposing this cloture order at this time. This of course to me boils down again to a fact which I think we see constantly shown, and that is that the majority party must be responsible to the voters of the state for the cost of this session and for the length of the session. The minority party obviously does not feel responsible in that respect. The minority party knows that it cannot enforce by its vote the carrying of this cloture order and therefore it knows that it will not have to live with it in the future.

As far as the new members are concerned, and as far as their constituencies are concerned, I am sure that everybody realizes that there are Senators in every county and that these Senators could very nicely put in legislation for any one of the towns which may not have had a representative at that particular time. Therefore, Mr. Speaker and ladies and gentlemen of the House, I hope that this order does receive passage.

The SPEAKER: The Chair recognizes the gentleman from Old Orchard Beach, Mr. Plante.

Mr. PLANTE: Mr. Speaker, I think that the record should be The circumstances set straight. which evolved concerned this ad hoc Committee which the gentleman from Pittsfield referred to were quite different than they were at the time that Governor Clauson presided over a similar session. I was a member of that same committee as I was this time. ever, the circumstances which I state are different was that that particular session was not a rump session as this one was. There was no stacked deck. In other words. Governor Clauson made no public afferences to the fact that he would have a hands-off and that it would be entirely within the hands of the legislative leaders in what would be introduced. However, the circumstances here are different. The well-known secret session held in the Blaine House on Friday changed the circumstances and this is why that we felt that having had a stacked deck and having people come in purely for no real reason when decisions had already been made. we felt that the circumstances warrant our position today.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I would like to commend the remarks of our Floor Leader, Mr. Fogg and the Assistant Floor Leader, Mr. Plante. I also would like to set the record straight.

It seems odd as to who is talking about who is playing what type of politics and when. Just before we convened after your Republican caucus I had three members of the Press who came to me to tell me that the Floor Leader of the Republican Party expounded as usual with both feet in the mud to the effect that the Democrats' only aim was to be obstructionists and also one Jalbert would join that Twenty minutes later we parade. convened and our Governor comes in of this same body and same political faith, and quoting him, "let us remember this spirit of peace on earth and good will to all men." Ten minutes later the same Floor Leader of the same Republican Party bounces right back and just because we merely object to a cloture rule, a cloture order, without mentioning party politics, again we are playing picayune petty politics. Now on a low level or a high level if the Republican Floor Leader wants to have his toast browned up, I assure you that we can accommodate him. We are also aware of the fact that it costs money for us to be here. The reason that we are here is because of a comedy of errors at the regular session. The reason that we are here basically is L. D. 1206, when I stated from this very seat that the money was not in the bill. The reason we are here is because certain leaders of the Republican Party would not show the Secretary of State of their own will, of their own party, the reapportion bill. The reason we are here is because we did not appropriate enough money to effectuate the second year for the said salaries of the state employees and so on and so on and so on.

Now let us start out right here and now. As far as I am concerned, you can roll out your steamroller, vote any way you want to. I am here representing my people from Lewiston, I am a member of the Democratic Party. I intend to remain as such. I am going to give my opinion as honestly as I can, and if I am accused of playing politics, of course I am. I'm in no cribbage game here.

The SPEAKER: The Chair understands that the question before the House is the motion of the gentleman from Pittsfield, Mr. Baxter, that this Order receive passage in concurrence and the gentleman from Madison, Mr. Fogg, has requested a division. All those in favor of the passage of this order, please rise and remain standing until the monitors have made and returned their count.
