The PRESIDENT: For the information of the Senator from Kennebec, Senator Marden, the Chair will state that this pamphlet put out by the League of Women Voters is very educational, and that we have children coming here from high schools repeatedly. I think also that the new legislators will enjoy reading it. I believe that the cost is very small.

Mr. MARDEN: Would it be less than fifty cents a copy?

The PRESIDENT: Oh yes, five cents or a penny a copy.

Thereupon the order received passage.

ORDERED, the House concurring, that there be paid to the officers of the Senate and House of Representatives as advances on account of compensation, amounts included in fortnightly lists, certified to the State Controller by the Secretary of the Senate and the Clerk of the House, respectively, and that the final payrolls of such officers at the end of the session bear the approval of the Joint Standing Committee on Appropriations and Financial Affairs. (S. P. 85)
