Tuesday, January 24, 1961

Senate called to order by the President.

Mr. EDGAR of Hancock: Mr. President, with regard to Item No. 1-22, Bill "An Act Relating to Ferry Services for Long Island Plantation" (H. P. 304) (L. D. 465) four years ago when the various island ferry services were created the island of Long Island Plantation was not included and general funds were provided for the operation of the other ferry services under the supervision of the Maine Port Authority. Two years ago, as a result of popular referendum, the Maine Port Authority was given the authority to operate a ferry service to Long Island Plantation along with the other ferries but no money was made available to carry this out. In the last session of the Legislature the Appropriations Committee provided \$10,000 to finance a study and survey by the Maine Port Authority to determine the feasibility of ferry service to Long Island. The Legislature now has the results of that study and survey which does state definitely that ferry service to Long Island is desirable and necessary.

The purpose of this bill is to provide the funds by which the Maine Port Authority can carry out the results of this survey and study and the money to underwrite the expenses will be included in the general fund appropriation for the Maine Port Authority along with

the expenses of the existing island ferries.

In view of the fact that the Appropriations Committee in granting the moneys for the survey acquainted themselves quite thoroughly with the situation in connection with ferry service to Long Island, this seems to me to be definitely a matter to be referred to the Committee on Appropriations and Financial Affairs rather than Highways.

I might also state that I have conferred with the Senate Chairman of both Highways and Appropriations and they are in agreement on this. So I now move that Item No. 1-22 Bill "An Act Relating to Ferry Services for Long Island Plantation" be referred to the Committee on Appropriations and Financial Affairs in non-concurrence.
