Thursday, February 9, 1961

Senate called to order by the President.

Prayer by Rev. Alice T. Hart of Hallowell.

The PRESIDENT: Now comes a signal honor as we welcome one of Maine's more glamorous and beautiful products in promotion of one of our strongest economic assets. I refer to Maine's Potato Blossom Queen, who comes here to call attention to the Sixth Annual Maine Potato Week. Miss Carol Ivey, crowned queen last July at Fort Fairfield's annual Potato Blossom Festival, is a student at our University of Maine, and we are not only pleased, but ex-tremely fortunate to have the good luck to welcome her to the Senate Chamber. Let us honor Miss Carol Ivey, Maine Potato Blossom Queen.

Thereupon, Miss Carol Ivey was escorted to the rostrum by the Senator from Aroostook, Senator Edmunds amid the applause of the Senate, the members rising. Miss Ivey addressed the Senate as follows:

Miss CAROL IVEY: Mr. President, ladies and gentlemen of the Senate: Thank you very much for giving me the opportunity to be presented here today. If you do not mind, I would like to dispense with formalities and be the daughter of an Aroostook County potato farmer today and say, "Shucks, I sure am glad I am here." But, seriously, I am deeply honored in

holding this position which I do in representing Maine's great potato industry. I find it to be a thrilling and an educational experience, especially this last week of Maine Potato Week which began February 2nd, with several appearances in Bangor and Augusta, and then coming here today. Tonight I am leaving for Quebec City and next month I will be going out of state to Providence, Springfield, Hartford and Boston.

Now, in keeping with the occasion and since I know you must be tired of speeches all day long, I would like to present you, Mr. President, with a pie - and don't any of you dare ask what kind of pie. Mr. President, would you accept this potato pie with the compliments of the Maine Potato

Industry?

The PRESIDENT: I am sure they would like it. We have a little note here that this Maine Potato Pie was supplied by Representative Marguerite Smith of Falmouth from a prize winning recipe. Maine Potato Week is co-sponsored by the Maine Potato Commission, the Maine Department of Agriculture and all growers and handlers of this most important product, and this recipe is a part of the observance now going on — February 2-11, ten days devoted to the Maine potato. I understand that this is really quite a pie. Am I right, Miss Ivey?

Miss IVEY: It certainly is.

At this point, Miss Carol Ivey, Maine Potato Blossom Queen was escorted from the Senate Chambers by the Senator from Aroostook, Senator Edmunds.

The PRESIDENT: The Senator from Penobscot, Senator Stanley is temporarily a bachelor so I am going to give the pie to him and will ask the pages to present it to Senator Stanley of Penobscot.

Mr. STANLEY of Penobscot: Mr. President, I would be very glad to share the pie with any member of the Senate, or any guests. I would like to congratulate Aroostook County for their fine selection of a Maine Potato Blossom Queen. I think she did an excellent job and will certainly present to the nation the type of people that we are in the State of Maine.

Mr. EDMUNDS of Aroostook: Mr. President, I might say, speaking for Senator Christie, Senator Cyr and myself, that we have always been proud to be from Aroostook but today we are doubly proud.

Mr. MARDEN: Mr. President, I move that this matter be referred to the Committee on Judiciary, and in so doing, I think I have the approval of Senator Christie, Senator Stanley and Senator Noves.

The motion prevailed and the bill was so referred.

The President laid before the Senate the second tabled and today assigned item, (S. P. 92) (L. from Hancock, Senator Brown. Mr. BROWN of Hancock: Mr. President, due to the fact that this bill has many legal technicalities in it, I move that it be referred to the Committee on Legal Affairs in non-concurrence.

The motion prevailed and the bill was so referred.

On motion by Mr. Marden of Kennebec, the Senate voted to take from the table (S. P. 103) (L. D. 248) Senate Report from the Committee on Business Legislation on Bill, "An Act Changing Name of Portland Symphony Orchestra to Maine Symphony Orchestra." and that it "Ought to pass," which was tabled on February 2 by that Senator pending acceptance of report.

Mr. MARDEN of Kennebec: Mr. President, I am embarrassed to take the time of the Senate on such an innocuous piece of legislation; it is truly a tempest in a teapot, but there is a principle involved which I would like to discuss in connection with my moving that this honorable body vote to indefinitely postpone this legislation.

There is a symphony orchestra in Waterville called the Colby Com-munity Symphony Orchestra. There is one in Bangor, and of course there is one in Portland. Dr. Strider, the President of Colby College, happens to be a director of the Portland Symphony Orchestra. Dr. Strider is opposed to this legislation. It is my understanding that the people who are interested in the same musical field in Bangor are likewise opposed. Truly, the committee reported this out unanimously "Ought to pass," but I think my friend, Senator Porteous, would say in all fairness that there was a misunderstanding with the opposition, so to speak, as to whether or not in fact any hearing was going to be held that day, because I think my friend, Senator Porteous, was surprised to learn that there was opposition.

My position, seriously, is that it is not good legislation. Colby and Waterville are not jealous because they did not think of it first. We are the Colby Community phony Orchestra because the orchestra members are composed of Colby students and members of the community of Waterville. The Portland Symphony Orchestra, presumably, is named that because it is the Portland Symphony Orchestra: it is not the Maine Symphony Orchestra. But the principle involved is a little more serious than that: there is a tendency, I think, that once we achieve something named "Maine" this "Maine" that, for the general public to have the feeling that it is then an official body of the State; and not at this session or the next session, perhaps, but at a session six or eight years from now when they need to buy a new cello or an oboe they will be down to the legislature asking for the money. This does not seem quite fair to the housewives who go from door to door in Bangor and Waterville, trying to raise funds to buy their cellos and oboes.

So with an apology again to this honorable group for taking your time on such a small measure, I will really incur the wrath of my friend, Senator Porteous, by saying that I want to be in harmony with him, I hope we will make beautiful music together, and we must stay in tune with the times, but let's have no discord. I therefore move indefinite postponement of the bill and ask for a division.

Mr. PORTEOUS of Portland: Mr. President, having never heard my fellow senator sing, I am not sure I can get in harmony with him, but I would like to set the record straight as to why I put this bill in, however innocuous it may be termed.

I was asked by the Symphony people in Portland and told by them that they had contacted the Bangor people and the Waterville people and that there was no objection. It is true that the day of the hearing it was uncertain in the mind of the Senator from Kennebec, Senator Marden, that the hearing might be postponed on this particular bill.

Just for the record, I would like to state that the purposes for which the name-change was designed I believe are sound ones, I think they would promote the State of Maine and not just the City of Portland. The Portland Symphony Orchestra is a full-size symphony orchestra, completely instrumented to play a wide range, the fullest range of selections that symphony orchestras normally play.

Aroostook has its potato and the Portland Symphony Orchestra is growing as fast as the Aroostook potato, and we in Portland believe that through changing the name to the Maine Symphony Orchestra we will have more recognition throughout the country that it is our symphony rather than a Portland, Oregon symphony. Also, very few people in Portland play in it, but most of the people come from outside. I believe four people appeared for this bill at the hearing and none of them were from inside the confines of the City of Portland. There has been no intention, stated or implied, to go to the State for funds. We go from door to door for funds with which to buy our instruments; we pay one of the top conductors anywhere in the country, Rauben Gregorian as our conductor. Our symphony orchestra is a very serious project and one that I think the entire State of Maine can be proud of.

There is no problem in Bangor, because there is no other Bangor that I know of; there is no problem in Colby, because there is no other Colby I know of, but there is another Portland and it is a larger Portland, and many times when Portland is listed in national advertising it is usually listed as Portland, Maine, and if it is only "Portland" that means Portland, Oregon.

Now fellow colleagues, we are trying to promote the State of Maine, and this symphony orchestra can speak well for the culture that has been achieved here.

Going back to the funds, I might say that our budget went up from \$5000 two years ago to \$30,030 this last year, and we are raising that through contributions from individuals and business firms.

I am sorry in the first place that there has been some misunderstanding, but I assure you that it was not my fault that there was any misunderstanding — it seems to have been from both ends, from the symphony in Portland as well as those in Bangor and Waterville. I do apologize for taking up your time, because I do not think that the Board of Directors of the Portland Symphony Orchestra would have proposed this and would have asked to introduce it as a change in their name unless they had seriously considered it as being best for them and best for the State of Maine.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Kennebec, Senator Marden, that Bill, "An Act Changing Name of Portland Symphony Orchestra to Maine Symphony Orchestra" be indefinitely postponed. Is the Senate ready for the question?

Mr. CHASE of Lincoln: Mr. President and fellow Senators: Defend-

ing the committee's report: the committee felt that due to the fact that there are many organizations in Maine called "Maine," like "Maine Hardware", "Maine Trust & Banking Company" and many, many others, that the Portland was the first symphony orchestra to ask and we should give them our support. Had the Bangor Symphony Orchestra appeared first, I feel that the committee would have given them the same support. Thank you.

STANLEY of Penobscot: Mr. President, in regard to this particular bill, I would hope that the people of Portland would capitalize on the fact that there is a bigger city by the name of Portland on the west coast, because they can get lots of publicity from that with no expense. If they change their name to the Maine Symphony Orchestra they would lose that advantage. We do not feel bad about the fact that Portland was here first. We have had tremendous publicity for the City of Bangor by our cwn efforts in our 125th Anniversary Celebration of a year long. I would certainly support the argument of my friend from Kennebec, Senator Marden, about indefinitely postponing this bill, and perhaps we could play "The Flight of the Bumblebee" at the same time.

BROWN of Hancock: Mr. President, I think that the Business Legislation Committee felt that there are many businesses and firms using the name "Maine" in their title. I think they also felt that this was on a first-come first-served basis, and where the Portland Symphony was the first to apply for the name that the committee should go along with the bill. The committee could not find any objective criticism whereby there would be harm in allowing the Portland Symphony to use the name "Maine" in their title and I hope the motion to indefinitely postpone does not prevail.

Mr. BROOKS of Cumberland: Mr. President and my colleagues of the Senate: I rise without too much knowledge of symphony orchestras or music as a whole. With due respect to my friends from

Waterville and Bangor, I would like to say that there have been precedents set in other states where names of city symphonies have been changed to the name of the state, obviously to enhance the prestige of the particular state. I would name a few: Virginia, Vermont, Rhode Island and Connecticut. I must support with great enthusiasm my colleague from Cumberland County.

Mr. MARDEN of Kennebec: Mr. President, I have just received a note concerning this grave issue, and the note says this:

'This bill was not cleared with

the boys,'

Said Marden with a great deal of noise.

The musicians of Maine have a right to complain

If you limit their symphonic joys."
(Laughter)

The PRESIDENT: The question before the Senate is on the motion of the Senator from Kennebec, Senator Marden, that the bill be indefinitely postponed. A division has been requested.

A division of the Senate was had. Mr. STANLEY of Penobscot: Mr. President, I would like to change my vote if I may.

The PRESIDENT: The vote has not been announced and you may change if you wish.

Mr. STANLEY: Mr. President, I would change my vote from indefinite postponement to acceptance of the Committee report.

Mr. MAYO of Sagadahoc: Mr. President, I had no intention of getting into this debate but I have been informed by my good friend, Senator Porteous of Cumberland that there are many people from Bath who play in this Symphony Orchestra. I will change my vote and vote for acceptance of the report.

A division of the Senate was had. The PRESIDENT: The Secretary has informed the Chair that some Senator has not voted. The Chair will again ask for a division.

Mr. STANLEY of Penobscot: Mr. President, I probably have set a record voting in favor of this bill, against it and neutral. I wish to record myself as being against indefinite postponement.

A division of the Senate was had. Thirteen having voted in the affirmative and seventeen opposed, the motion to indefinitely postpone did not prevail.

Thereupon, on motion by Mr. Porteous of Cumberland, the Ought to pass report of the committee

was accepted, the bill read once and tomorrow assigned for second reading.

On motion by Mr. Noyes of Franklin

Adjourned until Tuesday next at ten o'clock in the morning.
