Comes from the House, Indefinitely postponed.

Mr. MAYO of Sagadahoc: Mr. President and members of the Senate: In regard to this L. D. 1264 which comes from the House Indefinitely Postponed, I will say that in our executive session regarding this bill we decided that the original bill was not properly worded and so we came out with a new draft. At the time we came out with the new draft there were nine members of my committee present, and at that time we discussed the new draft and we had a unanimous "Ought to pass" report on the new draft.

By way of explanation of what this bill does: we now have on our statutes laws regarding the employment of minors under 18. All this bill in the new draft will do is to add three categories to the already existing categories of places where minors under 18 are not allowed to work. I should not say "are not allowed to work"; they are allowed to work under certain restrictions. Now what this bill adds is construction projects, tree surgery and public utilities. I have had no objections to this

redraft of the bill since it came out. The gentleman of the House, Mr. Hardy, was a member of my committee who voted to indefinitely postpone this bill. I talked to him this morning and he said he had had a few letters from private utility companies, namely telephone companies, in his area. They ob-jected to the redraft of the bill because certain minors under 18 years of age are employed in the cleaning-up of brush. I explained to Mr. Hardy that these minors will still be able to be employed by utility companies or in tree surgery under certain conditions. If they feel they are unduly burdened they have the right to appeal under the present law and have a public hearing. As I say, right now we have manufacturing, mercantile establishments, laundries, dry-cleaning establishments and bakeries, and all this bill proposes to do is to add construction projects, tree surgery and public utilities. I therefore see no reason why this Senate should not accept the unanimous committee report "Ought to pass in New Draft." I move that the Senate accept the unanimous "Ought to pass" report of the committee in non-concurrence.

Mr. EDGAR of Hancock: Mr. President, may I address a question through the Chair to the Senator from Sagadahoc, Senator Mayo?

The PRESIDENT: The Senator from Hancock, Senator Edgar, may state his question and the Senator from Sagadahoc, Senator Mayo, may answer if he chooses.

Mr. EDGAR: Mr. President, I would like to ask the Senator from Sagadahoc, Senator Mayo if there is specifically outlined anywhere in the statutes or in this bill any conditions under which minors under 18 may work in construction projects or public utilities? I have not seen any such provision, although there may be one some-

where. I would like to know if that is spelled out anywhere in the statute. If it is not, then regardless of what the Senator from Sagadahoc said about their being permitted to work, this bill forbids them working for any public utility with no conditions and no exceptions.

Mr. MAYO: Mr. President, in answer to the Senator from Hancock, Senator Edgar, I will say that I do not see it written out in this legislative document that we are discussing. I do not have in my possession at this moment the regular laws pertaining to the Commissioner of Labor, so I cannot answer his question. If there is any question regarding that, I think possibly the best thing to do would be to table this bill. I will withdraw my original therefore motion and move that the bill be tabled until the next legislative day.

The motion prevailed and the bill was tabled until the next legislative day pending acceptance of the committee report.
