SENATE

Tuesday, February 21, 1961

Senate called to order by the President.

Prayer by Rev. Royal Brown of Gardiner.

On motion by Mr. Gilbert of Kennebec,

Journal of yesterday read and approved.

The PRESIDENT: The Chair would like to mention that Reverend Brown is one of my old friends. He is a member of the Lions Club in Bangor and has been pastor of one of our churches for years. It is nice to have you with us.

We have in the Senate Chamber this morning a young man who is a cousin of the Senator from Piscataquis, Senator Parker, Douglas Stevenson from Wayne. He attends Wayne Grammar School and is in the 7th grade. The Chair would like to appoint Douglas Stevenson as Page for the day. Would Mrs. Foster please escort the young man to his seat? (Applause)

We also have in the Senate Chamber this morning a group of fifty young people and adults from Christian Citizenship Seminar of the Maine Baptist Youth Fellowship, which is being held in the Penney Memorial Church. Officers present are: Rev. Vernon Legg, Director of Youth Work for the United Baptist Convention Maine; Dr. John Thomas, Executive Secretary of the Council on Christian Social Progress of the American Baptist Convention, New York; State Chairman of Christian Citizenship, Vernon Palmer II, Caribou; Eastern Area Vice President, James Lufkin, Bangor; State Treasurer, Catherine Dunn, Gardiner; State Guild Chairman, Janice Chase, Augusta.

This group of young people visited in Washington a year or two years ago and they felt they should visit the State House and enjoy the privileges of our State House and get a little knowledge as to how State Government works. They felt they should attend sessions at the State House before they went to Washington, but they were royally received in Washington by

the Maine Delegation. I know they will have a royal reception here. It is a pleasure to have you with us. (Applause)

We also have in the Senate Chamber this morning a group from St. Peter's School, Lewiston, numbering forty young people. They are in the balcony, as I understand. They are accompanied by Brothers Leonce, Lavalle and Dacian. It is a pleasure to have you with us and we hope you enjoy your stay. We also have in the balcony the sons of one of our Senators, the Senator from Kennebec, Senator Farris, Ronald Farris and Gregory Farris. They are grandchildren of Ralph W. Farris, Sr., who was a member of the Senate in 1940-41 and the sons of the Senator I just mentioned, the present Senator from Kennebec, Senator Farris. It is a pleasure to have you with us. If you will please stand, I am sure the Senate would like to recognize you. We know that you will probably take your father's place as Senators. (Applace)
