#### SENATE

Tuesday, February 28, 1961

Senate called to order by the President.

Prayer by Rev. Alton E. Maxell of Augusta.

On motion by Mrs. Lord of Cumberland,

Journal of yesterday read and approved.

Mrs. Lord of Cumberland was granted unanimous consent to ad-

dress the Senate.

Mrs. LORD: Mr. President and Members of the Senate: I have two things I would like to do. First, I would like to tell you that this report on the new Boys Training Center is on the desks. There is a supplemental book which is quite large and quite expensive to print, and there will be a dozen copies in the Library if anyone wishes to see these books, and also in other places. I hope you will take an interest and see the amount of work that the committee did on this project.

Also I would like to ask the Senate to extend congratulations to the Cheverus High School of Portland who won the Western Maine Conference. I think these boys have worked very hard and that they will appreciate very much getting a letter from the Secretary of the Senate congratulating

them.

The PRESIDENT: Thank you, Senator Lord. Will you make that a motion.

Mrs. LORD: Yes, Mr. President. Mrs. Christie of Aroostook was granted unanimous consent to address the Senate.

Mrs. CHRISTIE: Mr. President, the Presque Isle basketball team won the Eastern Maine Tournament last Saturday night, so I would like to have the Secretary send a letter congratulating them.

Mr. Brooks of Cumberland was granted unanimous consent to address the Senate.

Mr. BROOKS: Mr. President, I also would request a letter to go to the basketball players of North Yarmouth Academy who last Saturday evening won the Western Class L Championship. This Saturday they will have the honor of meeting the high school in Portland for the Class L state championship.

Mr. Bates of Penobscot was granted unanimous consent to address the Senate.

Mr. BATES: Mr. President, continuing the spirit of the morning and hoping that it is not necessary to inform the Senate that Orono won the Class L Eastern Maine

Championship, I request a different letter of a higher congratulatory nature as compared to the other school letter be sent to the Orono High School basketball squad.

The PRESIDENT: I am sure the Secretary will attend to his duties as outlined here this morning. I think it would be wonderful to show our appreciation of the fine sportsmanship these schools have showed by giving them a good hand. (Applause)

Mr. Edgar of Hancock was granted unanimous consent to address

the Senate.

Mr. EDGAR: Mr. President, in view of the fact that our honorable President has expressed his approval of these letters being sent out, I would like to have included on the list the basketball team of Mount Desert which last Friday night in Bangor won the Class M championship.

The PRESIDENT: Not to be outdone, they will be taken care of too. I think we should also give that team a hand. (Applause)

Mr. Stilphen of Knox was granted unanimous consent to address the Senate.

Mr. STILPHEN: Mr. President, I would like to have Rockport included in that too. I believe they won the small school championship.

The PRESIDENT: I hope the Secretary is keeping a list of all these teams. I think that team should have a round of applause too. (Applause) It is nice to recognize our home teams.

The President laid before the Senate the first tabled and today assigned item, (H. P. 458) (L. D. 658) Bill, "An Act Providing an Advisory Committee for Security Dealers." tabled on February 22 by the Senator from Hancock, Senator Brown, pending adoption of House Amendment A; and on motion by that Senator, House Amendment A was adopted in concurrence and the bill was tomorrow assigned for second reading.

The President laid before the Senate the second tabled and to-day assigned item, (H. P. 50) (L. D. 91) Resolve, Loaning to City

of Hallowell the Replaced Furniture of the Executive Council Chambers, tabled on February 23, by the Senator from Franklin, Senator Noyes pending motion by Senator Mayo of Sagadahoc for final passage; and on further motion by Mr. Noyes of Franklin, the resolve was retabled and especially assigned for tomorrow morning at ten o'clock.

Mr. FARRIS of Kennebec: Mr. President and members of the Senate, this Item 21 just removed from the table has had its hearing before the Committee on Legal Affairs but Senator Porteous has pointed out that there are a number of proponents who wish to be heard on this measure and due to error they were not notified and were unable to be present on the

day the bill was heard. In the Legal Affairs Committee executive action indicated that they would be willing to have this matter returned to Legal Affairs for further hearing in order to accommodate Senator Porteous and I now move that it be recommitted for further hearing.

The motion prevailed and the bill was recommitted to the Committee on Legal Affairs.
