Mrs. CHRISTIE: Mr. President I move the acceptance of the Minority Ought to pass Report and I would like now to move that the bill be tabled.

Mr. MAYO of Sagadahoc: Mr. President and members of the This Senate: bill pertains to changing the laws of the State regarding public drinking places. The way the law is now written it allows certain drinking provided the owner of the establishment will allow it in his restaurant, for a person to have a drink in this restaurant or sporting place. The main problem as this bill is written, as I see it, is that the many sporting places we have in the north country that now have a dining room in the sporting establishment would not be permitted to allow the sportsmen in those hunting areas and fishing areas to have a so-called cocktail with their dinner or before dinner in the dining room. I am afraid if this bill is passed that it will make a terrific difference to our sporting industry and also our vacation in-dustry. Many of these people are used to having a cocktail before dinner and certain restaurants and certain hotels who do not have a regular liquor license do sanction the person bring a bottle to the table, and set-ups and ice are served.

I would certainly hope that the motion of the Senator from Aroostook, Senator Christie does not prevail and that the Senate will accept the "Ought not to pass" report in concurrence with the House action. I would ask for a division. The PRESIDENT: The Chair recognizes in the Senate Chamber one of our former Governors and Secretary of State, a man who has done much for the State of Maine. It gives me pleasure to introduce to the Senate and guests here former Governor Lewis O. Barrows of Newport, Maine. (Applause) I think he will be recognized later in the day.

Will the Governor please say a word?

Ex-Governor LEWIS O. BAR-ROWS: Thank you, Mr. President and members of the Senate. It is very gracious of you to give me this opportunity to break into your busy session.

I might say I came here this morning with some degree of nostalgia, because in 1907 I happened to be, along with the late Congressman Frank Fellows of Bangor, a page in the Maine Senate.

In looking through the supplement of the Kennebec Journal this morning I noticed one instance of which I still have a very vivid recollection. The big question of that session, as some of you may remember, was whether or not capital building should be the transferred from Augusta to Portland. Well, that particular day-I remember it quite well because one of the then Senators from Cumberland County, later to be a Democratic Governor of Maine. Senator Oakley Curtis-called me and said, "My boy, you go down into the library and you bring up an armful of the largest volumes you can find there." I did not have any idea what it was all about but I did it. He said, "Now put them right on the floor and go back and get another one, and did that. It soon became per-T fectly evident what the motive was. I am not sure whether you have a grapevine nowadays around here, but the way the Senate was in those days you could pretty near snap a line and all on the eastern side of the Kennebec River were in favor of retaining the State Capitol in Augusta and those on the west side preferred Portland. One of the reasons for that was the total inadequacy of hotel accommodations in Augusta. The Augusta House at that time did not have a wing on it; it was three stories and that is all it was. Private dwellings refused to take any more people, so it was very difficult. It was discovered on this particular day that one of the the Hon. Joseph W. Senators, Simpson of York, later the Chairman of the Republican State Committee, had taken a train to go home on Friday. Well, as soon as that happened a motion was made to pass the bill to retain the capital here. Then Senator Curtis got the floor. He opened up the largest book he could find and he started to read it from one end to the other until there was afforded an opportunity of retrieving Senator Simpson, who had taken the train to go home. They got him off the train at Gardiner and brought him back, and as soon as he walked through the Senate Chamber door Senator Curtis sat down and the bill was tabled. As a result of that, that was my first exposure to a marathon talk and there was a compromise by the people of Au-gusta to enlarge and rebuild the Augusta House much as you see it now.

Now that is a long story, but that is part of the nostalgia of coming into the Senate Chamber after many years. Secondly, if you get a copy of the 1907 Session Laws and see the make-up of the Senate and also the officers of the Senate, I think you will find I am the only one alive that was then serving as an officer of the Senate. I recognize one member of Governor Cobb's Executive Council, the Hon. W. Scott Libby of Lewiston, now alive; and I think there is one distinguished member of the Senate from Washington County that probably occupies the seat occupied by his father, so all of those things tend to increase the nostalgia.

In conclusion, I notice quite a change for the better: now you no longer employ male pages, you have distaff members serving you. I have no doubt they are probably more efficient, but I am absolutely certain they are much better looking. Thank you, Mr. President. (Applause, members rising)
