#### Orders of the Day

The President laid before the Senate the 1st tabled and today assigned item (S. P. 325) (L. D. 1000) Bill, "An Act Relating to Chiropractic Treatment Under Workmen's Compensation Law," tabled on March 21 by Senator Sampson of Somerset pending motion by Senator Edmunds of Aroostook to indefinitely postpone.

Mr. SAMPSON of Somerset: Mr. President, I move the pending question.

The PRESIDENT: The question is on the motion of Senator Edmunds of Aroostook that the bill and papers be indefinitely postponed.

Mr. FARRIS of Kennebec: Mr. President, inasmuch as I did present an amendment to this bill and inasmuch as that amendment has not yet been read into the record other than having been printed and reproduced, I would merely like to explain the purpose of the amendment.

I spoke at quite some length previously upon this measure and explained that all that the proposed bill does is to permit our chiropractors to be paid under the Workmen's Compensation Act for the chiropractic treatment which they render in accordance with the license which they hold and in accordance with the law of the State of Maine. It is a very simple issue, a very fair and equitable one and certainly worthy of passage.

Now the amendment completely clarifies any questions which anyone might have as to control in regard to the chiropractic treatment to be rendered. In other words, we insert after the words "chiropractic treatment" that this is to be performed or permitted subject to the approval of the employer. It is specifically spelled out, there can be no damage to the employer, to industry, and certainly to the public, because the public merely will be entitled to have payment made by the employer under the terms of the Workmen's Compensation Act in the event that he goes to his chiropractor as a result of an industrial accident rather than as a result of any other accident where he would be going to his own chiropractor.

I certainly, in fairness, equity and good conscience urge that the motion of the Senator from Aroostook, Senator Edmunds, to indefinitely postpone be defeated. The PRESIDENT: The question is on the motion of Senator Edmunds to indefinitely postpone, and a division has been requested.

A division of the Senate was had. Sixteen voted in the affirmative and fifteen opposed.

The PRESIDENT: In order to keep this measure open, the Chair will vote No.

Sixteen having voted in the affirmative and sixteen opposed, the motion to indefinitely postpone did not prevail.

Mr. FARRIS of Kennebec: Mr. President, I now move that this matter lie upon the table.

Mr. MAYO of Sagadahoc: Mr. President, I request a division.

A division of the Senate was had. Fifteen having voted in the affirmative and sixteen opposed, the motion to table did not prevail.

Mr. FARRIS of Kennebec: Mr. President, I now move adoption of Senate Amendment A.

The Secretary read Senate Amendment A to S. P. 325, L. D. 1000:

"Amend said bill in the 5th line by adding after the words 'chiropractic treatment' the underlined words 'subject to the approval of employer'."

Mr. EDMUNDS of Aroostook: Mr. President, I request a division when the vote is taken on the motion of Senator Farris of Kennebec.

The PRESIDENT: The question before the Senate is on the motion of Senator Farris of Kennebec to adopt Senate Amendment A.

A division of the Senate was had. Eighteen having voted in the affirmative and twelve opposed, Senate Amendment A was adopted, and the bill as amended was tomorrow assigned for second reading.

Mrs. LORD of Cumberland: Mr. President, I rise to a point of order. I believe we have not accepted the bill and it has not been read.

The PRESIDENT: The Secretary will read the endorsements.

The SECRETARY: In the Senate, on March 14, the Majority Ought to Pass report prevailed. On March 14th, the bill was read once and Senate Amendment A was presented. The bill was tabled pending adoption of Senate Amendment A. On March 21, a motion to indefinitely postpone was made by Senator Edmunds of Aroostook and the bill was tabled on March 21st by Senator Sampson of Somerset, pending the motion by Senator Edmunds.

Mr. FARRIS of Kennebec: Mr. President, is it now in order to move for second reading on this legislative day?

The PRESIDENT: The bill must now be assigned for second reading.

Thereupon, the bill was tomorrow assigned for second reading.

The President laid before the Senate the 2nd tabled and today assigned item (S. P. 3365) (L. D. 1098) Bill, "An Act Permitting Municipalities to Raise Money for Youth Programs." tabled on March 21 by Senator Wyman of Washington pending adoption and reproduction of Senate Amendment A; and on further motion by the same Senator, Senate Amendment A was read and adopted and the bill was passed to be engrossed.

Sent down for concurrence.

Mr. Gilbert of Kennebec was granted unanimous consent to address the Senate.

Mr. GILBERT: President Mr. and members of the Senate: Tt seems that back here two weeks ago every member of his respective community was introducing so-called State Champions, and today I have the pleasure of presenting a National Champion. Т <sup>-</sup>the honor of introducing have as he is known to us here in his home, the City of Augusta. Jerry has just turned 17, he is a member of our local Cony High School and is the son of Mr. and Mrs. Gerald F. Varnam

Last week he won the United National Junior Nordic States Cross Country Championship at Lake Placid, New York, against the best of competition. As you country skiing is know. cross among the most grueling of sports, requiring great stamina as well as great skill and conditioning, and Jerry has all of that.

What is particularly striking about his feat is that Jerry took up competitive skiing seriously only this winter - and, by the way, he did not own a pair of skis; he used his coach's skis - and by the end of the winter he was a national champion. He won the Maine and Eastern Junior crowns first, and then capped his record by placing first in the nationonly defeating not exals. champions of the United States but also Champion Reece of Canada.

It takes no great skill to forecast the future of Jerry as he will go into the United States Olympics.

With him is his skiing coach at Cony High, a former member of the skiing team at the University of Maine - and I am sure that Senator Brooks will like this-Graydon P. Erickson, who has spent a great deal of time with the boy. taking him from the time he started, and I am sure that Graydon Erickson is just as proud of Jerry as the people of the City of Augusta are.

It gives me great pleasure to present to you young Jerry Var-nam and his coach, Graydon P. Erickson. (Applause)

The PRESIDENT: The Chair would ask the Senator from Kennebec, Senator Gilbert, to escort Mr. Varnam to the rostrum. (Applause, members rising)

Mr. GERALD VARNAM: Mr. President, I am pleased to be here and I am glad to do what I did for the State of Maine. Thank you. (Applause)

The PRESIDENT: It certainly is nice to have a young man like Mr. Varnam representing the State of Maine. (Applause)

The Chair also notes in the Senate Chamber the presence of one of our former Senators, Senator Joseph Harvey of Biddeford. It is certainly a pleasure to have Senator Harvey with us, and I will ask the Sergeant-at-Arms to escort former Senator Harvey to the rostrum and we will give him a big hand when he comes up. (Applause)

Mr. JOSEPH HARVEY: Mr. President and members of the Senate: This is indeed an unexpected pleasure on my part. When I look back to sitting on this rostrum twenty years ago and see this fine setting that you have here now and the great group of legislators that is here. I do not know as I can recall any of them being here while I was here. I want to say that you have done a splendid job so far from what I have read, and I trust that when the session is over the people of the State of Maine will appreciate your good work and your efforts in behalf of legislation that is worth passing. (Applause)

PRESIDENT HILLMAN: Thank you for your kind words.

On motion by Mr. Stilphen of Knox, the Senate voted to take from the table the 42nd tabled and unassigned item (S. P. 400) (L. D. 1347) Bill, "An Act Revising Registration and Licensing Dog Laws." tabled on March 21 by Senator Stilphen of Knox pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed.
