Mrs. CHRISTIE: Mr. President, I ask for a division on this motion.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Aroostook, Senator Christie, that this bill be substituted for the report of the committee.

Mr. FARRIS of Kennebec: Mr. President and members of the Senate: This is the bill which was debated briefly on the previous legislative day but there are some Senators here today who were not able to be here last Friday, so again, very briefly, I wish to point out that this is a mandatory suspension of fifteen days for any licensee who sells intoxicating beverages, including the sale of beer for off-premises consumption. The legislature in their wisdom in past years have seen fit to leave this as an administrative matter and it was the feeling of the Legal Affairs Committee unanimously that this should be an administrative matter so that innocent licensees who become in violation of the law due to the forging of identification cards by minors nineteen or twenty years of age who appear to be older than twenty-one are not unjustly and harshly penalized. For that reason, I hope that the motion of the Senator from Aroostook, Senator Christie, that the bill be substituted for the "Ought not to pass" report of the committee. A division has been requested. All those in favor of the motion of the Senator from Aroostook, Senator Christie, will please stand in their places until counted.

A division was had.

6 having voted in the affirmative and 25 in the negative, the motion did not prevail.

Mr. PORTEOUS of Cumberland: Mr. President and members of the Senate: On your desks is an explanation of this. I hope that it is sufficient and that you will adopt Report A, the Ought to Pass Report.

The motion prevailed, the Ought to Pass Report A was accepted and the bill read once.

Thereupon, on motion by Mr. Ferguson of Oxford, the bill was tabled pending second reading and especially assigned for Thursday next.

The President laid before the Senate the 8th tabled and specially assigned matter (S. P. 353) (L. D. 1086) Bill, "An Act Clarifying the Liquor Laws," tabled on April 7th by the Senator from Androscoggin, Senator Couture, pending adoption of Senate Amendment "A" (Motion by Senator Christie of Aroostook)

Mr. COUTURE of Androscoggin: Mr. President and members of the Senate: In reading this amendment very carefully last week and knowing the previous bill that was passed and signed by the Governor already—the bill that has already been accepted, voted by b o t h branches and signed by the Governor—for the purpose of leaving the bill clear as it was introduced I will now move the indefinite postponement of Senate Amendment 'A".

CHRISTIE of Aroostook: Mrs. Mr. President and members of the Senate: This bill which was enacted very recently did something that is very detrimental to enforcement in our State, and, for that reason, as I said Friday, I contacted the Governor and received his permission to contact the Attorney General and try to make a correction in this situation, which I did through this amendment.

I hope the Senate will consider very carefully before they defeat this amendment because what it does is to put the State back where it was before in regard to enforcement of this law in regard to the sale of liquor in veterans' clubs and organizations. It leaves it that the veterans may bring guests in and have them served liquor but it does not permit sale to others who may come in from other veterans' organizations or auxiliaries.

brought out Someone this thought: that when women are permitted to go unattended into a private club like this the situation can become very bad. I find that the enforcement division does feel that it is a very bad situation as it is now, and it would be much worse if this bill were allowed to go through as enacted.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Androscoggin, Senator Couture, that Senate "A" Amendment be indefinitely postponed.

Mr. COUTURE of Androscoggin: Mr. President and members of the Senate: I certainly understand, as the Senator from Aroostook, Senator Christie, has explained, that this will allow members of other organizations to go in and be served, but I for one do not see any difference between one veterans' organization and the others. They just draw the line and say where the veterans can go and where they can't go. I cannot see that there is any crime or that there is anything wrong in allowing members of different veterans' organizations that hold liquor licenses to visit each other and be served in their own club. Mrs.

Christie admits they had a conference with the Governor on the matter and the Governor did not seem to have any objection in regard to it and he signed the bill. I don't know what the reason is that she wanted to correct it. It seems to me it will draw a line for the veterans. It seems to me that the veterans should be allowed to visit each other in their clubs and be served.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Androscoggin, Senator Couture, that Senate Amendment "A" be indefinitely postponed. A division has been requested.

All those in favor of the motion of the Senator from Androscoggin, Senator Couture, will rise and stand in their places until counted. A division was had.

9 having voted in the affirmative and 18 in the negative, the motion did not prevail.

Thereupon Senate Amendment "A" was adopted.

Mr. Jacques of Androscoggin presented Senate Amendment "B" and moved its adoption.

"B" Senate Amendment was read by the Secretary.

On motion by Mr. Stilphen of Knox, the bill was tabled pending the adoption of Senate Amendment "B" and specially assigned for the next legislative day.

D. 900) Bill, "An Act Relating to Penalty for First Offense for Driving Motor Vehicle Under the Influence of Intoxicating Liquor," tabled on April 7 by Senator Christie of Aroostook pending enactment; and on further motion by the same Senator, the bill was passed to be enacted.

D. 1017) Bill, "An Act to Incorporate the Domestic Finance Corporation of Kennebunk," tabled on March 15 by Senator Marden of Kennebec pending enactment; and on motion by the same Senator, the rules were suspended and the Senate voted to reconsider its former action whereby the bill was passed to be engrossed.

The same Senator presented Senate Amendment A and moved its adoption.

Senate Amendment A was adopted and the bill was passed to be engrossed in non-concurrence.

D. 1342) House Report Ought to Pass, from the Committee on Health and Institutional Services on Bill, "An Act Providing for Registration of Sanitarians," tabled on April 7 by Senator Marden of Kennebec pending acceptance of the report: and on further motion by the same Senator the report was accepted, the bill read once and tomorrow assigned for second reading.

On motion by Mr. Cyr of Aroostook, the Senate voted to take from the table the 58th tabled and unassigned item, (H. P. 488) (L. D. 688) House Report, Ought to Pass as Amended by Committee Amend-ment A from the Committee on Inland Fisheries and Game on "Resolve, Regulating Ice Fishing on Umsaskis Lake and Long Lake. Aroostook County," tabled on March 31 by Senator Cyr of Aroostook, pending acceptance of the report; and on further motion by the same Senator, the report was accepted, bill read once, Committee the Amendment A read and adopted and the bill tomorrow assigned for second reading.

On motion by Mr. Cyr of Aroostook, the Senate voted to take from the table the 59th tabled and unassigned item, (H. P. 486) (L. D. 686) House Report, Ought to Pass as amended by Committee Amendment A from the Committee on Inland Fisheries and Game on "Resolve, Regulating Ice Fishing on First Musquacook Lake and Second Musquacook Lake, Aroostook County," tabled on March 31 by Senator Cyr of Aroostook pending acceptance of the report; and on further motion by the same Senator, the report was accepted, the bill read once, Committee Amendment A read and adopted and the bill tomorrow assigned for second reading.

Mr. STILPHEN of Knox: Mr. President, through the Chair I would like to ask the Senator from Kennebec, Senator Marden, the purpose of the amendment to L. D. 1017, Bill, "An Act to Incorporate the Domestic Finance Corporation of Kennebunk," and if the title perhaps should not be amended also.

The PRESIDENT: The Senator from Knox, Senator Stilphen, asks a question through the Chair of the Senator from Kennebec, Senator Marden. The Senator from Kennebec may answer if he wishes.

Mr. MARDEN of Kennebec: Mr. President, this bill was presented not by me but in behalf of a business man in Waterville who wanted to expand an existing operation. He hoped that he might expand it by opening up a new business in Kennebunk, but in the House the gen-tleman from Kennebunk protested the opening up there of any further business of this type and therefore the House indefinitely postponed this measure. The business man from Waterville wanted the charter giving him the right to open a new operation and therefore suggested that the bill be amended to take care of a Waterville location, so the business might be opened up in Waterville instead of in Kennebunk. It is my understanding that the amendment also changes the title of the bill.

The PRESIDENT: Does that answer the Senator's question? Mr. STILPHEN: Thank you, Mr.

President.
