# HOUSE

#### Wednesday, January 23, 1963

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Christopher A. Ives of Hallowell.

The journal of yesterday was read and approved.

# Papers from the Senate

ORDERED, the House concurring, that a Joint Select Committee on Railroad Passenger Service be established, consisting of 2 members of the Senate to be appointed by the President of the Senate, and 3 members of the House of Representatives to be appointed by the Speaker of the House; the chairman to be designated by the President of the Senate; and be it further

ORDERED, that the committee confer and negotiate with officials of the Boston and Maine, Maine Central, and Bangor and Aroostook Railroads with regard to ways and means of restoring railroad passenger service to and from points in Maine north and east of Portland through voluntary action on the part of the railroads; and be it further

ORDERED, that the committee report the results of such conferences and negotiations to the 101st Legislature, together with recom-mendations, if any, for legislative action whereby the State of Maine may cooperate with the railroads in the restoration of such passenger service (S. P. 196)

ORDERED, the House concurring, that a Committee, consisting of three members from the Senate, appointed by the President of the Senate, and five members from the House of Representatives, appointed by the Speaker of the House, and two members to be appointed by the Governor, is hereby created. The Committee is directed to study, determine and report to the 101st Legislature, on or before April 1, 1963, its recommendation of a site for the relocation of the Boys' Training Center. The Committee shall organize forthwith and elect a chairman to assume the responsibility of coordinating the committee's activities.

The expenses incurred by the Legislative members of the Committee shall be limited to the sum of \$1,000. Such amount to be expended from the Legislative appropriation (S. P. 197)

ORDERED, the House concurring. that any Town Clerk or Board of County Commissioners may, upon written request to the Document Clerk, receive without charge, copies of all printed bills, so that there may be available to the public during the legislative session, a complete and convenient file of all printed bills (S. P. 198)

# STATE HIGHWAY COMMISSION STATE OF MAINE Augusta

To the Senate and

House of Representatives

of the 101st Legislature

Chapter 84, Resolves of 1959, and Chapter 97, Resolves of 1961, authorized the State Highway Commission to make a survey of the Maine-Quebec highway and appropriated a total of \$15,700.00 from the General Highway fund for this purpose.

Following is a summary of the material in the State Highway Commission's files:

(1) Seven quadrangle sheets showing route and various landmarks.

(2) Three quadrangle sheets showing land owners along the surveyed route.

(3) Three quadrangle sheets showing location between the U. S.-Canadian line at St. Pamphile and Little Black River.

(4) Ten survey books ("AQ-1 through AQ-10").

(5) One roll on which horizontal alignment has been plotted to a scale of 1 inch equals 200 feet.

(6) Thirty-nine sheets tracing cloth with alignment plotted to a scale of 1 inch equals 200 feet.

(7) One notebook entitled, "Ashland-Quebec Survey" containing all computations.

Of the original \$15,700.00 there was expended for the above purpose a total of \$15,608.32. The balance of \$91.68 was lapsed on June 30, 1962.

Mr. WELLMAN: Mr. Speaker, I would inquire if the House has in its possession House Paper 353, "An Act relating to Property Tax Appeals."

The SPEAKER: The Chair would inform the gentleman that the paper is in the possession of the House.

Mr. WELLMAN: Mr. Speaker, I would like to move that we reconsider our action of yesterday whereby we referred this bill to the Taxation Committee. If we so reconsider our action, I would like to see this bill sent to the Judiciary Committee. I feel that this is a problem that probably should best be handled by them. I would ask for reconsideration.

The SPEAKER: The gentleman from Bangor, Mr. Wellman, moves that we reconsider our action whereby we assigned House Paper 353 to the Committee on Taxation. Is this the pleasure of the House?

The motion prevailed.

Thereupon, on further motion of the same gentleman, the Bill was referred to the Committee on Judiciary, ordered printed and sent up for concurrence. The SPEAKER: The Chair has the sad duty of announcing the tragic and untimely death of the Honorable William G. Earles of South Portland, which occurred yesterday afternoon by accident on his return home from duties here during the session yesterday morning.

Representative Earles was held in high esteem by all who served with him, and we extend our sympathy to the family and his host of friends.

At this time, the Chair will recognize the gentleman from Freeport, Mr. Crockett.

Mr. Crockett of Freeport presented the following Resolution and moved its adoption:

> STATE OF MAINE 101ST LEGISLATURE HOUSE RESOLUTIONS

WHEREAS, the members of the House of Representatives of the One Hundred and First Legislature have learned with profound sorrow of the death yesterday of an esteemed colleague, Honorable William G. Earles, Representative from South Portland, and a member of the House of Representatives in 1955, 1957 and 1959;

AND WHEREAS, in his association with the members of this House he was ever honorable and kindly, being highly regarded for his character and sterling qualities of mind and heart;

AND WHEREAS, the members of the House of Representatives sense in his passing a personal loss and a genuine grief;

NOW, THEREFORE, BE IT RE-SOLVED: That the State of Maine mourns the loss of a faithful and valued public servant, and the members of the House of Representatives lament the departure of an esteemed and trusted friend;

AND BE IT FURTHER RE-SOLVED: That these Resolutions be entered in the Journal of the House and an engrossed copy of these Resolutions be sent to the family of the deceased;

AND BE IT FURTHER RE-SOLVED: That as a further token of respect the House do now stand adjourned. The Resolution was received out of order under suspension of the rules, read and adopted.

The SPEAKER: The Chair at this time will appoint the delegation from Cumberland County to attend the services which will be held on Friday morning at ten o'clock at the Holy Cross Church in South Portland.

In accordance with the above Resolution, the House stood adjourned until one-thirty o'clock tomorrow afternoon.
