Honorable Members of the One Hundred and First Legislature Gentlemen:

It is with great personal gratitude on behalf of myself and the citizens of the State of Maine, that I transmit to you herewith, a communication from the Honorable Percival P. Baxter, former Governor of the State of Maine, received by me on January 22, 1963. This communication is self-explanatory and sets forth the desire of the Honorable Percival P. Baxter to obtain concurring Legislative action in the acceptance of a gift of 7,764 acres of forest land to the State of Maine.

On September 5, 1962, consistent with the authority vested in me by the provisions of the Revised Statutes, Chapter 11, Section 16, the Governor and Executive Council accepted on behalf of the State of Maine, a gift of this tract of land, to be added to previous gifts of forest land which now comprise the Baxter State Park.

An Act will be proposed for your consideration and concurrence in acceptance of this gift, in keeping with Mr. Baxter's request. I submit Mr. Baxter's generous offer with the observation that favorable consideration of the accompanying legislation is in the public interest and respectfully recommend your earliest favorable action.

This act of great generosity on the part of Mr. Baxter is further exemplification of the donor's continued interest in the preservation of the natural resources of our State for posterity.

The SPEAKER: The Chair recognizes the gentleman from Bangor, Mr. Wellman.

Mr. WELLMAN: Mr. Speaker, I will shortly move that we suspend the rules so that we may accept this bill and give it its several readings today. However, before we undertake such action, I would like to make a few brief comments concerning this gift and its place in the total gifts that Governor Baxter has given to the State.

In 1931 he gave 7,000 acres which included the mountain itself in the park; in 1938 he gave 6,000 acres; in 1939, 6,000 acres; in 1940, 4,174 acres; in 1941, 12,000 acres; in 1942, another 12,000 acres; in 1943,

another 12,000 acres; in 1944, 24,000 acres; in 1945, 35,000 acres; in 1947, 10,000 acres; in 1949, 14,000 acres, and in 1955, 53,000 acres, making a total at that time of 193,254 acres.

During this period, he made a donation to help with the road construction in the park and also gave to the State his summer residence, Mackworth Island, and the bridge connecting it with the mainland, as a school for the deaf. In 1953 he gave \$675,000.00 in connection with that particular institution.

In the last session, you will remember, he gave \$498,000.00 in trust for the maintenance and care of Baxter State Park, and so now this Legislature is being asked to approve the action of the Council accepting 7,764 acres to complete a program for the State and the people of Maine of a park of 200,000 acres.

I think we should note in Governor Baxter's letter to Governor Gardiner in 1931 where he said: "I expect someday to see my ambition realized." This day is now here. His ambition has been realized. With great modesty Governor Baxter ends his letter to Governor Reed by saying: "This brings to an end an interesting incident in Maine history." I suggest to you that this is not an end, but this is rather a beginning, a beginning of a great Park and a great program for the people of the State of Maine and indeed for the people of this Country.

I now move, Mr. Speaker, that we suspend the rules so that we can give this bill its several readings today.

Thereupon, the Bill was given its three several readings under suspension of the rules and passed to be engrossed without reference to a Committee in concurrence.

Mr. O'Leary.

Mr. O'LEARY: Mr. Speaker, I would like to know if the Clerk has in his possession House Paper 54, L. D. 77, "An Act relating to Mandatory Jail Sentence in Night Hunting Cases."

The SPEAKER: The Chair would inform the gentleman that the paper is in the possession of the House, with the Report "Ought not to

pass."

Mr. O'LEARY: Mr. Speaker, I move we reconsider our action of yesterday whereby we accepted the Judiciary Committee's "Ought not to pass" Report on this bill.

The SPEAKER: The gentleman from Mexico, Mr. O'Leary, moves that the House reconsider its action whereby the "Ought not to pass" Report was accepted.

The Chair recognizes the gentleman from Belfast, Mr. Thornton.

Mr. THORNTON: Mr. Speaker, this bill was referred to the Committee on Judiciary, duly advertised, and a full hearing had, and the Committee was unanimous in reporting it "Ought not to pass."

This offense has a very severe penalty at the present time, and the Judges do have discretion in regard to imposing a jail sentence on the first offense. If the same man comes back a second time, they do not have that discretion: they are obliged to give him jail. Although the fine is extremely heavy, first offense is anywhere from \$200 to \$400; second offense from \$400 to \$800, and if a poor man is convicted and is unable to pay the fine, he has to lay it out in jail at the rate of one day in jail for every dollar of the fine.

The Committee was unanimous in feeling that this bill should not pass, and I hope this move to reconsider will not be accepted by the House.

The SPEAKER: The question before the House is the motion of the gentleman from Mexico, Mr. O'Leary, that the House reconsider its action whereby the "Ought not to pass" Report was accepted. Is the House ready for the question? All those in favor of reconsideration will say aye; those opposed, no.

A viva voce vote being taken, the motion did not prevail.

Mr. RUST: Mr. Speaker, Ladies and Gentlemen of the House: You have before you this morning several pages presented to you under the title "Maine Navy Seeks Conquests." Now this is a little news item which I would like to bring to your attention because it relates to two of our State Department's functions. It talks about Maine's one-ship navy is coursing southward today, loaded to her Plimsoll line with ammunition. The ship is the proud "State of Maine," operated by the cadets and midshipmen of the Maine Maritime Academy. The ammunition consists of over 100 feet of display material, large color transparencies and other materials advertising the atmosphere of Maine and the products which we produce here. This is a cooperative venture by the Maine Maritime Academy and the Department of Economic Development.

While these boys are on their cruise, they will make stops at a number of ports among which will be Kingston, Balboa, San Diego. San Francisco, Los Angeles, Cristobal, San Juan and New York City, and while in these ports of call our boys will be contacting various organizations in the area and also they will have this material on display for people who come on board to visit the ship while in port.

So far as we know, the State of Maine is the only State that conducts such a program, and it is possibly because other states don't have the fine institution such as the Maine Maritime Academy, a school that in a relatively few years has become a highly regarded Maine institution, not only for the excellence of the job it does scholastically but for its determination to

boost Maine on any and all occasions. Thank you.
