HOUSE

Tuesday, February 5, 1963

The House met according to adjournment and was called to order by the Speaker.

Prayer by Captain William O. Wilbur of the Salvation Army, Augusta. The members stood at attention during the playing of the National Anthem.

The journal of the previous session was read and approved.

The SPEAKER: The Chair is pleased to recognize at this time in the balcony of the House seven Star and Life Scouts from Troop 1 of Brewer. This is the oldest Scout Troop in the country. They are accompanied by Judge Wesley C. Archer.

On behalf of the House, the Chair extends to you a warm welcome, and we trust that you will benefit from your visit with us here today. (Applause)
