Mr. SMITH: Mr. Speaker, I would inquire of the Chair if L. D. 89 is still in the possession of the House?

The SPEAKER: The Chair would inform the gentleman that the paper is in the possession of the Mr. SMITH: Mr. Speaker, recently this bill, "An Act relating to Sale of Beverages in Returnable Bottles" was passed out of the Committee on Liquor Control with an "Ought not to pass" Report.

The SPEAKER: Would the gentleman make a motion so that the matter will be before the House? Then the gentleman may debate.

Mr. SMITH: I will move that this bill be reconsidered for the purpose of amendment or recommittal.

The SPEAKER: The gentleman

may proceed.

Mr. SMITH: Thank you. It was returned out of Committee by a vote of 7 to 3 "Ought not to pass." This bill yesterday, the Committee Report was accepted and looking it over and speaking with most of the members of the Liquor Control Committee, I found that the real difficulty here could be taken care of in an amendment. The difficulty seemed to be over the fact that the return a ble containers included everything from glass to tin cans, and also that charge of five cents.

Now this bill affects carbonated and malt bottles only. If that charge of five cents were on the carbonated bottles, for instance, it would make it real difficult for children to go in and buy and pay a deposit of a nickel every time they bought anything; and also this bill was a poor bill in that you would have to pay a nickel deposit on a tin can that you would ultimately destroy, and yet most of us feel that this bill does have some degree of merit, especially if you run over a bottle on the highways. But actually, I believe the only thing that we are trying to get at here, those that were trying to get at it, was the subject of glass.

I had prepared an amendment which is on your desks, that would substitute the word "glass" before the word "container" and also after the word "returnable" making this bill — limiting this bill only to glass containers and knocking out the five cent deposit altogether.

However, due to the fact that this amendment will change the meaning actually of the bill and substitute a new bill here, it is now my desire, if you gentlemen will permit this to be reconsidered, to have this recommitted to the Liquor Com-

mittee to take care of these necessary things. I have already moved that this be reconsidered. Thank

The SPEAKER: The question before the House is the motion of the gentleman from Strong, Mr. Smith, that we reconsider our action whereby we accepted the "Ought not to pass" Report.

The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I am not rising to object to having the matter reconsidered for the purpose of recommitment, but I see something else in the bill which I hope if it is recommitted, there will be some changes made. As I read this bill, it says it shall be unlawful for any person or persons to transport or have in possession any carbonated beverages which is not in a non-returnable bottle. I foresee this situation; assuming John Brown and his wife leave Massachusetts and they decide to come to Maine and they are going there for the weekend and they take with them four bottles of orangeade and a couple of sandwiches. They have with them two teenage children. They stop at one of our picnic areas to have a lunch, and while they are there, they are stopped by a police officer, and he sees that they have in their possession four bottles of orangeade. So therefore, under this bill, it says person or persons having in their possession, Mr. Jones would be guilty of a crime, Mrs. Jones would be guilty of a crime, two teenage children would both be guilty of juvenile delinquency. Now I hope that that is not the intent of this bill.

The SPEAKER: Is the House ready for the question?

The Chair recognizes the gentleman from Corinna, Mr. Osgood.

Mr. OSGOOD: Mr. Speaker, I would like to make a few remarks in regard to this. I introduced this bill. At the beginning, I didn't consider it very important, but since its introduction I have received so many complaints from farmers who have been plagued by this menace, that I believe that it should receive consideration.

I am not out to hurt anybody, but I believe these farmers are due some consideration from this body. Now there are plenty here who can testify to their experiences as to damage to their farm machinery and their domesticated animals.

This is not a liquor bill. This is a litter bill, and was intended as such. Now there are plenty of people here, if they will get on their feet, can tell of their experiences with glass. I will accept those amendments that have been offered here. but I would like to make it plain that it isn't a liquor bill. Therefore, I feel that it should come before the Agricultural Committee where it was intended it should go. I am a freshman here and therefore that on my part was overlooked.

Now they can break the tires on farm machinery such as balers. tractors and others besides. I have evidence that those bottles have been raked up into windrows, gone into bales, which breaks the bottles going through into the baler. and a great many of them have been found and eliminated. Some of them get by. Animals have gotten them into their stomachs and have died as a consequence. Now I feel that that is a litter problem. These farmers of course, they pay — well, they're paying us, they are helping to pay us; they are helping to pay this — the revenues to the state, and a good big bunch of them, and I feel that the least we can do, if we can save them a little money along with the other taxpayers of the state, I think we are remiss if we don't do it.

The SPEAKER: The Chair recognizes the gentleman from Enfield,

Mr. Dudley.

Mr. DUDLEY: Mr. Speaker, I would like to ask one small question through the Chair. Was it the intent of this bill to cover such bottles as olive bottles, pickle bottles, milk bottles and many others, or is it discrimination against one industry?

The SPEAKER: The gentleman from Enfield, Mr. Dudley, poses a question to anyone in the House who cares to answer.

The Chair recognizes the gentleman from Benton, Mr. Kent.

Mr. KENT: Mr. Speaker, Ladies and Gentlemen of the House: I don't think my two months are quite

up from what I was informed in Bangor, but I do want to say just a little bit in regard to this bill.

As many of you know, I am a dairy farmer, and this has been a problem for us every year. The first thing that happens before we start to harvest our hay crop, especially on a main travelled road, we have to go and do the best we can to pick these bottles out of the hay. Many is the time that I have driven along beside the road mowing hay and heard the bottle under a tractor tire go "crunch."

Now as the gentleman said a few moments ago, these can be raked up into the windrows of hay. If there could be some way that this could be amended. I don't think it is possible to even eliminate the hazard altogether because regardless if there were some bottles that had a returnable charge of 50 cents they would still be thrown away, but it would eliminate part of it, and I assure you that this is a problem for every farmer in our whole state, and quite a serious problem. I add this to go along with this reference because I believe the bill really has merit and could be amended. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Strong, Mr. Smith.

Mr. SMITH: Mr. Speaker, due to the fact there is a little difference of opinion maybe here, I would ask for a division.

The SPEAKER: Is the House ready for the question? A division has been requested. All those in favor of reconsideration of our action on Bill "An Act relating to Sale of Beverages in Returnable Bottles," House Paper 65, Legislative Document 89, will rise and remain standing until the monitors have made and returned the count.

A division of the House was had.

One hundred seven having voted in the affirmative and twenty-three having voted in the negative, the motion did prevail.

The SPEAKER: The question now before the House is on the acceptance of the "Ought not to pass" Report.

The Chair recognizes the gentleman from Strong, Mr. Smith. Mr. SMITH: Mr. Speaker, I move we accept the Minority "Ought to pass" Report.

The SPEAKER: There is a pending motion, the "Ought not to pass" Report. The pending motion, after reconsideration, is the "Ought not to pass" Report. All those in favor of accepting the "Ought not to pass" Report will say aye; those opposed. no.

A viva voce vote being taken, the motion did not prevail.

The SPEAKER: Now the Chair understands that the gentleman moves to accept the Minority "Ought to pass" Report. Is it the pleasure of the House to accept the Minority "Ought to pass" Report?

The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I was under the impression that there was going to be a motion that this be recommitted to Committee.
