The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I move that item 1, House Paper 889, "An Act Revising Price Controls on Milk" be referred to the Committee on Business Legislation.

The SPEAKER: The gentleman from Portland, Mr. Childs, moves that this item 1, be referred to the Committee on Business Legislation and 800 copies printed. Is that the pleasure of the House?

The Chair recognizes the gentleman from Scarborough, Mr. Coulthard.

Mr. COULTHARD: Mr. Speaker and Ladies and Gentlemen of the House: We have a similar bill before the Agricultural Committee at this time. It is not turned out of Committee as yet, so I would hope that the motion of the gentleman

from Portland, Mr. Childs, would not pass.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, the bill which the gentleman from Scarborough refers to is also a bill which was presented by myself. Members of the House, there is a great distinction between the two bills. The bill which is before the Agriculture Committee and which has not been reported out, was a bill to abolish the Maine Milk Commission. This particular bill only refers to abolishing controls at the consumer level. It does not affect the producer or the farmer whatsoever. It is strictly a question of whether the dealers are getting more than a fair share of the take. It is a question of whether the consumers in the State of Maine are paying too much for milk. It is a question of the difference of price between the producer level and the consumer level and has absolutely nothing to do with the Agricultural Committee. So therefore, hoping this bill will get a fair hearing and knowing that it is a matter which concerns business more than it does agriculture, I hope that my motion will prevail.

The SPEAKER: The Chair recognizes the gentleman from Livermore, Mr. Boothby.

Mr. BOOTHBY: Mr. Speaker, I cannot see where you can divorce this from Agriculture. The Commissioner of Agriculture is an ex-officio member of the Milk Commission at the present time, and this bill directly affects all of our thousands of dairy farmers throughout the State. I think the Agricultural Committee is the proper place to handle it, and I would ask for a division.

The SPEAKER: The Chair recognizes the gentleman from Benton, Mr. Kent.

Mr. KENT: Mr. Speaker, Ladies and Gentlemen of the House: Anything that has to do with the price of milk certainly affects the farmer, and I sincerely hope that the gentleman's motion is defeated.

The SPEAKER: The Chair recognizes the gentleman from Bowdoinham, Mr. Curtis.

Mr. CURTIS: Mr. Speaker and Ladies and Gentlemen of the House: I agree with the gentleman from Portland, Mr. Childs, that this should be handled in some sort of way to get a fairer hearing than bills previously have got in other Legislatures concerning milk.

The question now which every farmer is up against, if the farmer interested in, then perhaps I agree with what has been said that he is interested in somewhat, although this particular bill if enacted as written, it would not affect the farmer but little. In other words, it does not change his, but it does do something which is time something should be done and which has not been done over the number of years past since we had the establishment of this control board. The dairies who retail the milk in this State of Maine have got themselves into a position where it is almost impossible to appear against them or do anything against them. They are - in fact in my own county they have be-come so powerful that for some just minor thing that doesn't matter a bit as far as a good quart of milk is produced, they just cut off the producer, and I think it is high time that this condition be brought before Business Legislation or somewhere where it might get a real good hearing, and I shall support, and I trust other farmers will, support the gentleman from Portland, Mr. Childs' motion.

The SPEAKER: Is the House ready for the question? The Chair recognizes the gentleman from Scarborough, Mr. Coulthard.

Mr. COULTHARD: Mr. Speaker, Ladies and Gentlemen: One more word if I may. The price fixing or control by the Commission so-called, I might say that the Commission is made up of producers, producer-dealers, consumers and as the gentleman from Livermore said, the Commissioner of Agriculture, so all parties concerned would have a voice in the price of milk. Thank you.

The SPEAKER: The question before the House is the motion of the gentleman from Portland, Mr. Childs, that Bill "An Act Revising Price Controls on Milk", House Paper 889, be referred to the Com-

mittee on Business Legislation, and a division has been requested. All those in favor of this matter being referred to the Committee on Business Legislation please rise and remain standing until the monitors have made and returned the count.

A division of the House was had.

Forty-nine having voted in the affirmative and seventy-two having voted in the negative, the motion did not prevail.

The SPEAKER: The Chair recognizes the gentleman from South Portland, Mr. Taylor.

Mr. TAYLOR: Mr. Speaker, Ladies and Gentlemen of the House: I am very strongly opposed to the passage of item 11, Legislative Document 254, on the grounds that the purpose of this bill is to create a new charter for each branch of the Public Finance Corporation when there is already a charter allowing this corporation to operate its main office and branch offices presently in effect. It becomes obvious that the issuance of a separate charter for each branch is a tax dodge, to evade full payment of corporation taxes to our Federal Government and, as a responsible Legislator, I do not believe that the Members of this House should become a party to legalize ways and means for any corporation to evade Federal taxes.

Pending a possible amendment to this present law, I hereby move that this bill be indefinitely postponed.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. MacLeod.

Mr. MacLEOD: Mr. Speaker, we heard this bill in the Business Legislation Committee and it came out of that Committee with a unanimous "Ought to pass" Report. I don't think it is the duty of this Legislature to prohibit business or to make it difficult for business to operate in this Country or in this State when it is acceptable under the tax laws of the United States of America. We have many businesses in this State that form separate corporations for tax purposes and do this legally. If this is the prime reason why the Public Finance Corporation is forming this new corporation for tax reasons, I still don't think it is our business to prohibit them from engaging in business.

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Humphrey.

Mr. HUMPHREY: Mr. Speaker. the Public Finance Corporation system is owned and operated by American Investment Company Illinois, a reasonable organization whose shares are listed on the New York Stock Exchange. It has been doing business in the State of Maine for quite a long while, and now operates nineteen licensed small loan agencies all over the State. Our statutes and the banking law require that each office be specially licensed by the Bank Commission. The system is now operated with thirteen charters, thirteen separate corporations, some of which have more than one licensed office. Public Finance wishes a separate corperate charter for each location, and are willing to pay the corporation franchise taxes to the State of Maine necessary to exist as a corporation. These bills are only to permit such existence. They do not license the doing of business, they already have their license. And I will say the State will lose \$500 on each one of these if this bill is indefinitely postponed. I hope the motion of the gentleman from South Portland, Mr. Taylor, does not prevail, and I ask for a division.

The SPEAKER: Is the House ready for the question? The Chair recognizes the gentlewoman from Peru, Mrs. Vaughn.

Mrs. VAUGHN: Mr. Speaker, Ladies and Gentlemen of the House: I would like to add to what the gentleman from Brewer, Mr. Mac-

Leod, has said, that this was checked out with the Bank Commissioner, and they have no objections to these finance companies being given separate charters. This was asked at our committee hearings and this is what he said, they had no objection to them. And again, I wish to reiterate what the gentleman from Augusta, Mr. Humphrey, has already said, that it does mean \$500 to the State on each one of these that are incorporated. Thank you.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I only want to say that at the present time there is a bill before Congress which will prevent finance companies from doing this in the future. At the present time it is still legal. If we did have a corporate income tax in the State of Maine I would certainly oppose this legislation because it would have an impact on the State's finances, but at the present time we do not have a corporate income tax and it will not have any effect on the State.

The SPEAKER: Is the House ready for the question? The question before the House is the motion of the gentleman from South Portland, Mr. Taylor, that item 11, "An Act to Incorporate the Public Finance Corporation of Belfast," House Paper 185, Legislative Document 254, be indefinitely postponed. A division has been requested. All those in favor of the motion to indefinitely postpone will please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Four having voted in the affirmative and ninety-three having voted in the negative, the motion did not prevail.

Pending—Acceptance.

The SPEAKER: The Chair recognizes the gentleman from Eagle Lake, Mr. Gallant.

Mr. GALLANT: Mr. Speaker and Members of the House: I would like to take this opportunity to thank Mr. Plante for tabling this bill. The intent of this bill was not triple hooks but was a single hook spaced about four inches apart, which is not a detriment to the fish when they can't fish for the fish. Ladies and Gentlemen, I now move to substitute the bill for the report and if it passes that stage I will offer an amendment. Thank you.

The SPEAKER: The gentleman from Eagle Lake, Mr. Gallant, moves that the bill be substituted for the "Ought not to pass" Report. All those in favor of the motion will say aye; those opposed, no.

A viva voce vote being doubted by the Chair, a division of the House was had.

Seventy-three having voted in the affirmative and twenty-eight having voted in the negative, the motion prevailed, the Bill was substituted for the Report, the Bill read twice and tomorrow assigned.

The Chair laid before the House the second tabled and today assigned matter:

House Order Relative to Members being Absent for Committee Meeting.

On motion of Mr. Jalbert of Lewiston, referred to the Committee on Rules and Business of the House.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I rise in substitution for Mr. Jones of Farmington who has laryngitis. He now wants me to move that the bill be passed to be engrossed.

Thereupon, the Bill was passed to be engrossed and sent to the Senate.

The Chair laid before the House the fourth tabled and today assigned matter:

An Act Providing a State-wide Limit on Certain Fish (H. P. 33) (L. D. 57)

The Chair laid before the House the sixth tabled and today assigned matter:

HOUSE REPORT—Ought to pass in new draft—Committee on Judiciary on Bill "An Act relating to Prohibition Against Loitering on Private Property or Peeking Therein" (H. P. 219) (L. D. 288) reporting same in a new draft (H. P. 888) (L. D. 1184) under same title.

Tabled — February 12, by Mr. Smith of Bar Harbor.

Pending—Acceptance.

The SPEAKER: The Chair recognizes the gentleman from Bar Harbor, Mr. Smith.

Mr. SMITH: Mr. Speaker, I move acceptance of the "Ought to pass" report in new draft.

The SPEAKER: The gentleman from Bar Harbor, Mr. Smith, moves the acceptance of the "Ought to pass" in new draft report. Is that the pleasure of the House?

The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker and Members of the House: Yesterday I hadn't peeked at the right rule until I got straightened out by the Speaker in an attempt to ask a question pending this legislation. I don't intend to go to the same well today. And also because of the fact that when I did ask my question from any member of the Judiciary Committee yesterday, I didn't see too many members of the committee rise too quickly to answer my question; so they somewhat left the situation up to our good friend from Bar Harbor, Mr. Smith. So today, to somewhat bail him out, I will direct my question to a specific member of the Judiciary Committee. He might throw the ball to somebody else. I would ask my question of the gentleman from Portland, Mr. Childs, to explain this little gem to us.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, has posed a question through the Chair to the gentleman from Portland, Mr. Childs; and he may answer if he so desires, and the Chair recognizes that gentleman.

Mr. CHILDS: Mr. Speaker and Members of the House: I am assuming that the gentleman from Lewiston is asking me to define "peek"; but the dictionary which I have is a very small one, and I believe it says though that peeking is one who glances through a small crack. Now, you are asking me when a person would be guilty of this crime. Assuming that it's a small crack and he peeks in, he would be guilty; if he goes up to a window and just looks, he would not be guilty. Also I assume that if he is gawking, he would therefore not be guilty of peeking. But as I said, my dictionary is very small and I do know that the gentleman who sits on Judiciary with me, the gentleman from Wiscasset, Mr. Pease, has a very, very large dictionary and he probably can give you a much better definition of the word "peek."

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I fail to see the gentleman from Wiscasset rise to follow up on the question, so I will ask him to explain — the gentleman from Wiscasset, Mr. Pease — to explain his version of this gem.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, poses a question through the Chair to the gentleman from Wiscasset, Mr. Pease, who may answer if he so desires: and the Chair recognizes that gentleman.

Mr. PEASE: Mr. Speaker and Members of the House and in particular, the gentleman from Lewiston, Mr. Jalbert: It is my understanding that the bill as originally introduced by the gentleman from Manchester, Mr. Gifford, was intended to provide a particular statutory remedy for the case where an individual wandered or loitered or entered upon the private property of another for the purpose of peeking, gawking, looking through small cracks, and in any other manner causing a general nuisance in the use of his eyes to seek to determine what the interior of the building might look like or what might be in the interior of the building or what that object in the building might look like.

In going over this in the Judiciary Committee, and in a serious vein, we determined that the original would perhaps make it a draft crime for an individual to look for a lost golf ball for example, in that he might be wandering on private property. Consequently, in working this out with the Attorney General's office, we came up with a new draft which made it specifically a crime-it is a misdemeanor, not a felony-a misdemeanor to enter upon the private property and peek in the nighttime, but only into an inhabited building or structure located on that particular piece of property.

I am not sure that the prestige of the Maine Legislature is going to rise and fall on the passage or failure of passage of this particular bill; perhaps its sponsor would have more particular information.

The SPEAKER: The Chair recognizes the gentleman from Manchester, Mr. Gifford.

Mr. GIFFORD: Mr. Speaker and Ladies and Gentlemen of the House: Certainly a little fun should be a part of every day. It would be a dull life indeed if we could not have our bit of levity, if we could not from time to time enjoy a joke at another's expense, expecting of course that the day will come when the tables might well be turned: and this bill that I introduced in its original form I confess lends itself very well to the purpose in which it has been used here this morning. However, I can assure you that it is not a funny matter to the victims of this type of offensive activity. And certainly I feel confident that you will agree with me that this type of activity should be condemned and that our Statutes should make provision for the apprehension and conviction of this type of individual.

This bill was introduced to fill a void in our Statutes which do not spell out this type of offense in a clear manner, a void which makes more difficult law enforcement and prosecution of this offense against society. We have heard them talking about "peeping Toms." We all know what they are. We all certainly condemn the "peeping Tom" and we desire him to be brought to justice. This bill is intended to assist in that aim.

In its original form there were objections to it, although the original was a copy of an existing Statute in another state, in the State of California. But there were objections that I feel were justifiable ones, by members of the Judiciary Committee, who felt that possibly the innocent were not well protected under it and that certainly we have as much interest in protecting the innocent as in bringing the wrongdoer to justice. Consequently it chose to redraft the bill and present it to you in the form in which it now appears. I am sure that we may feel confident; the learned gentlemen of the Judiciary Committee

have gone over it carefully from this point of view, and that we have little to fear if it becomes law.

I certainly would urge you, while enjoying the fun that we have this morning, to seriously consider and consider favorably the passage of this bill to aid and prevent as much as it is ever possible recurrences of this type of activity, which I am sure we all agree is offensive to our society.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I now have to speak in a rather serious tone on this. I have noticed that there is a difference in the title of the bill and the contents of the bill. The title of the bill is relating to prohibition against loitering on private property or peeking therein, and the contents of the bill reads "and peeking therein." Right now I can't recall just what the intent of the committee was, so possibly if the contents of the bill is what we wanted then the title of the bill would not be important; but if the title of the bill is what we wanted, there may be some necessary changes have to be made in it.

The SPEAKER: The question before the House is the motion of the gentleman from Bar Harbor, Mr. Smith, that Bill "An Act relating to Prohibition Against Loitering on Private Property or Peeking Therein" ought to pass in new draft. Is that the pleasure of the House?

The Chair recognizes the gentleman from Bangor, Mr. Wellman.

Mr. WELLMAN: Mr. Speaker, I move that this item be tabled until tomorrow.

Thereupon, the Report and New Draft were tabled pendingacceptance and specially assigned for tomorrow.

The Chair laid before the House the seventh tabled and today assigned matter:

An Act relating to Testamentary Additions to Trusts (S. P. 37) (L. D. 30)

Tabled — February 12, by Mr. Smith of Bar Harbor.

Pending-Passage to be Enacted.

On motion of Mr. Smith of Bar Harbor, retabled pending passage to be enacted and specially assigned for Wednesday, February 20.

The Chair laid before the House the eighth tabled and today assigned matter:

HOUSE REPORT—Ought not to pass — Committee on Inland Fisheries and Game on Resolve, Regulating Bag Limit of Trout in Aroostook County. (H. P. 45) (L. D. 68)

Tabled — February 12, by Mr. Wellman of Bangor.

Pending-Motion of Mr. Cookson of Glenburn to accept Report.

The SPEAKER: The Chair recognizes the gentleman from Houlton, Mr. Berman.

Mr. BERMAN: Mr. Speaker, this is a bill which I introduced for the President of the Houlton Fish and Game Club. Now I have confidence in the essential fairness of the House Chairman, Frank Anderson and the other House Members of this Committee, and I bow to their decision in this matter and offer no objection to the acceptance of the Committee Report.

The SPEAKER: The pending question is the motion of the gentleman from Glenburn, Mr. Cookson, that the "Ought not to pass" Committee Report be accepted. Is this the pleasure of the House?

The motion prevailed. Sent up for concurrence.

The Chair laid before the House the ninth tabled and today assigned matter:

Bill "An Act relating to Issuing of Bonds by School Administrative Districts" (S. P. 51) (L. D. 101)

Tabled — February 12, by Mr. Bradeen of Waterboro.

Pending — Passage to be Engrossed.

Mr. Snow of Jonesboro offered House Amendment "A" and moved its adoption.

House Amendment "A" was read by the Clerk as follows:

HOUSE AMENDMENT "A" to S. P. 51, L. D. 101, Bill, "An Act Relating to Issuing of Bonds by School Administrative Districts."

Amend said Bill, in the Title, by striking out the word "Districts"

and inserting in place thereof the words and figure 'District No. 15.'

Further amend said Bill by striking out, in the 2nd line, the words "Districts are" and inserting in place thereof the words and figure District No. 15 is'

Further amend said Bill by striking out, in the 7th line, the word "Districts" and inserting in place thereof the words and figure 'District No. 15'; and by striking out, in the 8th line, the word "their" and inserting in place thereof the word "its'

Further amend said Bill by striking out, in the 12th line, the word "the"; and by striking out in said 12th line the word "Districts" and inserting in place thereof the words and figure 'District No. 15'

Further amend said Bill by strikout everything after the enacting clause, except the emergency clause, and inserting in place thereof the following:

'Issuing of bonds by School Administrative District No. 15. Notwithstanding any other provision of law, each issue of bonds for capital outlay purposes for School Administrative District No. 15, Gray and New Gloucester, shall mature in such annual installments as shall be determined by the Board of School Directors, so that the first installment shall be payable not later than 2 years after the date of issue and the last installment not later than 25 years from the date thereof.'

House Amendment "A" was adopted, the Bill passed to be engrossed as amended in non-concurrence and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Auburn, Mr. Waterman.

Mr. WATERMAN: Mr. Speaker, I would inquire if House Paper 875, Bill "An Act relating to Refund of Excise Taxes on Malt Beverages Sold to Maine Army National Guard Training Site" is still in the possession of the House?

The SPEAKER: The Chair would inform the gentleman that the bill is in the possession of the House.

Thereupon, on motion of Mr. Waterman of Auburn, the House voted to reconsider its action of February 12 whereby the Bill was referred to the Committee on Liquor Control.

On further motion of the same gentleman, the Bill was referred to the Committee on Taxation, ordered printed and sent up for concurrence.

Mr. Coulthard of Scarborough was granted unanimous consent to address the House briefly.

Mr. COULTHARD: Mr. Speaker and Ladies and Gentlemen of the House: On behalf of the State Department of Agriculture, and the potato industry of the State of Maine, I want to take this opportunity to thank Representative Albert E.
