Mr. CROMMETT: Mr. Speaker, Ladies and Gentlemen of the House: This Document 283 regulates fishing in the West Branch of the Penobscot River which is a very short distance from my home. The people in Millinocket do not favor the passage of this Resolve. As it is written, we feel that it discriminates against family affairs and children. We have no objections to the fly fishing; we object to fly fishing only. The fish biologists in that district claim there are a lot of trash fish. Sometimes it is almost impossible to fly fish with the pulpwood going down the river. There are picnic areas along this river and the people from Millinocket and the surrounding areas go there with their families and they like to fish. The little boys like to fish with worms. Little boys are not fly fishermen. I move that this Resolve be indefinitely postponed.

The SPEAKER pro tem: The question before the House is the motion of the gentleman from Mil-

linocket, Mr. Crommett, that the Resolve and accompanying papers be indefinitely postponed.

The Chair recognizes the gentleman from Ellsworth, Mr. Anderson.

Mr. ANDERSON: Mr. Speaker, this bill came out of the committee unanimous ought to pass and it is purely a matter of conservation, and we feel that it is just; and I should hope that the motion by the gentleman to indefinitely postpone would be defeated.

Mr. DUDLEY: Mr. Speaker and Members of the House: This is quite near me also; I am quite familiar with this spot. I feel as though I agree with the gentleman from Millinocket, Mr. Crommett; he lives near there and knows the problem. These children do like to fish. There are a lot of trash fish there. I see no harm in leaving the way it is. Just a few minutes ago we let a bill go through that says fly fishing only to a certain pond. I agreed to that; it is a small pond, and I don't believe the children could do much fishing because they have to cast their fly way out into the pond.

Now we have just set aside one place for fly fishing only. There are several other places in the State, but this is the Penobscot River. You are now talking about the Penobscot River where pulp runs down sometimes for days and days, where it is impossible to fly fish, and there are a lot of camp sites, as he has already told you, along this river, and it enables the people to go there and have a picnic dinner and the children take a little line with an angleworm and do a little fishing, and I hope we don't take that privilege away from them here today. I concur that this bill should be indefinitely postponed.
