The Chief of the State Police before issuing said license may require the applicant to file proof of financial responsibility or to post a bond conditioned so as to compensate for any damage to a vehicle during an inspection or adjustment due to negligence on the part of such applicant or his employees, provided, that the aggregate liability of the surety for all such damages shall, in no event, exceed the amount of such bond or proof of responsibility. Said bond or proof of responsibility shall, in no case, amount to less than \$5,000.

Further amend said Bill by striking out all of that part designated "Sec. 13-E." of section 1 and inserting in place thereof the following:

'Sec. 13-E. Disposition of fees. The amount received from the fees under sections 13-A to 13-D shall be credited to the General Highway Fund.'

The Chair recognizes the gentleman from Bowdoinham, Mr. Curtis.

Mr. CURTIS: Mr. Speaker, inasmuch as this affects people of low wages and inasmuch as when this law was originally passed, the wages were much lower than they are now, it seems only reasonable that we should sensible adopt the Majority "Ought to pass" Report because these workers are a little worse off than they were a few years ago. And after all, it is the worker who pays all the bills. It is only reasonable that he should be taken care of, and I do have people working for me, and I know they have to live, and I am very sure that if some of the workers owed me, that I think this would allow them to keep something to keep them alive and would be a real thing. So, I move we accept the "Ought to pass" Report.

The SPEAKER: The motion for indefinite postponement has priority.

The Chair recognizes the gentleman from Madison, Mr. Hendsbee.

Mr. HENDSBEE: Mr. Speaker, this was my bill and was one that I filed early in the session and of course for quite a while I was not here due to confinement in the hospital. This bill was more or less of a request bill from many of the lawyers and a couple of municipal judges in my area who felt, as I do, that the amount of money that was left after a trustee process of \$30 was not sufficient for a man to maintain his family. Therefore, this bill was put in to raise it to \$40, and I now move the acceptance of the "Ought to pass" Report.

The SPEAKER: The pending question before the House is the motion of the gentleman from Wiscasset, Mr. Pease, that the Bill and

both Reports be indefinitely postponed.

Mr. Curtis of Bowdoinham requested a division on the motion to indefinitely postpone.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I believe the intent of this bill is very simple and certainly very simple for the members of this House to understand. The original intent of \$30 which was passed — I believe it was \$20 originally and it was increased some years ago to \$30. The idea of the bill is, even after you put a trustee on, that a man should still be able to have enough money left to pay his rent and buy his food and take care of his family. Now if you believe that a man can take care of his family on \$30 a week. you should vote for the indefinite postponement of this bill. If you believe it takes more than \$30 a week to support a family, I believe that this bill should pass. I hope this motion to indefinitely postpone it will not prevail.

The SPEAKER: Is the House ready for the question?

The Chair recognizes the gentleman from York, Mr. Rust.

Mr. RUST: Mr. Speaker, I rise in support of the motion of the Wiscasset, gentleman from Pease. And as far as I am concerned, I mean, this bill raises the exemption from \$30 to \$40; it is not a big raise, but the basic purpose behind trustee attachments is not to get at the honest man; it is not to get at the conscientious hardworking man; but it is a means of getting at the so-called 'deadbeat.' And if you people have been in business today and have tried to collect money from these people, you know who I am talking about. They don't need any help.

The SPEAKER: Is the House ready for the question?

The Chair recognizes the gentleman from Rumford, Mr. Jobin.

Mr. JOBIN: Mr. Speaker, I wish to go on record as concurring with my good friend from Bowdoinham, Mr. Curtis. It has been my experience in a good many cases, it is not only the so-called 'Dead-beats'

that suffer from this particular bill. My reason for supporting Mr. Curtis is the fact that regardless of what the wage earner or father of a family may be, I don't feel it is the responsibility of his wife or children, I don't feel that they should be held to task for anything at least, and most of all I don't feel that they should be left at least without the means of shelter and food. Thank you.

The SPEAKER: Is the House ready for the question? The question before the House is the motion of the gentleman from Wiscasset, Mr. Pease, that the Reports and Bill "An Act Increasing Amount of Wages Exempt from Trustee Process," House Paper 234, Legislative Document 302, be indefinitely postponed. A division has been requested.
