Friday, May 17, 1963

The House met according to adjournment and was called to order the the Speaker.

Prayer by the Rev. Mr. Frederick E. Dougherty of Augusta.

The journal of yesterday was read and approved.

Paper from the Senate Non-Concurrent Matter

An Act relating to County Taxes in Places not Incorporated (H. P. 689) (L. D. 945) which was passed to be enacted in the House on April 24 and passed to be engrossed on April 3.

Came from the Senate passed to be engrossed as amended by Senate Amendment "A" in non-concurrence.

In the House: The House voted to recede and concur with the Senate.

Orders

Tabled and Assigned

Mr. Libby of Portland presented the following Order and moved its passage:

WHEREAS, it appears to the House of Representatives of the One Hundred and First Legislature that the following are important questions of law and that the occasion is a solemn one; and

WHEREAS, there is pending before the House the Bill entitled "An Act Amending the Charter of the City of Portland Relating to Imposition of a General Business and Occupation Tax" (H. P. 1094) (L. D. 1569); and

WHEREAS, the Constitutionality of said Bill has been questioned; and

WHEREAS, it is important that the Legislature be informed as to the constitutionality of said Bill; now, therefore, be it

ORDERED, That the Justices of the Supreme Judicial Court are hereby respectfully requested to give to the House, according to the provisions of the Constitution on this behalf, their opinion on the following questions, to wit:

Question 1. May the Legislature grant the right to one municipality to levy a tax by ordinance when such right is not granted at the same time to all other municipalities in the State?

Question 2. If the answer to Question 1 is in the affirmative, may the Legislature grant the right to a municipality to levy a tax upon persons carrying on or exercising within such municipality any trade, business, profession, vocation or commercial activity measured by the gross receipts or gross income from such activities?

Question 3. If the answers to the two foregoing Questions are in the affirmative, may the Legislature grant the right to such municipality to determine the rate of such tax upon selected types or classes of those persons subject to it, such tax not to exceed, however, one percent of such gross receipts, in view of the provisions of the Constitution of Maine, Article IX, Section 8?

Question 4. If the answers to the first two Questions are in the affirmative, may the Legislature grant the right to a municipality to specify exemptions from such tax?

Question 5. If the answer to Question 1 is in the affirmative, would said Bill, if enacted into law and carried out by an ordinance of the City of Portland enacted thereunder, be constitutional?

Pursuant to House Rule 46, the Order was tabled pending passage and specially assigned for Tuesday, May 21.

The SPEAKER: The Chair recognizes the gentleman from Houlton, Mr. Berman.

Mr. BERMAN: Mr. Speaker, due to the substantial number of empty seats here this morning, I would hope that someone would table this matter pending acceptance of either report.

Thereupon, on motion of Mr. Plante of Old Orchard Beach, tabled pending acceptance of either Report and specially assigned for Tuesday, May 21.

On motion of the gentlewoman from Chelsea, Mrs. Shaw, House Rule 25 was suspended for the remainder of today's session in order to permit smoking.

Passed to Be Engrossed Bill "An Act relating to Exempting from Property Tax Pleasure Boats in the State for Storage" (H. P. 1092) (L. D. 1567)

Was reported by the Committee on Bills in the Third Reading, read the third time, passed to be engrossed and sent to the Senate.

Third Reader Indefinitely Postponed

Resolve Appropriating Moneys to Promote and Advertise Maine's Ski Business (S. P. 96) (L. D. 233)

Was reported by the Committee on Bills in the Third Reading and read the second time.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. MacLeod.

Mr. MacLEOD: Mr. Speaker and Members of the House: Yesterday this House saw fit not to approve cuts of \$1,700,000 off the current services budget. Yesterday this House saw fit to enact into law a bill calling for the expenditures of some \$69,000,000 over the next two years and a bond issue of some \$8,000,000. This was the general highway fund appropriation. Not one word of debate. Not one word of criticism. Not one word of explanation. This measure passed, carrying a total of over \$69,000,000. So I suppose that to stand here this morning and to say that to appropriate \$30,000 to advertise a specific tourist industry will have the same effect as those two bills vesterday. But I feel that this is money being spent by the DED for a segment of our tourist business, perhaps this is going to bring the business into that one hundred and some thousand dollar road that we voted this week to give to the ski industry. I feel this is bad legislation. I feel this is money that should not be appropriated for a specific business such as this. This is strictly nothing more than the government of this state subsidizing one particular business in favor over another. So, I therefore move the indefinite postponement of this measure.

The SPEAKER: The gentleman from Brewer, Mr. MacLeod, n o w moves the indefinite postponement of item 2, Resolve Appropriating Moneys to Promote and Advertise Maine's Ski Business, Senate Paper 96, Legislative Document 233. The Chair recognizes the gentleman from Cape Elizabeth, Mr. Berry.

Mr. BERRY: Mr. Speaker and Members of the House: I would like to concur with the remarks of my good friend from Brewer, Mr. Mac-Leod. I think that the funds necessary for this could be found perhaps from the budget of the Department of Economic Development. I also would urge the indefinite postponement of this bill.

The SPEAKER: The Chair recognizes the gentlewoman from F a lmouth, Mrs. Smith.

Mrs. SMITH: Mr. Speaker, T think this again is a matter for the House to decide. It was felt in the committee, by a greater majority of the committee at least. and it was brought out unanimous that this was a segment of the industry that perhaps we should put some extra money into to see if we could upgrade the industry and bring more money into the state. I think that would be up to the House to decide.

The SPEAKER: The Chair recognizes the gentleman from Hampden, Mr. Littlefield.

Mr. LITTLEFIELD: Mr. Speaker, Ladies and Gentlemen of the House: Believe it or not, I am glad to agree and support the motion of my colleague from Brewer, Mr. MacLeod, to indefinitely postpone this matter.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I, as a signer of the unanimous "Ought to pass" Report of the committee, I did it without weakness. If I am going to be weak signing a report, I am going to sign it "Ought not to pass" and be honest with myself. The committee discussed this bill at length. It was felt by the committee that this industry in that area spent a great deal of their own funds, that we are way late in Maine in expending funds for this fast-growing industry, and I am not a skier, and I don't live near the area, and for that reason the committee signed the report unanious "Ought to pass."

Insofar as the argument is concerned that it could be found in the present funds of the DED. I assure you that that is not feasible. I am sure that, really seriously, that the gentleman from Cape Elizabeth, Mr. Berry, is fully aware of that. Now just because apparently the DED is under fire is no reason that anything that mentions DED is going to go down the drain, because if that is to be, then let's go back, go to the Reference of Bills Committee and put a bill in to strike out the Department of Economic Development. I think this is a sound piece of legislation. It involves \$30,000, and I think it will pay us back tenfold. I certainly hope that the motion to indefinitely postpone does not prevail. When the vote is taken, I move it be taken by division.

The SPEAKER: The Chair recognizes the gentleman from Cape Elizabeth, Mr. Berry.

Mr. BERRY: Mr. Speaker, Members of the House: I don't relish the statements of the gentleman from Lewiston, that I realize what I am saying and say something differently. The Department of Economic Development has money for advertising. It can direct a portion of this advertising to the ski business. Now those are the facts.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: Mr. Speaker, I would like to ask a question through the Chair of the gentleman f r o m Cape Elizabeth, Mr. Berry. Will he spell out the advertising budget of the DED, and tell me exactly the \$30,000 that he wants to strike out.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, poses a question through the Chair of the gentleman from Cape Elizabeth, Mr. Berry, who may answer if he desires.

The Chair recognizes the gentleman from Cape Elizabeth, Mr. Berry.

Mr. BERRY: Mr. Speaker, I do not recommend that necessarily \$30,-000 be spent promoting the ski business from the Department of Economic Development. I say that in their advertising budget, they can direct some of their money toward the ski business.

The SPEAKER: The Chair recog-

nizes the gentleman from Auburn, Mr. Turner.

Mr. TURNER: Mr. Speaker, I don't know but what I would like to go along with this, if I could get an amendment hitched onto this whereby they would subsidize my pony and horse trading deal. I like saddle horses and trading cows. That business is slipping like the dickens, and I think if I could get a little boost out of the DED, it would help. But I will go along with the indefinite postponement of this.

The SPEAKER: Is the House ready for the question? As many as are in favor of indefinite postponement, will please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Seventy-nine having voted in the affirmative and twenty-seven having voted in the negative, the motion to indefinitely postpone did prevail.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

Mr. JALBERT: I move that we reconsider our action whereby we indefinitely postponed this item, and when you vote, vote against my motion.

The SPEAKER: The gentleman from Lewiston, Mr. Jalbert, moves that the House reconsider its action whereby it indefinitely postponed item 2, Resolve Appropriating Moneys to Promote and Advertise Maine's Ski Business, Senate Paper 96, Legislative Document 233. All those in favor will say aye; those opposed, no.

A viva voce vote being taken, the motion to reconsider did not prevail.

Thereupon, the Resolve was indefinitely postponed in non-concurrence and sent up for concurrence.

Third Reader Amended Tabled and Assigned

Bill "An Act Revising the Maine Employment Security Laws" (H. P. 778) (L. D. 1151)

Was reported by the Committee on Bills in the Third Reading, and read the third time.

The SPEAKER: The Chair recognizes the gentleman from Gouldsboro, Mr. Young. Mr. YOUNG: Mr. Speaker, in regards to item 3, where there are so many vacant seats and this is quite an important bill, I wished that somebody would table it.

Thereupon, on motion of Mr. Wellman of Bangor, tabled pending passage to be engrossed and specially assigned for Tuesday, May 21.

Finally Passed Constitutional Amendment

Resolve Proposing an Amendment to the Constitution Designating Procedure for Determining the Election of Governor (S. P. 530) (L. D. 1451)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I ask the House to vote against this Constitutional Amendment.

Thereupon, this being a Constitutional Amendment and a two-thirds vote of the House being necessary, a division was had.

The SPEAKER: Eighty having voted in the affirmative and thirtyone having voted in the negative, the Constitutional Amendment has received final passage.

Mr. Childs of Portland then requested a roll call.

The SPEAKER: For the Chair to order a roll call, it must have the expressed desire of one-fifth of the members present. All those who desire a roll call, will please rise and remain standing until the monitors have made and returned the count.

Thirty members arose.

The SPEAKER: Obviously, 30 having requested a roll call, it is ordered. The question before the House is the final passage of Resolve Proposing an Amendment to the Constitution Designating Procedure for Determining the Election of Governor, Senate Paper 530, Legislative Document 1451. Emergency Measure Failed of Enactment

An Act relating to Loans by Washington County (S. P. 592) (L. D. 1556)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a division was had. 97 voted in favor of same and 10 against, and accordingly the Bill failed of enactment and was sent to the Senate.

Passed to Be Enacted Emergency Measure

An Act Appropriating Moneys for Maine Civil War Commission (H. P. 408) (L. D. 561)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a twothirds vote of all the members elected to the House being necessary, a division was had. 104 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

Emergency Measure

An Act to Authorize the Municipalities of Detroit, Etna, Plymouth, Dixmont and Stetson to Form a School Administrative District (H. P. 435) (L. D. 640)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a twothirds vote of all the members elected to the House being necessary, a division was had. 106 voted in favor of same and 3 against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Childs.

Mr. CHILDS: Mr. Speaker, I rise first for a parliamentary inquiry. I ask the Chair to rule on the germaneness of the amendment to this bill.

The SPEAKER: The Chair would advise the gentleman that the amendment having been adopted without the question of germaneness being raised, the Chair will rule that the point of order comes too late.

The gentleman may proceed.

Mr. CHILDS: Mr. Speaker and Members of the House: This was a bill in its original form which was before the Judiciary Committee, and the Committee reported it out unanimously "Ought not to pass." Then this particular bill was amended the bill which was amended had absolutely nothing to do with the bill which is before the House now. The title of the bill was amended and the contents of the bill was amended. It was therefore brought back before the Legislature in a form which had already been unanimously voted "Ought not to pass" by the Judiciary Committee. I therefore move at this time that this bill and its accompanying papers be indefinitely postponed.

indefinitely postponed. The SPEAKER: The gentleman from Portland, Mr. Childs, moves that item 8 be indefinitely postponed.

The Chair recognizes the gentleman from York, Mr. Rust.

Mr. RUST: Mr. Speaker, Ladies and Gentlemen of the House: I rise in opposition to my colleague on the Judiciary Committee, the gentleman from Portland, Mr. Childs. This bill having been amended, the problem of germaneness, if one ever existed, is not now before the House and cannot be questioned.

The purpose of this particular amendment is important. At the present time fifteen of our counties are in a position to take advantage of social security provisions for their Sheriff's Department. Unfortunately, at the time that law went through the County of Kennebec did not take advantage of the opportunity, and this bill here is a vehicle by which the Sheriff's Department of the County of Kennebec will be able to take advantage of that particular provision of the law, and I would support the bill and oppose the motion of indefinite postponement, and when the vote is taken I would request a division.

The SPEAKER: Is the House ready for the question? The question before the House is the motion of the gentleman from Portland, Mr. Childs, that "An Act Declaring Sheriffs to be Policemen for Purposes of Social Security," Legislative Document 1149, House Paper 796 be indefinitely postponed. A division has been requested.

All those in favor of the indefinite postponement of this matter will please rise and remain standing until the monitors have made and returned the count.

A division of the House was had. Thirty-two having voted in the affirmative and sixty-seven having voted in the negative, the motion did not prevail.

Thereupon, the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.
