Thursday, January 14, 1965 Senate called to order by the President.

Prayer by the Rev. Arthur Christopher of Augusta.

ORDERED, the House concurring, that when the House and Senate adjourn, they adjourn to meet on Tuesday, January 19 at ten o'clock in the morning. (S. P. 76)

Joint Orders

ORDERED, the Senate concurring, that Joint Rule 19B be amended by striking out the third paragraph of said Joint Rule and inserting in place thereof the following:

"The Clerk of the House shall cause Joint Rules 19A and 19B to be published in all daily papers in the State at least twice monthly for the two months immediately preceding the convening of the Legislature in regular session and Joint Rule 19B at least twice during January prior to the 3rd Friday of the month." (H. P. 109) Read and Passed in concurrence.

ORDERED, the Senate concurring, that the Joint Rules be amended by adding thereto a new Rule 19-E, to read as follows: "19-E. With the approval of the Committee on Reference of Bills, a bill or resolve may be presented jointly by not more than 2 members of the same branch." (H. P. 110)

Read and Passed in concurrence.

At this point, a Message was received from the House in the form of an Order delivered by the Hon. Jerome G. Plante, Clerk of the House to Senator Brown of Hancock.
