Bill, "An Act to Create a committee to Study Effect of Foreign Labor in Maine." (S. P. 16) (L. D. 29)

Which was Read a Second Time and Passed to be Engrossed, As Amended.

Sent down for concurrence.

Orders of the Day

Mr. SNOW of Cumberland: Mr. President, is L. D. 121, S. P. 60 in the possession of the Senate?

The PRESIDENT: The Chair will state that it is, having been requested by the Senator.

Thereupon, on motion by Mr. Snow of Cumberland, the Senate voted to reconsider its action of yesterday whereby it accepted the Majority Ought Not to Pass report of the Committee on Election Laws on Bill, "An Act Determining Position of Names of Candidates on Primary Ballot" (S. P. 60) (L. D. 121)

Mr. SNOW of Cumberland: Mr. President, I now move that the Senate accept the Minority Ought to Pass report on this bill, and for the following reasons I would like to speak on this for a moment.

I would point out to the members of the Senate that there are only eleven in this august body whose names are in the latter part of the alphabet. I would point out that in the House, with a membership of 151 there are but thirtynine members with their names in the latter part of the alphabet. I would also point out to the Senate that, with all consideration to the fairness of the Committee on Elections, that only one member of that committee has a name in the latter part of the alphabet. I would further point out to the Senate that my name, as you know, begins with "S", and I consider that I campaigned under hardship in my own county because not only did I have to campaign against the charm and attractiveness of the lady Senator but I was also handicapped because her name begins with "C" and was listed before mine on the ballot.

I would point out that this bill was drawn up after consultation with the Secretary of State's office and at that time there were no objections raised as to the drawing of the order of names by lot. Thank you.

The PRESIDENT: The Senator from Cumberland, Senator Snow, now moves that we accept the Minority "Ought to Pass" report on L. D. 121.

Mr. STERN of Penobscot: Mr. President, I would like to join in with Senator Snow because you know I have been running for office for the last twenty-five years, and it has just dawned upon me that the only reason that I have been defeated for the last twenty-five years is because my name begins with "S" and that is at the end of the list.

Mr. SMITH of Cumberland: Mr. President, I would like to join my brother colleagues with the "S".

Mr. MENDELL of Cumberland: Mr. President, although my name is in the middle, "M", I would like to register a yes vote. For a number of years, at least the last ten years that I have been watching particularly the House of Representatives in the City of Portland, regardless of party if you are in the first half of the ballot you are in, whether the ballot is split or whether the whole line goes in. Thank you.

Mrs. CHISHOLM of Cumberland: Mr. President, even if we drew lots I still would come out on top!

Mr. CAHILL of Somerset: Mr. President, as long as the lower half of the alphabet is going to gang up on the upper half, I shall have to side in with the upper half of the alphabet. I do not know whether anyone has ever studied into this or not, but they used to tell a story about a fellow who had a lot of horses, white horses and black horses, and they were discussing the problem of keeping these horses and so forth. One fellow came to the conclusion that you should never have white horses because it cost more to feed them than it did the black horses. The other fellow asked why. "Well," he said, "I don't know, unless it is that we have more of the white horses." Perhaps for that reason there may be more from the upper half of the alphabet elected to public office than there are from the lower half.

I move the bill be tabled.

The PRESIDENT: The Senator, having debated his tabling motion is out of order.

Thereupon, on motion by Mr. O'Leary of Oxford, the bill was tabled pending motion by Mr. Snow of Cumberland that the Senate accept the Minority Ought to Pass report.

On motion by Mr. Glass of Waldo, the Senate voted to reconsider its action taken earlier in today's session whereby (Item 1-26) Bill, "An Act Relating to Posting Land Against Hunting" (H. P. 493) (L. On motion by Mr. Letourneau of York, the Senate voted to take from the table the 4th tabled and unassigned item (S. P. 263) Bill, "An Act Relating to Application of Certain Carriers to Gasoline Road Tax" tabled by that Senator on February 2 pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on Taxation and sent down for concurrence.

On motion by Mr. Hoffses of Knox, the Senate voted to reconsider its action taken earlier in today's session whereby (Item 1-41) Bill, "An Act Relating to Elevators Used on Farms" (H. P. 508) (L. D. 661) was referred to the Committee on Legal Affairs;

and on further motion by the same Senator, the bill was tabled pending reference.

On motion by Mr. Shiro of Kennebec, the Senate voted to take from the table the 3rd tabled and unassigned item (H. P. 435) (L. D. 564) Bill, "An Act Relating to Taxes Paid by Town of Wells to Ogunquit Village Corporation" tabled by that Senator on February 2 pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on Legal Affairs in non-concurrence and sent down for concurrence.

On motion by Mr. Glass of Waldo, the Senate voted to reconsider its action taken earlier in today's session whereby (Item 1-90) Bill, "An Act Providing for an Additional Trial Term for York County" (H. P. 560) (L. D. 730) was referred to the Committee on Towns and Counties; and on further motion by the same Senator, the bill was tabled pending reference.
