JOINT RESOLUTION

Mr. Southard of Penobscot presented the following Resolution and moved its adoption:

In the Year of our Lord One Thousand Nine Hundred and Six-

Joint Resolution Protesting the Ordered Closing of VA Hospitals, Domiciliaries and Regional Offices.

WHEREAS, the Administrator of Veterans Affairs, Veterans Administration has summarily a nd publicly announced the intention of closing permanently thirty-one Veterans Administration facilities

throughout the nation, including eleven hospitals and four soldiers' home: and

WHEREAS, the Veterans Administration plans to transfer these veterans who are patients to other facilities, presumably including the Togus, Maine Veterans Administration hospital which is already filled to capacity, thereby creating hardships on Maine veterans; and

WHEREAS, the ordered closings of the Veterans Administration Regional Offices in New Hampshire and Vermont and the merging of their functions with the Boston Veterans Administration of fice raises grave doubts as to the future of the Togus Regional Office; and

WHEREAS, it was clearly the intent of the Congress of the United States, the veterans organizations and a grateful nation that our disabled veterans be cared for and that they and their dependents be rendered every possible assistance in applying for the other benefits to which they are rightly entitled; and

WHEREAS, the ordered closings of the Veterans Administration facilities will render undue hardship to our Maine veterans and their families, as well as those in New England and the entire nation, in seeking care and benefits;

NOW, THEREFORE, BE IT RE-SOLVED that the members of the United States Congress from the State of Maine are hereby urgently requested to use every possible means to cause the decision to close said facilities to be reversed; and

BE IT FURTHER RESOLVED that a copy of this Resolution, duly authenticated by the Secretary of State, be transmitted by the Secretary of State to the Honorable Lyndon B. Johnson, President of the United States; to the Honorable Ralph W. Yarborough, Chairman of the Senate Committee on Veterans Affairs; to the Honorable Olin E. Teague, Chairman of the Veterans Affairs Committee of the House of Representatives; to the Honorable William J. Driver, Administrator of Veterans Affairs, Veterans Administration; and to

Mr. CAHILL of Somerset: Mr. President, I move that we accept the Committee report and I would like to speak to the motion.

like to speak to the motion.

The PRESIDENT: The Senator may proceed.

Mr. President, CAHILL: this particular bill probably will affect more people in the State of Maine than any other legislation that we have before us. For some reason the committee feels unanimously that it should not pass. However we do have in our statutes at the present time laws that allow certain groups privileged communication, and certainly in the instance of religious leaders it would seem that they should enjoy the same privileged communications. Some of them must at times receive communications from people who perhaps have violated the law and they could be called before the courts at the present time and be made to testify and put in jail if they don't.

I would like just a little explanation from someone, if I can inquire through the Chair, as to why the report of the committee was this way, and any Senator may answer who so desires.

Mr. STERN of Penobscot: Mr. President, I would be very happy to answer Senator Cahill and explain as best I can briefly — which is difficult in regard to this particular bill.

I think it should be sufficient to say that there are two bills that are pending before our Judiciary Committee, and we felt that this particular bill was not worded so that we should decide it should pass. We still have under advisement a bill which is worded a bit differently and which purports to contain the same subject-matter with relation to statements of ministers, priests and rabbis. This bill has not been reported, we have not acted on it and we are still deliberating. We appreciate and understand that there is a lot of feeling on both sides in regard to this particular matter. I do not feel that this particular bill which we recommend "Ought not to pass" will affect our decision on the other bill, and there is a particular reason why we feel this "Ought not to pass" report should be accepted which has nothing whatever to do with the subjectmatter because we are still taking under advisement this bill which is still pending.

I might say that even though there may be a divided report on the other bill there are many reasons why there is so much feeling among lawyers on this particular bill. We feel that a s i d e from the demand on the part of the rabbis and the priests and the ministers that they should have the privilege of not being forced to testify, that this may open the door to many special groups such as physicians for instance, and before we know it we are going to have many groups that will demand that they be extended the same privilege.

Now we feel we are embarrassed because at present the only ones who have this privilege are the attorneys, and we are between the devil and the deep blue sea because if we do not vote to give others the benefit of this privilege many of you lay people are going to say the lawyers want it all their way. So we are between the devil and the deep blue sea, but I think that after we deliberate on this other bill which contains the same subject matter that we will come up with what I hope will be an intelligent decision that we hope will satisfy the members of this Senate. Thank you.

Mr. CAHILL: Mr. President, I would like to thank the Senator from Penobscot. I will bow to the will of the Committee and I am glad that there is other subject matter that will cover this, and I am sure I shall support it.

D. 8) Bill, "An Act Clarifying Excise Taxes and Fees for C a mp Trailers" tabled on February 11 by that Senator pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed in concurrence.
