### Orders of the Day

The President laid before the Senate the 1st tabled and today assigned item (S. P. 90) (L. D. 234) Bill, "An Act to Correct Errors and Inconsistencies in the Education Laws"; tabled on February 17 by Senator Brown of Hancock pending adoption of Senate Amendment A.

That Senator presented Senate Amendment A to Senate Amendment was read and adopted, Senate Amendment A as amended by Senate Amendment A was read and adopted, and the bill as amended was passed to be engrossed and sent down for concurrence.

The President laid before the Senate the 2nd tabled and today assigned item (H. P. 150) (L. D. 173) House Report, Ought to Pass in New Draft under title of "An Act Relating to Hours for Sale of Liquor" (H. P. 945) (L. D. 1065) from the Committee on Liquor Control on Bill, "An Act Relating to Hours for Sale of Liquor by Hotels and Class A Restaurants"; tabled on February 19 by Senator Jacques of Androscoggin pending that Senator's motion to accept the Ought to Pass Report; and that Senator moved the pending question.

Mrs. SPROUL of Lincoln: Mr. President, it was my understanding that on this bill there was supposed to be an amendment. This I learned from certain opposition to this bill. As for myself, I am opposed to it anyway, but, as I say, it is my understanding there was supposed to be an amendment. I also learned from talking with the Senator from Androscoggin that there was supposed to be an amendment, and he stated that this was not an easy bill to amend but that he would amend one somewhere along the line.

I fully recognize that will probably happen here, but I do feel that the opposition should at least have a chance to talk in hearing again and state their position rather than be lulled into a sort of sleep by the promise of an amendment. I therefore request that this be recommitted to the Committee on Liquor Control.

Mr. JACQUES of Androscoggin: Mr. President and members of the Senate: The Committee spent almost two hours trying to draw up this amendment to make this bill workable. As you know, in the summer time now they operate until one a.m. under the prevailing time, Eastern Daylight

Saving Time, and in the winter they operate until twelve o'clock, so we had to find a way to amend this bill.

The opposition agreed that this was a good bill. The only thing that they did not agree on is that we told them what we would do would be to take the two a.m. law, where you operate until two a.m. New Years unless it falls on a Sunday, and the Committee told them that we would go along with it, but when this new draft came out it was almost impossible to amend to make it workable. I did not know that this had not come true until we discussed it with the Attorney General's office and he told me that this bill was doing exactly what it says, and the liquor establishments would be open the year round until one a.m. except we have a special law that they may be open until two a.m. on New Years unless it falls on Sunday. Now I agreed with the opposition that there is another bill that we have in committeeand this is a new draft that we have on the table here today, Mr. President — that we would amend another bill to take away the two a.m. law. So I hope the members of the Senate do not go along with recommitting this bill. We have about thirty more bills that we have to hear; we have nine bills to be heard today, and I do not think that the committee would like to have this bill back again, so I hope the motion to recommit this bill does not prevail.

Mrs. SPROUL of Lincoln: President: As you well know, I tried to table this bill the other day in the hope that it would straighten itself out, but the good Senator from Androscoggin suggested that it be tabled until today. I haven't had a chance to understand the thing fully, and neither have I had a chance to talk with the opposition. I am not trying to slow up the session, if that is the thought here, but I would really like to see the bill recommitted and have another hearing or else have this lie on the table.

The PRESIDENT: The question before the Senate is on the motion of the Senator from Lincoln, Senator Sproul that the bill be recommitted to the Committee on Liquor Control.

Mr. JACQUES of Androscoggin: Mr. President, I ask for a division.

A division of the Senate was had. Two having voted in the affirmative and thirty-one opposed, the motion did not prevail.
