Wednesday, February 24, 1965

Senate called to order by the President.

Mr. JACQUES of Androscoggin: Mr. President, as I said yesterday, we had an executive session on this bill, we had a two-hour session debating this bill, and finally we got a new draft out changing the law permitting liquor to be sold until one a.m. the year

round, prevailing time. This new draft came out of committee unanimously "Ought to pass." The opposition to most of these liquor bills appeared before the committee favoring this bill. Now they say they do not like it and they are trying to amend it. If they amend it we are going back to the same old thing. As a matter of fact, during the summertime you will be operating until eleven so what good would this amendment do.

I move indefinite postponement of this Senate Amendment "A", Mr. President and I ask for a division.

The PRESIDENT: A division has been requested.

Mr. SHIRO of Kennebec: Mr. President, I would like to concur with Senator Jacques in his motion that this amendment be indefinitely postponed.

The PRESIDENT: The motion before the Senate is the motion by the Senator from Androscoggin, Senator Jacques, to indefinitely postpone Senate Amendment "A."

Mrs. SPROUL of Lincoln: Mr. President, I would like to ask a question through the Chair of the Senator from Androscoggin, Senator Jacques. Where is the amendment he was going to get out yesterday afternoon?

The PRESIDENT: The Senator from Lincoln, Senator Sproul, asks a question through the Chair of the Senator from Androscoggin, Senator Jacques, who may answer if he wishes.

Mr. JACQUES: Mr. President, I stated yesterday that I would not present an amendment to this bill and that this would be taken care of in committee. We had nine bills that we heard yesterday afternoon and we certainly did not have time to have an executive session. The executive session is slated for tomorrow morning, and this is when it will be taking place.

The President laid before the Senate the 1st tabled and today assigned item (S. P. 218) (L. D. 677) Senate Report, Ought not to Pass, from the Committee on State Government on Resolve Providing for Distinctive Name Tags for Members of the Legislature; tabled on February 17 by Senator Harding of Aroostook pending acceptance of the report; and on motion by Mr. Jutras of York, the resolve was retabled.

The PRESIDENT: At this time the Chair would like to recognize in the Senate Chamber a Girl Scout Group, No. 393. This group is from the Dow Air Force Base and they are accompanied by their chaperones, Mrs. M. G. Wassil and Mrs. Wiand from the city of Bangor. We welcome you here this morning and hope that you enjoy and benefit from your visit. The Chair would like to introduce the Senators from your county of Penobscot: Senator Bernard, Senator Faloon, Senator Southard and Senator Stern. (Applause)

On motion by Mr. O'Leary of Oxford, the Senate voted to take from the table the 15th tabled and unassigned item (H. P. 436) (L. D. 565) Bill. "An Act Providing for Safety Seat Belts for Motor Vehicles; tabled by that Senator on February 23 pending passage

to be engrossed.

Mr. O'LEARY of Oxford: Mr. President, I believe word has gone out pretty well as to what I intended to do this morning because I found on my desk a picture in today's Portland Press Herald of an automobile wrapped around a telephone pole, on Page 20 if anybody is interested in looking at it, and I do know who the culprit is.

However, Mr. President and members of the Senate, I believe very strongly about this bill and I believe it is not in the best interests of the citizens of the State of Maine. I believe that this is one step toward making it mandatory that we will in the near future have to wear them.

I think statistics will bear me out that every five years we have a turnover in automobiles in this state which costs us approximately three million dollars a year or fifteen million dollars every five years. This money is going out of the state and not staying in the state, and we are trying to get industries and tourists to come into the state and spend their money, but here we are trying to make Maine citizens send it out of the state.

As you know, these seat-belts are uncomfortable, they are not pleasant to sit on. In campaigning with my colleague, Senator Norris of Oxford, we spent the last two weeks in October traveling over two thousand miles in Oxford County and we never once put them on.

I do not believe at this time this is a very good bill and I think it is entirely unnecessary because most of the new cars will be coming through with them. It will be just the same as directional lights, and, as I said before, I think it is unnecessary, because I believe it is the first step in making it mandatory that we wear them. I move the indefinite postponement of this bill and all its accompanying papers.

The PRESIDENT: The motion

The PRESIDENT: The motion now before the Senate is the motion of the Senator from Oxford, Senator O'Leary, who moves the indefinite postponement of the bill,

L. D. 565.

Mr. SHIRO of Kennebec: President and members of the Committee on Transportation and members of the Senate: I think we have an opportunity at this time to contribute immeasurably to highway safety. I would like to state that the Committee on Transportation conducted a very thorough hearing in regard to compulsory installation of seat-belts on motor vehicles. I would like to state first of all that this particular bill pertains only to 1966 new model motor vehicles; it does not in any way affect any motor vehicle coming into the state or manufactured at this time or manufactured before 1966. The bill also does not make it compulsory to wear or use a safety seat-belt in a motor vehicle. The bill also provides only that seat-belts be furnished in the front seat of a motor vehicle. I think it is important for the members of the Senate to know these facts about the bill so that they can determine for themselves how it will be applied and how it will affect operators on our highways.

There were many, many persons — I say "many persons"—there were probably at least a dozen individuals who spoke before the Transportation Committee on this bill. There was absolutely no opposition whatsoever to this bill.

The requirement of this bill for the installation of seat-belts in the front seat of motor vehicles applies only to passenger automobiles, vehicles which would carry say up to eight passengers. This bill has been wholeheartedly endorsed by the Maine Highway Safety Committee, and as I have said, not only many persons connected with the Maine Highway Safety Committee endorsed this bill but also many who were connected with law enforcement and who had a great deal of experience with accidents which have occurred on our highways. It is strongly felt that this bill and the requirement that safety seat-belts be provided in the front seats of motor vehicles manufactured in 1966 would make a major contribution to safety on our highways, and I strongly urge the passage of this bill by the Senate.

Now I do not know who the "culprit" was that was responsible for the picture that appeared on Page 20 of the Portland Press Herald today. I can state that I was not responsible and I did not time the accident which occurred. However, for the benefit of those who may not have seen this particular photograph and read the excerpt, I would like to read it here, because I think it is extremely timely. It showed a picture of a motor vehicle which skidded into a pole, and it states here "The Driver Walked Away" and under the photo it states: "Mrs. Earl Smith, 30, of Buxton suffered only minor injuries when she skidded on Route 112 at Buxton and wrapped around a utility pole early Tues-day afternoon. State Trooper Edward Mendell, Jr. (I understand he is no relation to Senator Mendell) credited a seat belt Mrs. Smith was wearing with saving her life. Mrs. Smith, mother of four small children, was alone in the car." I can tell you now it was a serious accident. Now I am certain that in this instance a seat belt certainly may have prevented a fatality in this instance and may have saved the mother of four children, and I am certain that in the future it will save many more mothers and I am sure it will also prevent many serious injuries that otherwise would occur without the use of seat belts.

Now it has been brought out by the Senator from Oxford, Senator O'Leary, that this would compel persons to purchase seat-belts, but statistics were brought out before the Transportation Committee that an adequate seat belt could be purchased for as little as \$2.95. This is certainly a very small price to pay for a person's safety. I do not think that the requirement of seat belts would stand in any different position than requiring that someone have two red lights on the back of his vehicle. We know that through the years we have quired individuals to provide certain safety devices for their own safety as well as that of others, and I think at this time, with all the accidents that we have on the highways, which is giving us very serious consideration in regard to how we can prevent fatalities, how we can prevent serious injuries to individuals, that the passage this bill would certainly add im-measurably to safety. I think we would be doing a great disservice to ourselves and to the peo-ple of the State of Maine and to motorists and their passengers if we do not require that seat belts be provided. Most major manufacturers of motor vehicles are providing them, but not all of them are. I am sure the time will come when they will, and if this legislation is enacted by this Senate I am sure it will accelerate that time, and I am sure it would help save the lives many persons on our highways. I urge this Senate very strongly to pass this most beneficial legislation. Thank you.

Mr. JUTRAS of York: Mr. President, if Senator O'Leary had predicated his remarks with "down deep in your heart" I do not believe that I could at this time support and concur with his remarks. However, not having done that, I do fully concur with Senator O'Leary of Oxford in his remarks to the Senate.

I purchased a car in 1964 and this car came equipped with seat belts I never requested. I never used the seat belt once, and I therefore believe that this is an unnecessary piece of legislation and a waste of the taxpayers' money to effect such legislation at this time.

Mr. SHIRO of Kennebec: Mr.

President, I would like to ask for a division on that motion.

Mr. HILTON of Somerset: Mr. President, I had a minor automobile accident the first of the winter in the city of Waterville. I was going perhaps 25 miles an hour, following a car. The car ahead of me stopped. The first thing I thought of was to stop, and I did and I had about 18 inches to spare. I thanked the Lord I stopped in time and just about that time the rear of my car was hit by another car and it gave my neck a terrific snap. If I had had a seat belt, I don't think it would have helped any. I think it would have been worse.

Mr. JACQUES of Androscoggin: Mr. President, I am wondering—maybe the Chairman of Transportation Committee can enlighten me on this — I am wondering if a salesman traveling through Maine without seat belts, if he is compelled to have seat belts on a 66 car. Maybe the Chairman of the Transportation Committee could answer this.

The PRESIDENT: The Senator from Androscoggin, Senator Jacques, directs an inquiry through the Chair to the Chairman of the Transportation Committee who may answer if he chooses.

Mr. MENDELL of Cumberland: Mr. President, I did not follow the question. The bill as written provides that all sixty-six models have seat belts on the front seat only. Does that answer the Senator's question?

Mr. JACQUES of Androscoggin: Mr. President, that means that a salesman traveling through the state, coming from New Jersey or New York would have to stop at Kittery, stop at a garage in New Hampshire maybe before he gets into Maine because he might be arrested for not wearing seat helts

This is the way this seems to me; maybe it should be amended. I can't see it the way it is written now. This has come up before in the past two years. I've been around the legislative halls quite a few years and this has come up and it has been a very controversial issue. It has been

beaten many times and come up again. It could be good legislation. I have seat belts in my car and I didn't purchase the car with seat belts. I had them installed. But they are an awful bother. You either sit on them or they are outside the car dragging on the ground — if you don't wear them I mean. And another thing, we have Representative Cote. I don't know what he'd do. I don't know if they make them that big. I concur with the gentleman from Oxford, Mr. O'Leary.

Mr. MENDELL of Cumberland: Mr. President, I did not understand Senator Jacques. This does provide for Maine residents only.

In support of Senator Shiro, we spent one hour on this seat belt hearing. There was absolutely no opposition whatever. The passage of this bill would save over five thousand lives a year. If you want to sit on these seat belts, you can sit on them. However, if you do put them on, it is another safety measure and it will tend to cut down driver fatigue. would like to mention once again that we spent at least an going over this to make sure it was correct at our executive session. There was absolutely no opposition to this and I would predict that ten to fifteen years from now through education, you are going to put your seat belt on when you get into your car just like you snap on a seat belt when you get in a plane.

I ask for a division if one has not already been requested.

Mr. GLASS of Waldo: Mr. President, may I ask Senator Mendell a question through the Chair?

The PRESIDENT: The Senator may.

Mr. GLASS: Mr. President I am referring specifically to his reference to the saving of five thousand lives a year. I would like to know the source of his information.

The PRESIDENT: The Senator from Waldo, Senator Glass. directs an inquiry through the Chair to the Senator from Cumberland, Senator Mendell who may answer if he chooses.

Mr. MENDELL: Mr. President,

I don't have that source here but I will be willing to furnish it to Senator Glass.

Mr. SHIRO of Kennebec: Mr. President, it is my understanding that the source of that particular statistic, that it would save five thousand fatalities, was issued by the Maine Highway Safety Committee. I think it appeared in one of their circulars. I would also like to state at this time that according to the statistics produced at the hearing, it has been scientifically investigated and substantiated that safety seat belts without any question save lives and also prevent serious injuries.

Mr. STERN of Penobscot: Mr. President, as I sat here listening to the arguments pro and con I debated with myself whether or not I should get up and say anything. You see I have a selfish motive. Being a practicing attorney for the last thirty-one or thirty-two years, I have primarily handled negligence cases which often resulted in tremendous injuries, and I want you people to know that Senator Shiro certainly has an abiding sense of what is right, because I know he also handles negligence cases and, despite the fact that many of us who are attorneys handle these cases. I have seen enough of these cases to know that if we did have seat belts I perhaps would not be as wealthy as I am today. I want to say that I want to concur whole-heartedly with Senator Shiro's remarks. I feel that the belts should be there in the event people want to use them, and I am sure, as Senator Mendell remarked that it will only be a matter of education and time before people will become accustomed to their use and use them. So I want to go along with Senator Shiro in the passage of this bill.

Mr. O'LEARY of Oxford: Mr. President and members of the Senate: The Senator from Penobscot, Senator Stern, made an interesting statement just now on negligence. Now it could appear that if you had an automobile with safety seat belts and you were in an accident and it was the fault of the other automobile and you didn't have your seat belts fas-

tened and you sustained injuries perhaps you would be the one that was negligent and receive

no compensation.

Now a statement there was made here that if this bill was to pass it would save five thousand lives per year. However, I do not think we have had five thousand deaths in the State of Maine since we have had automobiles. We have lights and we have directional signals and we have brakes and windshield wipers on our automobiles. These are all safety measures, safety for the operator and safety so that he may not strike another automobile. As we drive down the highways we are liable to be stopped at any time by a state patroland our automobile spected. They inspect our lights, our brakes, our mufflers and everything else, and we have these automobiles inspected twice a year under the law as it is now. I believe this piece of legislation is just the first step in making it mandatory that we wear these I believe these belts will come with the new cars anyway, and I believe if we pass this measure that you won't be able to buy any seat belts for \$2.98, they will be \$25 or more.

I still believe this is not a good bill. I voted against it two years ago when it was killed and I will vote against it again here

today.

Mr. MOORE of Washington: Mr. President and members of the Senate: As a result of being a socalled "Downeaster," I sometimes have the reputation of being very hard to convince. Nevertheless, as a result of recently installing these seat belts in my own personal automobile and after realizing the comfort and safety possibilities which I feel have resulted. I would like to go on record as concurring with Senator Shiro, and I personally feel that the passage of this legislation would add tremendously to the future highway safety of our citizens. Thank you.

Mr. HOFFSES of Knox: Mr. President, I think perhaps there is a further clarification of these five thousand lives in order. I think that my good colleague Sen-

ator Mendell means throughout the United States and not just the State of Maine.

Mr. SNOW of Cumberland: Mr. President, last December during the pre-legislative conference Bangor, as most of the Senate knows. I and a considerable number of legislators were involved in a six-car collision. I was informed after the accident by the trooper who investigated it that the fact that I was wearing seat belt probably saved me from serious injury. This alone convinces me of the value of having these seat belts in our automobiles, and I would support bill.

Mr. GIRARD of Androscoggin: Mr. President, I move the previous question.

The PRESIDENT: The motion before the Senate is the motion to move the previous question. Does the Chair hear objection? The Chair hears none.

The question before the Senate is the motion of the Senator from Oxford, Senator O'Leary, that L. D. 565 and all accompanying papers be indefinitely postponed. A division has been requested.

A division of the Senate was had.

Mr. Brown of Hancock was granted permission to withdraw his motion to recede and concur and on further motion by the same Senator, the Senate voted to reconsider its former action whereby the bill was passed to be engrossed; that Senator then yielded to the Senator from Aroostook, Senator Manuel.

Mr. Manuel of Aroostook presented Senate Amendment A and moved its adoption.

Senate Amendment A was read and adopted, House Amendment A was read and adopted, and the bill as so amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.

On motion by Mr. Carter of Kennebec, the Senate voted to take from the table the 12th tabled and unassigned item (S. P. 404) Bill, "An Act Providing for Compulsory Retirement of Teachers at Age 65; tabled by that Senator on February 19 pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on Labor and sent down for concurrence.

The PRESIDENT: The Chair would like to recognize in the Senate Chamber two boy scouts, Warren King and Thomas Lynch from the town of Glenburn. These boys are here today earning their citizenship merit badge. We hope that you enjoy and benefit from your stay here. Their chaperone is Louis King. The Chair would like to introduce the Senators from your County, Senator Bernard, Senator Faloon, Senator Stern and Senator Southard of Penobscot County. (Applause)

On motion by Mr. Carter of Kennebec, the Senate voted to reconsider its former action where (Item 3-17) Bill, "An Act Relating to Compensation Rates in Certain Technical and Professional Classifications" (S. P. 438) was referred to the Committee on State Government; and on further motion by the same Senator, the bill was tabled pending reference.

The Joint Adjournment Order having been returned from the House, read and passed in concurrence, the Senate

Adjourned until Friday next at ten o'clock in the morning.
