Wednesday, March 3, 1965

Senate called to order by the President.

On motion by Mr. Smith of Cumberland, the Senate voted to reconsider its action whereby it accepted the "Ought not to pass" report of the committee. On further motion by the same Senator the Senate voted to substitute the bill for the report of the committee and the bill was given its first reading. Mr. JUTRAS: Mr. President, the reason why I am removing this from the table is because I believe that to keep an item tabled for an indefinite period of time is costly to the taxpayers of the State, and for that reason I deem this action to be proper and I believe that it should be considered by all of the Senators here, to remove these tabled items as soon as possible where it serves no purpose to keep them on the table indefinitely. So, with that in mind, I now move that we accept the "Ought to not pass" report of the committee.

Mr. Dunn of Kennebec moved the Acceptance of the Majority— Ought to Pass, as amended, Report.

Mr. MAXWELL of Franklin: Mr. President and members of the Senate: I am sure perhaps I am going to be called a pimple on the nose of progress this morning, but I am very much opposed to declassifying the waters of any stream in the State of Maine, regardless of the consequence. I feel that this is a wrong step, a wrong move and a move in the wrong direction. For this reason, I would move that this matter be tabled until Friday.

The PRESIDENT: Would the Senator please approach the rostrum?

(Conference at the rostrum)

Mr. MAXWELL: Mr. President. I would withdraw my motion to put this matter on the table until Friday. I would ask for a division though on the bill and hope that you will see fit to go along with me, because very definitely if we start allowing streams to be declassified in two years we will have a flood of bills in here asking that we declassify waters all over the State of Maine. I feel that the big paper companies, International Paper Company, Oxford Paper Company and others, have done a remarkable job over the past ten years of cleaning up the waters of the State. I feel that it won't be too long before Uncle Sam steps in and tells us we must do something regarding water running into our coastal waters. I won't debate this any longer this morning, but for these reasons I am much opposed to declassifying any waters.

Mr. CAHILL of Somerset: Mr. President, I must defend my signature on the majority "Ought to pass" report. I, like the Senator from Franklin, am a little red-faced, perhaps more so than he, however, I do understand from reliable sources that in order for this thing to get started they must have action now, and that when it does get going and during the process of operation that there will be a disposal unit installed in that area to take care of this situation. Under those circumstances, I have signed the majority "Ought to pass" report, and I do hope that it passes.

Mr. JACQUES of Androscoggin: Mr. President, I do not think we are doing any more than what we did two years ago when we expected one of the industries when

we had the other administration and this thing went through the Senate here like a bullet goes through a body. I do not think we are doing anything difficult, and I think, Mr. President, that at the time you opposed declassifying one of those rivers. Another thing, it never had a hearing like this one has had, that is the Water Improvement Commission was never even notified of this bill because they were not supposed to be. So I do not see anything wrong in this bill going through the way it is today. Thank you.

The PRESIDENT: The motion before the Senate is the motion of the Senator from Kennebec, Senator Dunn, that the Majority Report Ought to Pass be accepted. A division has been requested.

A division of the Senate was had.

The PRESIDENT: The Chair would like to be recorded as opposed to the motion.

Twenty-eight having voted in the affirmative and two in the negative. the motion prevailed; the bill was read once, Committee Amendment A was read and adopted and House Amendment A was read and adopted.

Thereupon, on motion by Mr. Harding of Aroostook, the rules were suspended and the bill was given its second reading and passed to be engrossed as amended in concurrence.
