Mr. Edwin H. Pert Secretary of the Senate State of Maine State House Augusta, Maine Dear Mr. Pert:

This will acknowledge receipt of your letter and the attached reso-

lution which you sent me. (Joint Resolution, H. P. 1030, March 12th)

I would like the members of the Maine House and Senate to know that Northeast does have a firm schedule for the summer perioda schedule we believe to be a good one, one that can be operated dependably and safely. As you know, a very substantial part of our Maine traffic originates and terminates at the Portland. Bangor and Presque Isle airports, and you will be pleased to know that this year our availability of seats and frequency will compare most favorable with and the bill most favorably with any schedule we have ever performed.

With respect to the smaller airports where we, of necessity, must operate DC-3s because of airport limitations, it is our belief that this schedule, also, will meet with favor as the frequency of flights, the times of departure are attractive from the public standpoint.

We look forward to an unprecedented volume of passenger traffic to and from our Maine cities this coming summer season.

The PRESIDENT: The Chair at this time takes great pleasure in announcing the presence in the Senate Chamber Of Maine's Junior Miss, Miss Barbara Foote. Barbara is 18, an honor student and a Senior at Caribou High School. She was second runner-up in America's Junior Miss Pageant at Mobile, Alabama, last week. The Town of Caribou has proclaimed this week "The Barbara Foote Week."

Saturday she will be a guest "disk jockey" for a record show over WEGP in Presque Isle. A motor parade this Saturday will take Miss Foote to the General Carter Armory for a reception in her honor.

Miss Foote is accompanied by Robert Hemingway, Executive Manager of the Caribou Chamber of Commerce and Mrs. Boyd Tankersley of the Chamber staff.

The Chair would now ask that the Sergeant-at-Arms please escort Miss Foote to the rostrum for the purpose of being recognized and to address the Senate.

Miss Foote was accompanied to the rostrum by the Sergeant-at-Arms amid the applause of the Senate, the members rising.

Miss BARBARA FOOTE: Thank you, Mr. President.

Ladies and gentlemen: it is indeed an honor to be here as it was an honor to be in Mobile representing the State of Maine.

Some people seem to have a mistaken idea about the Pageant. A lot of people turned on their TV's Friday night and said, "Oh no, not another one of these beauty contests." But it wasn't that, it was different. We were judged on poise, on personality, our talents, our general appearance and on scholarship which played such an important part in this Pageant. In most other pageants the winner is taken out of school for a year to complete her tours, but where scholarship is such an important part of this pageant taking our winner out of school would be defeating our main purpose. We get scholarships for placements. The winner received a \$6,000 scholarship, I received a \$2,000 scholarship, and this a very important port of the pageant.

I found it quite difficult to make people realize that I was not from the sticks and that Maine was just as great as any other state. They didn't think we had any electricity, they really believed that we had dog sleds up here, they think we all come from one-room schoolhouses and villages of about fifty or sixty people apiece. Some of the ideas they have are remarkable. I started talking about Maine potatoes. Of course I am from Aroostook County so I really had to advertise those. They had never heard of Maine potatoes; they thought that Idaho was the only state that grew potatoes.

state that grew potatoes. So advertising the State of Maine was really my job last week and I enjoyed it. I again thank you for asking me here today to address you, and I thank everybody that I had the opportunity to represent the State of Maine. Thank you. (Applause)

The PRESIDENT: The Chair would like to thank Miss Barbara Foote and we wish you well.

On motion by Mrs. Sproul of Lincoln, the Senate voted to take from the table the 2nd tabled and unassigned item (H. P. 94) (L. D. 103) Bill "An Act Relating to License for Sardine Packers"; tabled by that Senator on February 16 pending passage to be enacted.

Mrs. SPROUL of Lincoln: Mr. President, in reference to L. D. 103 and also L. D. 104, I would like to make some remarks and I would like to read some letters which I have. One of them says:

"I have been in the sardine industry for thirty years, and during that time when herring was caught was between December 15th and May 1st. 90 per cent of these were caught by purse seines and not fit for sardines and generally go to fish meal plants. The bill would have a tendency to affect the price the rest of the year. I, for one, am certainly opposed to year-round seining."

I have another letter from Green Island Packing Company:

"I would like to bring to your attention two bills, L. D. 103 relating to licenses for sardine packers and 104, "An Act Repealing the Law Relating to the Canning of Herring." These bills are just to cover up to allow some sardine packers to pack Canadian fish during the State of Maine closed season" and so on.

I have one from Port Clyde Packing Company:

"Dear Senator Sproul:

This letter is being sent to you to bring your attention to two bills, L. D. 103 and 104. Our industry — and you can confirm this from Mr. Richard Reed — the above bill should be put in to cover up for a few sardine packers who want to pack Canadian fish" etc.

I am reading these letters because I have been criticized for keeping this bill on the table for so long.

I have something else I would like to say: The fishermen in New Harbor, which is in my County of Lincoln, do not fish in the winter, they are not equipped for it and it has not been their custom, nor are they interested in packing or catching fish at this time of year. The belief is that if fish are packed now it will cut down the value of the fish the year round.

Placed on my desk as if by accident last Friday was the Cour-Gazette with a front page ier spread referring to fish caught off Pemaquid. I deliberately took no action on this so I could see what the fishermen in Lincoln County did during the past week. Not one approached me, so it shows there is no great interest in Lincoln County as far as fishing goes in the winter. However, I find on that the industry is divided this, and so, for that reason, I am going to allow the Senator

from Washington County to make the motion on this bill.

Thereupon, on motion by Moore of Washington, the bill was passed to be enacted.

On motion by Mrs. Sproul of Lincoln, the Senate voted to take from the table the 4th tabled and unassigned item (H. P. 95) (L. D. 104) Bill, "An Act Repealing the Law Regulating the Canning of Herring"; tabled by that Senator on February 23 pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed.

Mr. HARDING of Aroostook: Mr. President, I would like to inquire if H. P. 6, L. D. 6, Resolve Proposing an Amendment to the Constitution to abolish the Council and make Adjustments in the matter of Gubernatorial Appointments and their Confirmation, is in the possession of the Senate?

The PRESIDENT: The Chair would inform the Senator that it is, having been held at the request of the Senator.

Thereupon, on motion by Mr. Harding of Aroostook, the Senate voted to reconsider its action whereby the resolve was passed to be engrossed; and to further reconsider its action whereby Committee Amendment A was adopted.

The same Senator then presented Senate Amendment A to Committee Amendment A and moved its adoption.

Which amendment (S-81) was read and adopted and Committee Amendment A as amended by Senate Amendment A was read and adopted.

Mr. Harding of Aroostook then presented Senate Amendment A to the resolve (L. D. 6) and moved its adoption.

Senate Amendment A (S-82) was read and adopted, and the bill as amended was passed to be engrossed in non-concurrence.

Sent down for concurrence.

On motion by Mr. Carter of Aroostook, the Senate voted to take from the table the 6th tabled and unassigned item (S. P. 438) Bill, "An Act Relating to Compensation Rates in Certain Technical and Professional Classifications"; tabled by that Senator on February 24 pending reference to a committee; and on further motion by the same Senator, the bill was referred to the Committee on State Government.

Sent down for concurrence.

Mr. Jacques of Androscoggin was granted unanimous consent to address the Senate.

Mr. JACQUES: Mr. President, on behalf of myself, and I know I speak for many other members of this body past and present, I want to express my appreciation to you, to the Senator from Hancock, Senator Willey, the Sena-tor from Washington, Senator Moore, and the Secretary of Senate, Mr. Pert, as well the 25 members of the other body who served on the Welcome Back Day committee. Wednesday was a day that we will always remember as being overwhelmingly successful in every respect. It was a wonderful opportunity to renew friendships with former legislators and to enjoy a splendid joint convention and a delicious lunch. It was undoubtedly the most suc-cessful Welcome Back Day in the history of Maine legislatures. I did not want the fine work of all those who planned that day's activities to go unnoticed in the record. Again may I say that I deeply appreciate all of the effort that went into making this day a memorable one.

Mr. President, I would like to have the members of the Senate applaud the members who served on that committee. (Applause)

The PRESIDENT: The Chair would thank the Senator for his remarks.

On motion by Mr. Harding of Aroostock, the Senate voted to take from the table the 17th tabled and unassigned item (S. P. 153) (L. D. 394) Senate Reports from the Committee on State Government on Resolve Proposing an A m e n dment to the Constitution to Lower the Voting Age to Eighteen Years; Majority Report, Ought Not to Pass; Minority Report, Ought to pass; tabled by that Senator on March 16 pending acceptance of either report; and the same Senator moved acceptance of the Minority Ought to Pass report.

Mr. GLASS of Waldo: Mr. President, I would request a division on the motion.

A division of the Senate was had.

Twenty having voted in the affirmative and five in the negative, the motion prevailed and the Minority Ought to Pass report was accepted, the bill read once and tomorrow assigned for second reading.

Mr. Shiro of Kennebec was granted unanimous consent to address the Senate.

Mr. SHIRO of Kennebec: Mr. President, in regard to Item 17 on Page 11, I would like to have the Senate reconsider my vote. I had not realized that the Majority report was the Ought Not to Pass report and since this is a bill which I sponsored, I don't want to be on record as having opposed my own bill.

The PRESIDENT: The Chair cannot change the vote unless the Senate reconsiders its action whereby the bill was passed, but the record will show the Senator's remarks. The PRESIDENT: The Chair would like to recognize in the Senate, the husband of one of our Senators, Senator Chisholm. Would Mr. Chisholm please stand and be recognized? (Applause)

The Chair would also like to recognize in the balcony a group of Winslow High School students. This is the senior class in Problems of Democracy and they are chaperoned bv Ravmond Richard and Charles O'Leary. They are from Winslow and that is Kennebec County so the Chair would like to introduce the Senators from that County, Senator Shiro, Senator Dunn and Senator Carter. We welcome you here today and hope that you enjoy and benefit from your stay. (Applause)

The Chair would also like to recognize in the Senate a former Senator from Penobscot, Senator Harrington and we ask her to stand and be recognized. (Applause) Also present in the Senate this morning is the wife of one of our Senators. Would Mrs. Stern, the wife of Senator Stern, please stand? (Applause)

The Adjournment Order having been returned from the House, read and passed in concurrence, the Senate

Adjourned until Tuesday next at ten o'clock in the morning.
