Mrs. SPROUL of Lincoln: Mr. the President and members of Senate: This bill is similar to the same one before it went back to committee and came out in the new draft. As I have explained to the Senator from Cumberland, I have one academy with forty-five or fifty pupils in it, I also have a school in the town in which I live with 120pupils. twenty of which come from another town. It plainly can be seen that if we should lose the twenty from the other town we might come under this bill. As far as I can see, the payment must be made by the town and many school pupils may go to another town for courses in science, math and language. Now we offer one language, we do not offer another although presumably two would be better. I have discussed with the Department of Education in the past whether we should teach two, and I find that in most Maine colleges four years of one language is sufficient. I have discussed this with someone from Dresden, which is one of the academies I am concerned with, and they pose the question: What does Science include? That is something I would like to have answered. Also, what does the committee mean by "Mathematics' ? Does it include geometry and the various other phases of mathematics?

I do not like to disagree continually with the Senator from Cumberland but I cannot honestly sit here and represent my county and go along with legislation such as this. I therefore am against the motion of Senator Snow and I move the indefinite postponement of this bill.

Mr. SNOW of Cumberland: Mr. President, the basic purpose of this bill has been debated here before. Its purpose is to permit those young people who attend a small high school, a high school with fewer than 100 pupils and a high school which does not offer courses that satisfy their requirements for admission to college or for the purpose of pursuing some particular occupation later on, this permits them to transfer to a larger school where they may take the courses which they require.

This bill was recommitted to the Education Committee to accommodate Senator Sproul and to accommodate another Senator. We have number of made а changes which I think gives additional protection against the impetuous transfer of unqualified pupils. The redraft is changed in this respect from the original: the pupil desiring to transfer must obtain permission of the school board in the town where the high school is located. If permission is not granted and if the pupil or his parents desire to pursue the matter further, they may appeal to the Commissioner of Education who shall be the final judge in the matter. The Education Committee unanimously believes that this is a good bill, we do not desire to see it further amended, and I ask the Senate to defeat the motion for indefinite postponement.

Mrs. SPROUL of Lincoln; Mr. President, I still repeat I am afraid of this bill. I have watched bill after bill come through the Senate, I sat quietly by a short time ago while the motion went through for studying school districts. Presumably that is the direction in which we are heading, but I do not like to be continually forced into something and I do not believe anyone does. I appreciate the thought of the Senator from Cumberland that this bill might make for better education of children. So it might. But the expense, as I see it, is still going to fall on the individual towns. I therefore cannot go along with this bill.

Mr. HARDING of Aroostook: Mr. President and members of the Senate: First of all, I would like to say that this is not a party bill, and, secondly, I would like to say that it is not a personal bill.

My only interest in this matter is for good education which I think is a matter of concern to both parties. Now I believe it should also be clear to the members of the Senate that this is not an attempt to make any school unit do any particular thing. The only purpose is to provide an opportunity for some child who would like to go to college to have the courses offered in his school so that he may go to college. Now those courses are quite limited so far as the bill is concerned: it is only a two-year course in mathematics, science or a foreign language. Now let's face it: if there is any high school in this state which does not offer those kind of things to a boy or a girl who wants to go to college, they should be offered.

There is a protection here also that this child just cannot do this for no purpose; it has to be approved by the school committee, and I think that is a pretty good safeguard.

I think there is also another built-in safeguard. All you members of the Senate know how reluctant a particular child is to go to another school. He has his loyalties to his friends and he wants to stay here, and so, as a practical matter, there is not going to be any wholesale trans-fer of students in a case like this. This just provides an opportunity so that some child who wants to go to college and his high school does not offer the courses which will permit him to go to college, to transfer and get that kind of education which he needs. It seems to me that this is something which we all ought to be in sympathy with. It is not going to be a particularly expensive thing to anyone concerned. I think this is a good bill, I would like to see it pass. I would ask for a division on Senator Sproul's motion and I hope that her motion is defeated.

Mr. O'LEARY of Oxford: Mr. President. in this new redraft bothers me, the word "elect". I would much prefer the original bill with the amendment which I was going to offer. This bill as presented in the new draft is a lot more acceptable than the bill in its original form. I am not against education and I am hard-pressed to support the motion to indefinitely postpone and I am hard-pressed to support the Chairman of the Committee on Education. I would like to see the original bill substituted for the new draft and then amend it as I have proposed. That is all I have for comments on this bill.

Mr. HOFFSES of Knox: Mr. President, I may be out of order but I move that this item lie on the table until Wednesday next.

The motion prevailed and the bill was tabled until Wednesday next pending the motion of Senator Sproul of Lincoln that the bill and all accompanying papers be indefinitely postponed.

P. 384) (L. D. 1200) and on further motion by the same Senator, the bill was tabled pending acceptance of the report.

On motion by Mr. Jacques of Androscoggin, the Senate voted to take from the table the 15th tabled and unassigned item (S. P. 154) (L. D. 1124) Bill, "An Act Authorizing Androscoggin County to Raise Money for Garage and Court House Capital Improvements"; tabled by that Senator on March 19 pending enactment, and on further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Jacques of Androscoggin, the Senate voted to take from the table the 22nd tabled and unassigned item (H. P. 514) (L. D. 667) House Report, Ought to pass as amended by House Amendment "A" on Bill, "An Act Providing for Vacation Time for Employees of City of Lewiston"; tabled by that Senator on March 31 pending acceptance of the report; and on further motion by the same Senator, the report was accepted, the bill read once, Committee Amendment A read and indefinitely postponed; House Amendment A read and adopted, and the bill tomorrow assigned for second reading.

On motion by Mr. Violette of Aroostook, the Senate voted to take from the table the 12th tabled and unassigned item (H. P. 633) (L. D. 858) House Report, Ought to pass as amended by Committee Amendment A from the Committee on Judiciary on Bill, "An Act to Clarify the Civil Liability of Civil Defense Shelter Owners"; tabled by that Senator on March 17 pending acceptance of the report; and on further motion by the same Senator, the report was accepted, the bill read once, Committee Amendment Α read and adopted and the bill as amended was tomorrow assigned for second reading.

On motion by Mr. Harding of Aroostook, the Senate voted to take from the table the 17th tabled and unassigned item (H. P. 25) (L. D. 203) Bill, "An Act Repealing Milk Control Prices at the Retail Level"; tabled by that Senator on March 24 pending motion by Senator Hilton of Somerset to indefinitely postpone the bill and reports; and the motion to indefinitely postpone prevailed.

Mr. BOISVERT of Androscoggin: Mr. President, I would like to inquire if H. P. 535, L. D. 709, Bill, "An Act Relating to Retirement of Employee Option by Local Districts under Maine State Rement System" is in the possession of the Senate?

The PRESIDENT: It is, having been recalled from the Governor's office.

On motion by Senator Boisvert, the Senate voted to reconsider its action whereby the bill was passed to be enacted, and on further motion by the same Senator voted to reconsider its action whereby the bill was passed to be engrossed. The same Senator presented Senate Amendment "A" and moved its adoption. Senate Amendment "A" was read and adopted and the bill was passed to be engrossed in non-concurrence and sent down for concurrence.

On motion by Mr. Harding of Aroostook, the Senate voted to take from the table Item 24 on the tabled and unassigned list, (H. P. 421) (L. D. 533) Bill, "An Act Relating to Hours of Moving Pictures on Sunday," which was tabled by that Senator on March 31, 1965 pending enactment.

On motion by Mr. Shiro of Kennebec, the Senate voted to reconsider its action whereby the bill was passed to be engrossed. The same Senator presented Senate Amendment "A" and moved its adoption. Senate Amendment "A" was read and adopted and the bill was passed to be engrossed as amended.

The adjournment order having been received from the House, the Senate adjourned until ten o'clock next Tuesday.
