Tuesday, April 13, 1965

Senate called to order by the President.

Prayer by Rev. Thomas Nelligan of Augusta.

The President laid before the Senate the 1st tabled and today assigned item (H. P. 436) (L. D. 565) Bill, "An Act Providing for Safety Seat Belts for Motor Vehicles"; tabled on April 6 by Senator Mendell of Cumberland pending consideration; and on motion by Mr. Shiro of Kennebec, the Senate voted to insist on its former action and ask for a committee of conference.

The President laid before the Senate the 2nd tabled and today assigned item (S. P. 163) (L. D. 493) Bill, "An Act Authorizing the Leasing by the State of Wing of Community General Hospital Fort Fairfield to the Hospital"; tabled on April 6 by Senator Chisholm of Cumberland pending enactment.

Mr. HARDING of Aroostook: Mr. President and members of the Senate: This is not a party measure, it is a measure which I sponsored at the request of the citizens of Aroostook County and more particularly the Aroostook Mental Health Services. I now move the pending question.

move the pending question.
Mr. BROWN of Hancock: Mr. President, to be consistent the action which I took terms ago in the unmentionable body at the other end of the hall, I must move for the indefinite postponement of this bill. If this was an outright gift for dollar to the town of Fort field I would be all for it where there is still a ten-year lease agreement I am definitely opposed, and when the vote is taken, Mr. President, I request a division.

Mr. HARDING of Aroostook: Mr. President, I would like to speak briefly on the motion of the Senator from Hancock, Senator Brown.

The PRESIDENT: The Senator may.

Mr. HARDING: Mr. President, I would like to mention first of all that it has been said here in the legislative halls that when this bill was originally passed to construct this hospital it was not a wise decision. In hindsight we may say that is so, and yet I suspect that some of the decisions which we make at this legislature which we feel we have made in all due wisdom other legislators in other times will say that we did not act wisely, although I hope that will not be the case in too many instances.

In this particular case we have facility which is remaining vacant and is costing the State of Maine \$12,000 a year to keep this facility empty. It has been kept empty now for three years and we are going on four years having it thus. I would also mention that there comes to our attention the Appropriations Committee other empty facilities in the State of Maine. We have one down at Hebron which it costs the State of Maine \$30,000 a year to keep empty. We have another one at Presque Isle which costs the State of Maine another \$30,000 a year to keep empty.

It is the purpose of this bill to use this facility—and whether it was constructed wisely or unwisely is beside the point the purpose of this bill is to make use of this facility. Now I will mention that this bill has discussed with the Commissioner of Mental Health and Corrections, Mr. Ulmer, and he spoke favor of it at the hearing. It has been discussed with Dr. Schumacher of Mental Health and it has his approval and he in favor of it at the committee hearing. It also has been discussed with Dean Fisher of the Department of Health and Welfare and it has his approval.

Now this hospital proposes to pay the State of Maine for this building not in money but they propose to pay them in services. As I mentioned to you, the State over this ten-year period that this lease provides will have saved over keeping the building empty in insurance costs and what have you, they will have saved \$12,000 a year or \$120,000 over this ten-year period. The Community General Hospital has agreed to provide certain services for the out-patient treatment of mental health patients, which program has the endorsement of Aroostook County, and the value of those services which the Community Hospital estimates -and which, I might add, Dr. Schumacher says have been estimated too low - is another \$12,000 a year, which makes another \$120,-000 which the hospital will have contributed in services over this ten-year period. In addition, the Community General Hospital has agreed to provide to the State of Maine out-patient treatment facili-ties for T.B. patients for a period of twenty-five years. The value of those services has been estimated at \$3000 a year or \$75,000. In addition I might mention that the Community General Hospital has already paid for land and equipment for this facility the sum of \$25,300. So at the end of this twenty-five year period during which the Community General Hospital is bound to provide services to the State of Maine they will provide, in the value of services and savings to the State a total of \$340,300. But, more than that, this facility will lend itself to the inauguration of a mental health program which is a pilot program for the entire State of Maine.

I think you people here were as deeply moved as I was by the speech of Dr. Menninger at Orono about the treatment of our mental patients, how years ago we arrested them, we put them in jail and then they were confined to mental institutions. We are getting away from that now, thank the Lord, and this is the start of a program whereby these mental patients will go to a hospital just like any other sick person and be treated like any other sick person, the way they ought to be treated; there will be a psychiatrist hired and he will be there and the Community General Hospital has guaranteed under this arrangement that they will always have ten beds available for the

treatment of our mental patients in Aroostook County.

This program has received unanimous endorsement from the doctors of medicine throughout Aroostook County. One of the leading doctors was here to speak in behalf of it, Dr. Smith of Presque Isle. I would mention also that the County of Aroostook, in a very unusual move, appropriated from its county budget this year \$15,000 and they will appropriate \$15,000 next year for the inauguration of this mental health program. This is how bad they want it.

So I think this is a good program, I think it has been wisely conceived and if a mistake has been made in the past at least now we can make use of these facilities, put them to work, save the State money and at the same time provide a very useful program to Aroostook County and to the entire State of Maine. Therefore I would hope, in all due deference to my colleague, whom I esteem and respect, the Senator from Hancock, Senator Brown, that you would vote against his motion for indefinite postponement.

The PRESIDENT: The motion before the Senate is the motion to indefinitely postpone L. D. 493. A division has been requested.

Mr. SNOW of Cumberland: Mr. President, I would like to ask the Senator from Aroostook through the Chair what the committee report was on this document.

The PRESIDENT: The Senator from Cumberland, Senator Snow, poses a question through the Chair to the Senator from Aroostook, Senator Harding, who may answer if he so chooses.

Mr. HARDING of Aroostook: Mr. President, the committee report on this particular bill — and I would mention that there was not a single member of the committee who was from Aroostook County—after hearing all of the testimony in regard to the bill they reported it out unanimously "Ought to pass."

Mrs. SPROUL of Lincoln: Mr. President, I would like to ask a question through the Chair of the Senator from Aroostook. Do I understand that this is the program

which takes care of the children who are mentally retarded?

The PRESIDENT: The Senator from Lincoln, Senator Sproul, directs a question through the Chair of the Senator from Aroostook, Senator Harding, who may answer if he chooses.

Mr. HARDING: Mr. President. in answer to the Senator from Lincoln, Senator Sproul, this is not the program for the mentally retarded, this is for the mentally ill and it would cover the kind of patient who, if these facilities were not available, would be committed to the Bangor State Hospital, which is 220 miles away from the most northern distant point in Aroostook County

The PRESIDENT: Does the Senator consider her question an-

swered?

Mrs. SPROUL: Yes, Mr. President.

The PRESIDENT: The question before the Senate is the motion for indefinite postponement.

A division being had, 2 Senators having voted in the affirmative and 27 in the negative the motion to indefinitely postpone did not prevail. Thereupon the bill was passed to be enacted.

Mr. O'LEARY of Oxford: Mr. President, may I ask if L. D. 1313 is in the possession of the Senate?

The PRESIDENT: The Chair will inform the Senator that it is, having been requested by the Senator.

Mr. BROWN of Hancock: Mr. President, may we have the title of the bill read?

The Secretary read the title of the bill, Bill, "An Act Revising the Minimum Wage Law." D. 1313)

Thereupon, on motion by Mr. O'Leary of Oxford, the Senate voted to reconsider its former action whereby it accepted the Ought Not to Pass report and on further motion by the same Senator, the bill was recommitted to the Committee on Labor.
